# **DEPARTMENT OF HUMAN SERVICES**

Frank Guzzo, Director

Director Guzzo congratulated Chairman Carter, Freeholder Kowalski and Freeholder Granados on their election victory. He added that the Social Services safety net has remained strong because of this Board.

1. Authorizing the County Manager to award the proposed contracts obtained through advertised public bidding in accordance with the Local Public Contracts Law, NJSA 40A:11-1 et seq: Department of Human Services, Paratransit System for the purpose of providing Truck and Bus Parts for the 24 month period of December 1, 2013 through November 30, 2015: Linden

Associated Auto Parts, Linden, New Jersey, in the amount of \$9,285.00; and Parts Authority in the amount of \$4,975.00 for a total amount of \$14,260.00. (Bette Jane Kowalski)

- 2. Authorizing the County Manager to enter into contract with New Jersey Department of Human Services, Division of Disability Services, for 2014 Personal Assistance Services Program (PASP) funding in the amount of \$82,000.00 designated for program administration for the grant period of January 1, 2014 through December 31, 2014. (Bette Jane Kowalski)
- 3. Amending Resolution Number 2013-358, authorizing the County Manager to enter into agreements with a list of non-profit agencies for the purpose of providing a variety of social services to County residents in need, to extend the 2013 Peer Grouping Renewal Spending Plan for an additional five months through May 31, 2014 in the total amount of \$103,146.00 for a new total amount of \$298,562.00 and further authorizing the transfer of funds among the agencies during the contract period should service needs change and/or if any of the various agencies fails to meet its contractual obligation. (Bette Jane Kowalski)

Chairman Carter asked for an explanation of item #3.

Director Guzzo stated it is to amend the spending plan to renew for an additional 7 month until May 31, 2014. He stated that we receive more being a County hospital because we have the frailest of the frail patients.

4. Amending Resolution Number 2012-637, to extend the 2013 Alliance Grant for an additional six (6) month period from January 1, 2014 through June 30, 2014, and to further increase the award in the amount of \$265,436.00 for a new total amount of \$796,308, and to further amend existing subcontracts with the municipalities/agency, and further authorizing the County Manager to transfer funds among the municipalities/agencies during the contract period should service needs change and/or if any fails to meet its contractual obligation. (Bette Jane Kowalski)

Vice Chairman Hudak asked if item #4 is a municipal allocation.

Director Guzzo replied yes. He stated that the funding in 2012 was good. He stated that the reallocation of the grant dollars will be increased by 50% and extended an additional 6 months to the municipalities. He said it is a 100% match. He added that Winfield and Summit chose not to participate in the Alliance program. He stated that the average is \$40,000 to \$50,000 and is used for such programs as DARE and Project Graduation. ??

Vice Chairman Hudak asked if any of the municipalities have failed to expend the grant dollars.

Director Guzzo stated that all the municipalities spend the grant dollars awarded to them. He said all programs are monitored and if there are dollars that are not spent, we are able to reallocate the dollars within the current funding cycle and would be done on a quarterly basis.

Vice Chairman Hudak stated that within the last 4 years, the dollars awarded have decreased, hence, we want to make sure the dollars are being used.

5. Authorizing the County Manager to award 2013-2014 HEARTH Emergency Solutions (HES) Grant program subcontracts pursuant to the recent Request for Proposal (RFP) procurement process for the provision of activities, programs and services that relate to rental assistance, supportive services, and prevention services as permitted by the US Department of Housing and Urban Development regulations for the 8-month budget cycle from December 1, 2013 through July 31, 2014 in the amount of \$179,362 as specified on the spending plan, and to further authorize the County Manager to transfer funds among the various agencies during the

contract period should service needs change and/or if any of the various agencies fails to meet its contractual obligation. (Bette Jane Kowalski)

- 6. Authorizing the County Manager to award 2013-2014 Community Service Block Grant (CSBG) subcontracts pursuant to recent Request for Proposals (RFP) procurement process for the provision of services that include employment, case management, emergency shelter, food, rent/mortgage assistance and family supports as permitted by New Jersey Department of Community Affairs for the period of November 15, 2013 through May 31, 2014 in the amount of \$165,000 as specified in the spending plan, and to further authorize the County Manager to transfer funds among the various agencies during the contract period should service needs change and/or if any of the various agencies fails to meet its contractual obligation. (Bette Jane Kowalski)
- 7. Amending Resolution Number 2012-1020, increasing the 2013 Social Services for the Homeless (SSH) grant subcontract spending plan by \$41,373. The new total award for 2013 SSH subcontracted services would be \$652,893. The funding period would remain the same, January 1, 2013 through December 31, 2013. This resolution will further authorize the County Manager to transfer funds among the awarded agencies during the contract period should service needs change and/or if any of the agencies fails to meet its contractual obligation. (Bette Jane Kowalski)

Freeholder Jalloh asked how many agencies are entitled to receive this grant.

Director Guzzo replied, only one; the Elizabeth Coalition to House the Homeless. Freeholder Jalloh asked if the grant is to service one entity or if the amendment is for only one entity.

Director Guzzo explained that the amendment is for an additional \$41,000 and the funding entity remains the same such as; Catholic Charities, Home First, Plainfield YMCA, Urban League, Central Jersey... He said it is appropriated according to need and use.

- 8. Authorizing the County Manager to award a contract to Mutual of America, Parsippany, New Jersey, in an amount not to exceed \$34,000.00 for the period of July 1, 2013 through June 30, 2014 for the provision of Group Life Insurance with Group Accidental Death and Dismemberment Plan for employees not covered under the Public Employee Retirement System (PERS). (Bette Jane Kowalski)
- 9. Authorizing the County Manager to approve the Countywide Code Blue Emergency Shelter Initiative for the Winter of 2013-2014 in an amount not to exceed \$60,000 to address the needs of the homeless during periods of extreme weather conditions. (Bette Jane Kowalski)

Director Guzzo drew attention to item #9. He explained that Union County is the only County in the State to have a Code Blue Program. He explained that it is to seek out the homeless in the middle of the night and bring them to shelters during the most extreme cold temperatures. He stated that there are 61 shelters and 125 individuals and they have been awarded \$6,600 by the State. He said all the money has not been utilized.

Chairman Carter stated that the County partners with the municipalities and it is important that the programs continue.

Director Guzzo added that County Police sends out the alerts and it is a cooperative effort with the County and municipalities.

#### OFFICE OF THE UNION COUNTY PROSECUTOR

# Grace H. Park, Acting Prosecutor

First Assistant Tim Isenhour represented the Office.

1. Authorizing the County Manager, through the Union County Prosecutor's Office, to enter into a three (3) year contract with Sprint/Nextel, Denver, Colorado, using the national cooperative contract for service for existing secure push to talk units and any replacement phones, if needed, commencing December 1, 2013 through November 30, 2016 in an amount not to exceed \$138,000. (Linda Carter)

Chairman Carter asked if item #1 is a contract renewal.

Mr. Isenhour responded yes, they have used this vendor for a number of years. The use is private and consistently grant funded.

Chairman Carter asked if the amount has been the same.

Mr. Isenhour stated that he does not believe there has been an increase. It is a "not to exceed" amount of \$138,000. The average use is \$4,000 per month.

Freeholder Jalloh asked if the contract is for the service.

Mr. Isenhour stated that it is for the device, data plan and service.

#### DEPARTMENT OF ADMINISTRATIVE SERVICES

Matthew N. DiRado, Esq., Director

Director DiRado congrated Chairman Carter, Freeholder Kowalski and Freeholder Granados on their election.

Director DiRado stated that he will have 8 additional Resolutions for the next Freeholder Meeting to tie up loose ends prior to him leaving the County. He explained that they are for the dental renewal plan, the prescription and medical plans, disability insurance for 8 contracts; 48% will be paid by the County and 52% by the employee and the remaining will be for housekeeping matters.

1. Authorizing the sale of the County's personal property not needed for public use, pursuant to N.J.S.A. 40A:11-36; and declaring that the various vehicles and equipment are no longer needed for County purposes. (Linda Carter)

Freeholder Granados asked how many items are being auctioned as mentioned in item #1.

Director DiRado replied, 19 vehicles; 9 County use; 9 Prosecutor and 1 Union County Improvement Authority and 19 parks equipment, such as tractors, snow blowers and 83 pieces of computer equipment. He said last year \$83,000 was generated and they are doing an electronic auction this year.

Chairman Carter asked if there is a minimum bid amount to open the auction.

Director DiRado replied no. The equipment is old and are all retired as a result of the Asset Management system.

2. Amending Resolution Number 2012-1003, authorizing the 2014 Non-Contractual Salary Ranges, which are adjusted based upon the Consumer Price Index (CPI) for the previous twelve months, which increased 1.6%. (Linda Carter)

3. Renewing the County's membership with the New Jersey Counties Excess Joint Insurance fund for a three year period from January 1, 2014 through December 31, 2016. (Linda Carter)

Freeholder Wright asked about the membership fee item #3.

Director DiRado stated that they joined JIF in 2011 for 3 years. This item is only to join. It cost \$2.1 million in 2013 to join and there will be a slight increase next year. What???

Freeholder Estrada stated that there is no cost to the County to join JIF, we get insurance in return as we are self-insured.

Director DiRado stated that there are membership costs to join the policies and the County is the 3rd County to join JIF and there are 3 more counties joining.

Freeholder Mirabella asked if more counties join JIF, will the cost decrease.

Director DiRado replied yes, there is a shared risk and overhead cost.

Freeholder Mirabella asked if there is an increase in CPI range.

Director DiRado stated that in 1992, the Board estimated a guide salary increase. The CPI structure is 1.6%. It is based on grades, it is not a salary increase only a structure. He explained further, if someone falls below the minimum, as of January 1st, there will be an adjustment. He said there are currently 3 people who need to be adjusted.

4. Amending Resolution Number 2013-572, a contract with Roth D'Aquanni, LLC., Springfield, New Jersey, special counsel for personnel affairs to increase the cap for legal services in the amount of \$12,000 for a total contract amount not to exceed \$155,000. (Linda Carter)

#### **DEPARTMENT OF CORRECTIONS**

Brian Riordan, Director

1. Authorizing the County Manager to utilize its option to renew an agreement with Aramark Correctional Services, Inc., Atlanta, GA., for the provision of food services for the Union County Jail, for the period of November 13, 2013 through November 12, 2104 in an amount not to exceed \$1, 200,00.00 (Linda Carter)

Vice Chairman Hudak asked if item #1 is the same vendor as used by the Bayside State Prison as mentioned in the newspaper.

Director Riordan stated that they have received the same complaints, but they resolve the problems and have been responsive.

Vice Chairman Hudak asked if he is happy with the vendor's quality, variety and cleanliness.

Director Riordan replied yes. He said there has been a total change done for that institution and sometimes change is not always accepted well. He said this is a billion dollar company and corrections is a big market and they are content with their services.

Freeholder Jalloh asked if the monthly rate fluctuates.

Director Riordan explained that the daily population fluctuates. The per meal price and meals differ in price plus the SLAP individuals also get fed. He said \$20,000 to \$23,000 per week is spent on food services.

Freeholder Jalloh asked why there is one amount to the end of the year and one contract for 11 months.

Director Riordan stated that they wanted to break it down into 2 years. The contract runs from November to November

Freeholder Mirabella asked about the cost per meal and if there was a change from last year.

Director Riordan stated that the cost is \$1.235 for a standard meal, which covers 65% of the inmates, \$1.87 for religious meals and \$3.75 for Kosher meals.

# DEPARTMENT OF ENGINEERING, PUBLIC WORKS AND FACILITIES

Joseph Graziano, Director

1. Authorizing the County Manager to award a Professional Service contract to French and Parrello Associates, PA, Consulting Engineers, of Wall, New Jersey, for the purpose of providing 2014 Inspection of Dams, in an amount not to exceed \$21,750.00. (Linda Carter)

Freeholder Bergen asked if the price on the contract in item #1 is increased and if the Engineer is specialized in dams.

Director Graziano said it is not the same company. It is less than the last contract. He said the last contract was for \$23,000. This Engineer is qualified for dam construction. This will cover 8 dams. He said the dams are inspected every 2 two years to comply with regulations.

Freeholder Kowalski asked for the same dams are inspected every 2 years.

Director Graziano stated that the 8 dams are Briant Park, Springfield, Milton lake, Cranford, Robinson's Branch, Clark, Upper and Lower Lake, Mountainside, Bloodgoods Pond, Clark, Jackson's Pond, Cranford, and Seeley's Pond, Berkeley Heights.

Freeholder Estrada asked to get the evaluations of the dams when completed.

Director Graziano stated that he will forward the information to the Board.

County Manager Faella asked if there was an impact on the dams due to Storm Sandy.

Director Graziano replied yes.

- 2. Ratifying a request from the Township of Scotch Plains to close a portion of Martine Avenue, from Union Catholic High School, 1600 Martine Avenue to Inverness Drive for a 5K run that was held on Saturday, October 26, 2013. (Linda Carter)
- 3. Resolution granting permission to Township of Scotch Plains to close Park Avenue from East 2nd Street to Front Street on Sunday, December 1, 2013 from 12:30 p.m. to 5:00 p.m. for a Holiday Celebration. (Linda Carter)
- 4. Granting permission to the Borough of Mountainside to close New Providence Road from Mountain Avenue to Birch Hill Road on Saturday, November 2, 2013 from 7:00 a.m. to 12:00 p.m. (rain date November 9, 2013) for the purpose of moving the Historic Levi Cory House. (Linda Carter)

#### DEPARTMENT OF PARKS AND COMMUNITY RENEWAL

Ronald Zuber, Director

Deputy Director Cherron Rountree represented the Department.

Deputy Rountree congratulated Chairman Carter, Freeholder Kowalski and Freeholder Granados on their election victory. She stated that is will be her final meeting as an employee of the County.

Chairman Carter thanked her for her services to the County and wished her well on her next adventure.

1. Amending Resolution Number 2013-411, approving the 2013-2014 Consolidated Acton Plan, to include the City of Linden Street Resurfacing Project funded with Community Development Program Income funds in the amount of \$89,584.67. (Angel G. Estrada)

2. Amending Resolution Number 2012-1039, an agreement with KemperSports Management, North Brook, Illinois, for the operational expenses for the management and maintenance of the golf courses as required for the year 2013 in an amount of \$527,205 for a new total contract amount of \$5,756,973.00. (Linda Carter)

Freeholder Kowalski asked for an explanation of item #2.

Deputy Director Rountree explained that \$5.6 million was the projected revenue for the food/beverage and staff, but now the projected revenue is \$6.3, having a \$182,000 net profit overall for the County.

- 3. Authorizing the County Manager to award the proposed contract obtained through advertised public bidding in accordance with the Local Public Contracts Law, NJSA 40A:11-1 et seq: Department of Parks and Community Renewal: John R. Knabb & Sons, Kutztown, New Jersey, for the purpose of providing hay, for an extended contract period of twelve (12) months in the amount of \$189,150.00. (Linda Carter)
- 4. Authorizing the County Manager to award the proposed contract obtained through advertised public bidding in accordance with the Local Public Contracts Law, NJSA 40A:11-1 et seq: Department of Parks and Community Renewal: John R. Knabb & Sons, Kutztown, New Jersey, for the purpose of providing straw, for an extension of twelve (12) months in the amount of \$95,875.00. (Linda Carter)

Freeholder Jalloh asked about the contract extension in item #4. He asked if research has been done for a lesser amount.

Deputy Director Rountree stated that the price of hay has increased as the farmers could not dry hay and straw. She said hay went from \$290 per ton to \$375 per ton and straw went from \$295 per ton to \$390 per ton. Both have increased due to the weather.

5. Authorizing the County Manager to make an application for the FY 2015-2016 Subregional Studies Program of the North Jersey Transportation Planning Authority (NJTPA) for a \$300,000.00 grant, with a required County Match of \$60,000, to update the Union County Transportation Plan. (Linda Carter)

Freeholder Mirabella asked about the nature of item #5.

Deputy Director Rountree explained that it is to update the County Transportation Plan, if the grant is awarded, it will be July 2014. She stated that the last Plan was created in 2002.

6. Authorizing the County Manager to extend a contract with HAPPY Software and Services, Housing Pro Upgrade Section 8 House, Sarasota Springs, New York, to provide software maintenance and support for the contract period of October 1, 2013 through September 30, 2014 in the amount of \$6,519.00. (Linda Carter)

Freeholder Jalloh asked for an explanation of item #6.

Deputy Director Rountree stated that the County acts as a housing agency needed for Section 8 Housing. She said the waiting list is open and there are \$27,000 pre-applicants from Plainfield, Elizabeth and Union. This software helps maintain the list and is administered through a third party.

# **DEPARTMENT OF PUBLIC SAFETY**

- 1. Authorizing the County Manager to apply for a 2013-2014 NACCHO MRC grant award for Medical Reserve Corps (MRC) units to increase awareness and understanding of the Medical Reserve Corps (MRC) program; to support and increase MRC capacities at the local level; and expand the efforts and capabilities of local MRC units to support their community-based public health, preparedness and response initiatives. (Linda Carter)

- 5. Authorizing the County Manager to enter into an agreement with the Township of Union to provide back-up dispatch services to the township in case of emergency. (Linda Carter)
  - Freeholder Bergen said he is pleased that Union Township has signed on to the dispatching agreement with the County, even if it is only as a back up.
  - Freeholder Estrada asked about the charge to item #5.
  - Director Moran stated that there is no charge. He said we supply the radio equipment to the community and personnel. We fill in the temps for their personnel to be assigned to the Westfield office.
- 6. Authorizing the County Manager to accept a 6x4 Truck purchased by University of Medicine and Dentistry (UMDNJ) through the Urban Area Security Initiative grant initiative, valued at \$214,000, to enhance the County of Union's response capabilities. (Linda Carter)

Ms. Adour stated that item #3 is to authorize Runnells Hospital to enter into an agreement for professional services that are not covered by insurance, like phsychiatric patients. She said it is better to treat them with a specialist.

Chairman Carter asked if this has been done in the past.

Ms. Adour stated replied yes. The dollars are retained in case they are needed next year.

County Manager Faella thanked Ms. Adour, Director Guzzo, Freeholder Mirabella and Freeholder Wright for attending Runnells Specialized Hospital to address any questions or concerns.

#### OFFICE OF THE COUNTY COUNSEL

Robert E. Barry, Esq., County Counsel

County Counsel Barry congratulated Chairman Carter, Freeholder Kowalski and Freeholder Granados on their election victory.
