PRESENTATION TO THE BOARD

Jalloh, Vice Chairman Bruce Bergen and Freeholder Alexander Mirabella to Peter Capodice, Superintendent of Schools and various students of the Union County Vocational-Technical School, as the Union County Board of Chosen Freeholders designates the month of February, 2015 as "National Career and Technical Education (CTE) Month" in Union County.

Chairman Jalloh called upon Superintendent Peter Capodice. Mr. Capodice thanked the Board for their continued support and stated that they are very proud of their schools.

Chairman Jalloh called upon Ms. Baldasare and presented her with a Resolution. Chairman Jalloh read the Resolution aloud.

Ms. Baldasare mentioned how well the students were placed in the State.

A Resolution Presentation was made by Chairman Mohamed S. Jalloh to Mr. Patrick Scanlon on behalf of the Union County Saint Patrick's Day Parade Committee members; Dr. Margaret Mary McMenamin, Grand Marshal; Anthony J. Chairman Jalloh called upon Freeholder Wright and Freeholder Hudak to make a presentation to the St. Patrick's Day Parade Committee. He stated that the Board attends the parade every year and said it is always well-attended. General Chairman Tony Brennan introduced the members of the Committee.

Dr. McMenamin, Grand Marshal stated that she is very proud of the Union County St. Patrick's Day parade, adding it is the best St. Patrick's Day Parade in New Jersey. She said thanks to the work of our General Chair, their guest will be the General Chair of the New York St. Patrick's Day parade.

Chairman Jalloh congratulated all who were in attendance and praised them on their hard work.

OFFICE OF THE UNION COUNTY PROSECUTOR

Grace H. Park, Acting Prosecutor

First Assistant Prosecutor Tim Isenhour represented the Office.

1. Freeholder Carter asked if item #1 is done annually and if so, how much was spent last year.

Mr. Isenhour responded yes. He said \$102,000 was spent last year and it consisted mostly of experts and 1/3 was for transcripts.

2. Authorizing the County Manager through the Union County Prosecutor's Office to apply for and accept funding from the Edward Byrne Memorial Justice Assistance Grant, Megan's Law and Local Law Enforcement Grant in the amount of \$13,981 for the period of November 1, 2014 through October 31, 2015. (Vice Chairman Mohamed S. Jalloh)

1. Freeholder Mirabella asked why there is a need for a contract for another year.

Mr. Kobitz stated that there was always a contract in place via an RFQ just in case there is a Special Election in January. He said next year they will plan on an 11 month contract.

1. The County will partially reimburse for the cost of tuition and course fees,

Chairman Jalloh asked if the programs mentioned in item #1 are the only the programs that are reimbursed to the County.

Director Albert stated that these were the only ones from his department. He said he was uncertain if any other departments receive reimbursements for tuition.

Chairman Jalloh asked should an employee in the Finance Department receive a degree in Finance would that employee receive the tuition reimbursement.

Freeholder Mirabella asked how many employees are taking advantage of the tuition reimbursement.

Director Albert stated that there have been 5 to 10 employees registered in recent years.

Mr. Flemming stated that Dr. Chezian is now the Chief of the Psychiatric Unit. He explained further that Resolution 2014-709 is no longer needed because Dr. Chezian has taken over as the Chief of the department. He stated that the Chief resigned and the position has been eliminated. He said there is no savings. They are refilling the position.

2. Amending resolution 2014-985, a contract for the provision of Psychiatric Practitioners to provide coverage for weekends/vacations/holidays/emergencies for the patients of the Cornerstone Behavioral Health Hospital of Union County, approving new rates as of March 1, 2015 for an increase in an amount not to exceed \$10,000 for a total contract not to exceed \$58,000. DEPARTMENT OF ECONOMIC DEVELOPMENT

William Reyes, Deputy County Manager / Director

Deputy County Manager Reyes explained that items #2 and #3 are reductions in price compared to the last contracts.

- 1. Amending Resolution Number 2014-444, approving the 2014-2015 Consolidated Action Plan to include the City of Linden Demolition of Blighted Building Project for \$100,000.00 and the City of Linden Street Resurfacing Project for \$140,000.00 funded with Community Development Program Income funds for a total amount of \$240,000.00. (Chairman Mohamed S. Jalloh)
- 2. Amending Resolution Number 2014-144, (BA#78-2013) a contract awarded through the public bidding process to Top Line Construction Corporation, of Somerville, New Jersey, approving Change Order Number 1 (final) for the Intersection Improvements to Diamond Hill Road and McMane Avenue, Township of Berkeley Heights, New Jersey. This change order will reduce the original contract amount by (\$9,669.17) for a new contract amount not to exceed \$315,605.75. (Union County Engineering Project Number 2011-052) (Chairman Mohamed S. Jalloh)

Freeholder Carter said she was pleased to see the reduction in the contract, but asked why there is such a substantial decrease in the contract amount.

Engineer Tom Mineo responded. He explained that they anticipated bigger problems. He said an added contingency was due to any unknown issues that may arise.

Bibi Taylor, Director

Chairman Jalloh asked Director Taylor to given an overview of items #1 and #2.

1. Authorizing the Cancellation of Unissued Bond Balances in the Amount of \$14,785,000 (Freeholder Christopher Hudak)

Director Taylor stated that item #1 is to cancel the bonds because they were either completed or did not "take off." She said item #1 is essentially to clean-up the books and remove it from the debt capacity.

2. AUTHORIZING THE REFUNDING OF VARIOUS COUNTY BONDS FROM THE PROCEEDS OF THE SALE OF RUNNELLS HOSPITAL AND THE EXECUTION OF AN ESCROW DEPOSIT AGREEMENT IN CONNECTION THEREWITH (Freeholder Christopher Hudak)

Director Taylor explained that item #2 is the outset payment of \$6 million. She said since there were payments (February and anticipate a payment in March) made prior to the execution of

deposit, this Resolution authorizes the refunding of \$4.3 million of bonds that were previously issued to fund improvements for Runnell's Hospital

Freeholder Bergen asked if the outstanding debt is entirely from Runnells Hospital.

Director Taylor replied yes, the issue component.

DEPARTMENT OF HUMAN SERVICES

Frank Guzzo, Director

Freeholder Hudak asked if item #2 and #3 are grant funded.

Director Guzzo stated that it is State funded by the State Department of Parole.

Director Guzzo explained further that this item is to increase the contract with the Urban League with monies made available for another grant service, due to less of a need for mental health services and a greater need for housing ex-offenders. He said it is for individuals who are out of state prison on parole. There are currently 76 individuals enrolled at this level. He said since mental health services are not as needed, this item is to move dollars from Trinitas Hospital and the same amount is given to the Urban League to provide housing assistance.

- 4. Amending Resolution Number 2014-536, adopting the 2013 SuperNOFA Continuum of Care Spending Plan, to formally change the alternate name of one agency from YMCA of Eastern Union County to The Gateway Family YMCA. (Freeholder Bette Jane Kowalski)

Director Moran stated that during the budget process it will help cover vacations and such.

Freeholder Bergen asked if they are used on an as is basis.

Director Moran replied yes. They will be called when Dr. Shaik is not available. He stated that a pathologist needs to be on-call 24/7.

Freeholder Wright asked if these type of contracts are always for three years.

Director Moran replied yes, it is according to State Statute.
