Director of the Division of Purchasing Michael Yuska represented the Department

Authorizing the County Manager to renew the contract with Sage Software, Inc St Petersburg, Florida, for software licensing renewal, software updates and enhancement services for the County of Union's Human Resource Management System for the period of June 2, 2014 through June 1, 2015 in the amount of \$23,892.33 (Chairman Christopher Hudak)

Chairman Cartei asked if item #1 is a contract renewal

Director Yuska responded ves He said there has been a 4% increase since the last contract. He explained that the contract is for proprietary maintenance of software for the County's Human Resource Management System.

# DEPARTMENT OF ECONOMIC DEVELOPMENT

William Reyes, Deputy County Manager / Director

- Authorizing the County Manager to continue to participate in the Community Development Block Grant (CDBG), HOME Investment Partnerships Program (HOME) and the Emergency Solutions Grants Program (ESG) for fiscal years 2015 through 2017 (Chairman Christopher Hudak)
- Resolution approving the 2014-2015 Consolidated Action Plan (Year 40) including the Community Development Block Grant, HOME Investment Partnerships Program, and the Emergency Solutions Grant Program to the U.S. Department of Housing and Urban Development so that projects as listed therein maybe undertaken within the County of Union (Chairman Christopher Hudak)

Frecholder Kowalski asked for the number of homes that will benefit from items #1 and #2 She also asked about the funding

Deputy County Manager Reves stated that items #1 and #2 is for 4 projects and the number of units varies within each project. He said he is aware that there is a project in Flizabeth that consists of 6 units, Landen over 20 and a senior project in Flizabeth that consists of 40 units. Deputy County Manager Reves stated that he will provide the Board with the specifics for each project.

County Manager Faella interjected and stated that there has been an \$80,000 reduction in HOME allocation funding from the prior years. He said this year they received \$840,000

# **DEPARTMENT OF FINANCE**

Bibi Taylor, Director

Chairman Hudak asked if the items on the Agenda are to modify the Budget

Director Taylor replied yes, although, item #6 is adding a staff member as an authorized wire disburser for the Department

#### DEPARTMENT OF HUMAN SERVICES

Frank Guzzo, Director

Director Guzzo stated that he will have an additional Resolution for the next Freeholder Meeting

Chairman Hudak asked for an explanation of the Resolution from the Floor

Director Guzzo stated that the Resolution is for relocating the Youth Services Division, which is currently located in Linden. He explained that the current building has deteriorated and is a hazard to the staff and clients. He said the Resolution is to lease a 3,000 square foot (approximately) facility located at 288 North Broad Street in Elizabeth, which is smaller than the current building. He said the base rent is less than the amount they are currently paying for the first 5 years. He explained further that the new landlord will retrofit the space to the Division's needs. He said the location and condition of the building is an improvement compared to the current facility.

Freeholder Carter asked for a general explanation of the lease agreement

Director Guzzo explained that the lease is for 10 years commencing July 1, 2014, and there will be a 3% increase per year until the 6th year. The annual base rent will be 67,900 compared to \$80,700 plus common area maintenance charges (CAM)

Freeholder Carter asked Director Guzzo for the back-up information when it becomes available

Director Guzzo stated that he will have the information on Monday and will provide it to Freeholder Carter

Chairman Hudak asked if there is a clause in the lease should they choose to opt out. He said a County-owned facility should be considered to house the Division of Youth Services

Director Guzzo stated that he believes the lease consists of standard clauses. He said he will review the lease and will advise Chairman Hudak of the specifics

Authorizing the County Manager to approve the 2014 Peer Grouping Spending Plan in the total amount of \$203,175 for subcontracted services to be provided during the period of June 1, 2014 through December 31, 2014 and further authorizing the County Manager to transfer funds among the agencies during the contract period should service needs change and/or if any of the agencies fails to meet its contractual obligation (Freeholder Bette Jane Kowalski)

Freeholder Carter asked for an explanation of item #1

Director Guzzo stated that item #1 is the result of the end of the PLER Grouping Spending Plan funds for the year. He stated that item #1 is to fill the gap from July 1, 2014 to December 2014. The Resolution is for subcontracted services for social services to provide programs for mental health for the incarcerated, the homeless and elderly, youth programs for the disabled and employment skills. He said there is no other grant source available.

#### **DEPARTMENT OF PUBLIC SAFETY**

# Andrew Moran, Director

- Authorizing the County Manager to enter into a contract with Robert Wood Johnson University Hospital at Rahway to provide space for autopsies and external examinations for the contract period of April 1, 2014 through March 30, 2015, in an amount not to exceed \$60,000 (Chairman Christopher Hudak)
- Amending Resolution Number 2013-975, which awarded a competitive contract for ambulance billing services for the County of Union to reflect a change in the account numbers only (Chairman Christopher Hudak)
- Authorizing the County Manager to enter into an agreement with Lecia Geosystems, Norcross, Georgia, to provide training for the Sheriff's Office and/or other law enforcement agencies on specialized police equipment purchased with UASI Grant funding in an amount of \$23,520 (Chairman Christopher Hudak)

Chairman Hudak asked for an explanation of item #3

Director Moran stated that item #3 is to train Sheiiff Officers and Law Enforcement Officers to use the high speed laser scanner, which takes photographs of crime scenes and critical infrastructure. He said the scanner is designed for surveying but is ideal for crime scenes. He added that the scanner recreates a 3D image and is beneficial in court preceding.

Freeholder Granados asked how many law enforcement officers will be trained within the crime scene unit

Director Moran said approximately 10. He will provide the Board with the back up information
