**AN ORDINANCE FIXING THE SALARIES OF MEMBERS OF THE BOARD OF CHOSEN FREEHOLDERS, THE COUNTY MANAGER AND DEPARTMENT HEADS**

Be It Ordained by the Board of Chosen Freeholders of the County of Union as follows:

Section 1. The salaries of the Members of the Board of Chosen Freeholders, County Manager, County Counsel and Departments Heads shall be as hereinafter set forth and shall be effective as of January 1, 2017.

Section 2. That this Ordinance shall take effect at the time and manner provided by law.


