PRESENTATIONS FROM THE BOARD

A Resolution presentation was made by Freeholders Mohamed Jalloh and Bette Jane Kowalski to Sergeant Robert Christie, on behalf of the Union Police Department, for their outstanding efforts in supporting the Union County campaign to update handicapped parking penalty signs and for their concerted efforts to stop abuse of parking placards in their community.

Chairman Carter called upon Freeholder Jalloh, Freeholder Kowalski and Freeholder Wright to present Sergeant Robert Christie with a Resolution for launching a campaign to update handicapped parking penalty signs and for their efforts to stop abuse of parking placards in their community.

Freeholder Kowalski read the Resolution aloud. She asked Charlie Newman of the Division of Disability to join them.

Sgt. Christie thanked the Board for the Resolution and the ongoing support of the Board which benefits Union Township and Union County residents. He said they are committed to enforcing handicapped parking, stating that the statistics show that more than 50% of family members and friends of those who are disabled are using the placards. He said they are requesting identification and if the placard does not belong to the individual, they will receive 2 summons totaling \$500. The placard is immediately revoked and then suspension of the placard is decided by the courts.

Freeholder Wright congratulated Sgt. Christie for all his efforts.

Director Newman congratulated Sgt. Christie and the Union Twp. Police Department for improving the parking for the disabled.

Chairman Carter extended her gratitude.

A Certificate Presentation was made by Freeholder Alexander Mirabella to Marc Avena, a senior at Arthur L. Johnson High School in Clark, congratulating him on receiving the Union County Human Relations "Unity Award of Achievement by a Student."

Chairman Carter called upon Freeholder Mirabella and Freeholder Kowalski to make the next presentation. Freeholder Mirabella called upon Marc Avina and his parents. He stated he is always happy to recognize great students and student leaders. Freeholder Mirabella stated that Marc is a senior at A. L. Johnson High School in Clark and will continue his education at Rutgers University. He said he is proud of his efforts and presented him with a Certificate.

Marc thanked the Board for their recognition and said he has been helping restore churches in El Salvador and bringing families together. He thanked his family and mentors.

Freeholder Mirabella stated that Mark's mom is a great teacher with the Union County Vocational-Technical School - AIT.

Chairman Carter stated it is nice to see youth follow their passion.

OFFICE OF THE UNION COUNTY CLERK

JOANNE RAJOPPI, UNION COUNTY CLERK

Deputy County Clerk Nicole DiRado represented the Office.

1. Amending Resolution Number 2013-294, a contract with Royal Printing Services, Inc., West New York, New Jersey for the purpose of printing Official Ballots, Sample Ballots, Emergency Ballots, Emergency Ballot Tally Sheets, Provision Ballots and Provisional Ballot Inventory Cards for the US Senate Special Primary to be held on August 13, 2013 in the amount of \$181,205. (Chairman Linda Carter)

Freeholder Sullivan stated that Ms. DiRado was gracious to attend the Fiscal Committee

Meeting to speak about the Special Election. He stated that the Fiscal Committee was not opposed to costs of the Primary Election, but questioned the costs associated with the Special Election in October. He said they discussed the scheduling and the \$1.75 million cost to the County, stating that there is no guaranteed it will be reimbursed by the State.

Freeholder Sullivan asked Ms. DiRado to explain the time frame they are under.

Ms. DiRado stated that the County Clerk's Office has 5 working days beginning Monday, June 21st to Friday, June 28th to mail the ballots, which have to be printed and prepared first. They have to comply with the Federal law. She said there is a quick need to put contracts and purchase orders in place.

Freeholder Jalloh asked for more of an explanation of the fees that will be incurred. Ms. DiRado stated that there are provisional ballots, vote by mail ballots for the general election which includes a lot of overtime for regular employees and there will be seasonal employees salaries as well. She said there are postage and mailing and \$25,000 for the software consultant fees, which is not part of tonight's Resolutions. She said historically, the expenses for the primary election have been \$358,000.

Freeholder Jalloh asked if there is a fee associated with the machines from October to November.

Administrator of the Board of Elections Dennis Kobitz responded. He stated that most of the fees incurred will be for employee overtime. He said they have to wait for a court order to release the machines, then there is a County-wide recount, they need to be stripped and prepared for the ensuing election. He explained that only certified individuals can handle the voting machines. He said the primary election is scheduled for October 16th, the truckers have to bring the machines within 2 days. He said his staff will be working around the clock beginning Saturday, which will incur six certified employees to earn a lot of overtime.

Freeholder Estrada stated that the Special Election will be taking place unless there is a major challenge.

Mr. Kobitz replied yes. There is currently a Bill to have the Special Election changed to November, adding that he does not believe Governor Christie will sign the Bill.

Freeholder Hudak asked about the cost to each municipality.

Ms. DiRado stated that municipalities will incur overtime costs for employees to open schools during the summer months. They bear the costs of 100% of the official ballots. She said she was on a Conference call with Bob Giles and other County Clerks and the Board of Election.

Freeholder Hudak asked how long it took to be reimbursed by for the February 2008 Presidential Primary Election, and asked if there is inventory of municipal polling place that are available due to maintenance projects that occur in schools over the summer months.

Mr. Kobitz stated that Westfield has a bond referendum to improve their schools, Winfield does not have a school available, and a school in Hillside is improving the gym, but will provide them with another room. He said most schools are available.

Mr. Kobitz said the overtime costs were over \$190,000 and it will be a lot more. The reason being that the schools are closed, and the custodians typically do not work in the summer. He said the schools will bill the election Board.

Freeholder Hudak asked if the voting machine could be turned around from October to November in time.

Mr. Kobitz stated that the machines have to be delivered twice; for the Special and the General

election. He said we have 427 districts and 500 machines, and they are programmed by the Board of Election. It is a daunting task.

County Counsel Barry stated that there are currently two items on the Agenda to be discussed during Executive Session, but there were legal issues that arose at the Fiscal Committee Meeting relative to the costs associated with the Special Election and one of the County Clerk's current Resolutions. Therefore, there will be an additional item to be discussed during Executive Session.

OFFICE OF THE UNION COUNTY PROSECUTOR

Theodore J. Romankow, Prosecutor

Assistant Prosecutor Albert Cernadas, Jr. represented the Office.

1. Amending Resolution Number 2013-379, in order to extend the professional services contract with Elizabeth Deo, RN, for the period of June 9, 2013 through July 6, 2013 for an amount of \$2,800, total contract not to exceed \$7,000. (Chairman Linda Carter)

Chairman Carter asked for an explanation of items 2 and 3.

Mr. Cernadas stated that the DNA analyst in the lab is paid out of a \$2 million grant for DNA purposes and this item is to extend the contract.

Mr. Cernadas explained that item #3 is an annual contract. \$13,000 is for two salaries and the remaining is for equipment and investigative services.

County Manager Faella stated that he received the report from the Prosecutor's Office regarding the misuse of generators.

Mr. Cernadas explained that employees did use the generators during Storm Sandy, but there is no evidence to permanently keep them from the residents of Union County. Therefore, it is not a criminal matter.

- 2. Amending Resolution Number 2013-191, in order to extend the professional services contract with Cortney B. Boccardi, Richboro, Pennsylvania, for the period of June 30, 2013 through September 30, 2013 at no additional cost. (Chairman Linda Carter)
- 3. DEPARTMENT OF ADMINISTRATIVE SERVICES

There were no questions.

- 1. Amending Resolution Number 2008-879, a five year term contract with Cartegraph, Inc., Dubuque, Iowa, to provide implementation services, additional licenses, and training for the upgrade and customization of the existing application to incorporate an asset management system in the amount of \$34,190.00 for a new contract amount not to exceed \$216,290. (Chairman Linda Carter)
- 2. Approving Alfred Faella's Public Official Bond with the Hartford Insurance Company, Hartford, Connecticut for the period of April 1, 2013 through April 1, 2014 in the amount of \$400.00; representing no increase from last year's policy. (Chairman Linda Carter)

DEPARTMENT OF CORRECTIONS

Brian Riordan, Director

Director Riordan explained the 3 items listed on the Agenda.

1. Amending Resolution Number 2013-89, an agreement with Luminosity, Inc., St. Petersburg, Florida, for an additional eight months in order to extend the Jail Management initiative in an additional amount of \$30,000.00 for a total amount not to exceed \$218,464.00. (Chairman Linda Carter)

Freeholder Mirabella stated that if the population as mentioned in item #1 is decreasing why is would the contract be extended.

Director Riordan explained that there are currently 677 prisoners in the jail. He said there have been under 700 inmates that has remained constant within the past 1.5 weeks, stating that they are extending the contract with Luminosity as they are striving to fill the Manager position at

the jail, until then, they will be utilizing Ms. Van Nostrand of Luminosity and her staff.

Freeholder Mirabella congratulated Director Riordan for the great recommendation of Luminosity. He said the money has been well spent and well advised. He said this is the lowest jail population he has seen since he has been on the Board. He stated that there are usually 900 to 1000 inmates.

2. Authorizing County Manager to enter into an agreement with Monmouth County Police Academy Freehold, New Jersey, where as, the County of Monmouth will provide basic training courses for Union County Correctional Officer Recruits in an amount not to exceed \$17,000.00. (Chairman Linda Carter)

Freeholder Mirabella asked if the County has worked with the Monmouth County Police Academy in the past, referring to item #2. Director Moran, replied no, this is the first time. He said we rely on the Academy that is available to conduct the training courses for the Correctional Officer Recruits. We have used Passaic and Somerset Counties in the past.

Freeholder Mirabella asked why the County's Police Academy is not utilized for the training.

Director Riordan stated that it takes 12-14 weeks to become certified. He said that he would have to contribute his personnel to train and it is cheaper to send out than loose his staff. He said the first available academy for this training will be held in September at the Monmouth County Police Academy in Freehold. He said at this point, the officers will not return until later in the year. He said he has vacancies now that need to be filled and this is the soonest academy that is available.

Freeholder Mirabella asked if the vacancies require different training.

Director Riordan stated that the basic training is a 2 week orientation then 12-14 weeks of training, and then another week of in-house training to familiarize them on the structure of the facility when they return.

3. Amending Resolution 2013-144, to renew the contract between County of Union and Education and Health Centers of America, Inc., Wall, New Jersey, to provide comprehensive inmate substance abuse treatment/residential correction facility services to the inmates of the Union County Jail for the period of July 1, 2013 through December 31, 2013 in an amount not to exceed \$1,250,000.00. (Chairman Linda Carter)

Freeholder Estrada asked for last year's contract amount in item #3.

Director Riordan stated that they spent \$2,139,000 in 2012. He said the amount has been reduced. He said last year they used 164 beds at Delaney Hall, now there are 52 beds. He said there is really no way to predict how many they will need.

Freeholder Estrada asked about the net/net amount.

Director Riordan stated that there are 677 inmates in-house; 52 at Delaney Hall, 47 in Hudson County and 12 at the Ann Klein Psychiatric Hospital, which totals about 800. He said this is a record low, stating that the since he took the position in 2008, there has always been around 1,200 inmates in-house.

Freeholder Estrada congratulated Director Riordan and his staff on recommending Luminosity to the Board.

DEPARTMENT OF ENGINEERING, PUBLIC WORKS AND FACILITIES

Joseph Graziano, Director

Engineer Thomas Mineo represented the Department.

- 1. Concurring with the City of Summit's Ordinance No. 13-3006, "Turn Prohibitions; No Turns On to Briant Pkwy Between 7-9am & 4-6pm." (Chairman Linda Carter)
- 2. Amending Resolution Number 2011-1066, (BA#100) a contract through the public bidding process with Jogi Construction of Edison, New Jersey, approving Change Order No. 1 (final) for the Replacement of Prospect Street Culvert, City of Summit, New Jersey; reducing the original contract amount by \$28,473.03, for a new total contract amount of \$733,526.97. (Chairman Linda Carter)
- 3. Freeholder Jalloh asked for an explanation of item #4.

Mr. Mineo stated that the contract is for various fire protection for various park maintenance building required by code.

Freeholder Jalloh asked about the funding for last year.

Mr. Mineo stated it is a separate project, on an as-needed basis. He said they just finished one at Watchung Stables. He has been working with Steve Caruso who has been communicating with Public Safety.

Freeholder Estrada asked Mr. Mineo to update the Board as to how many more facilities need to be done.

- 5. Authorizing the County Manager to award the proposed contract obtained through advertised public bidding in accordance with the Local Public Contracts Law, NJSA 40A:11-1 et seq: Department of Engineering, Public Works & Facilities: Ralph Checchio, Inc., Scotch Plains, New Jersey, for the purpose of providing various asphalt overlay for Park Maintenance, to be completed by September 27, 2013 in the amount of \$280,714.00. (Chairman Linda Carter)
- 6. Amending Resolution Number 2011-633, (BA#40) a contract through the public bidding process with GPC, Inc., Millburn, New Jersey, approving Change Order No. 1 for the Union County Justice Complex Renovations, Phase II Project in an amount not to exceed

\$2,186,787.63 for a new contract amount not to exceed \$13,181,787.63. (Chairman Linda Carter)

Freeholder Sullivan asked for an explanation of the Change Order mentioned in item #6.

Director Guzzo explained that the Change Order is being added to the existing jail renovations. It was also part of the Hudson County Agreement to allow us to clear the pods that needed much work since it was built in 1989. He said the only work that has been done to the jail since then was the recent renovation of the kitchen. He said windows are in desperate need of refitting and caulking on the exterior, painting and refitting of doors need to be done. He said that is \$887,000 worth of the Change Order amount. He explained that no other improvements have been made to the jail since 1989 and since the pods are being vacated, now is the time to get this done.

Director Riordan stated that the contract has certified that the work needs to be done and it will provide a better environment for individuals who are in our care. The jail was built to accommodate approximately 500 inmates and it has been accommodating 1,200 inmates, resulting in much wear and tear.

Freeholder Sullivan asked how long it will take to complete the work.

Bob Pasquale, President of Pinnacle stated that there is 18 months remaining. There are a total of 10 pods and each pod will take 1.5 months to complete, which will bring it to October 2014. He said the costs are inclusive of the changes. Then they will begin with Phase 3, which is replacing the control center.

Freeholder Sullivan asked if Phase 3 is part of the contract and if they could expect any other Change Orders.

Mr. Pasquale stated that it is not part of this contract and there should not be another Change Order.

Director Riordan said that there has been some work done as part of Phase 3, while the pods are vacant, like replacing some of the electrical equipment to bring it up to date. He said if it is not done while the pods are empty, it will cost more to empty the pods again.

Freeholder Jalloh asked why the repairs were not anticipated prior to vacating the pods.

Director Riordan stated that he was not employed by the County when the scope was originally done. It has deteriorated since that time. He said the ventilation system, duct work, motors, belts and design of the doors leading to the showers all need to be replaced.

Mr. Pasquale stated that when the original scope was done in 2002, areas increased in interior design and being that the pods were not vacant, it made it difficult to see all the work that needed to be done.

Freeholder Sullivan asked where the dollars are coming from in item #13.

Director Taylor stated that the Special Election was unforeseen and it is funded out of surplus then will be in next year's budget.

Freeholder Sullivan stated that there has been no affirmative communication from the State that the County will be reimbursed. Director Taylor confirmed that he was correct.

Freeholder Hudak asked when the County received full reimbursement by the State for the last election.

Director Taylor stated that they received reimbursement seven months after the election in 2008. She said the County operated on a cash basis and there was no guarantee in surplus dollars.

Freeholder Hudak stated that this covers two election years, not involving weather events.

Director Taylor stated that there are unforeseen seasonal circumstances, overtime of staff, publishing costs, printing costs and mailings.

Freeholder Hudak asked how much of the cost was due to the storm on overtime costs and costs pertaining to the ballots in 2012.

Director Taylor stated that the bulk of the expenses were in overtime and mailings. She said she will provide the Board with the figures.
