OFFICE OF THE UNION COUNTY PROSECUTOR

Theodore Romankow, Union County Prosecutor

First Assistant Prosecutor Albert Cernadas, Jr. Represented the Office.

Mr. Cernadas stated that items #1 and #2 are being paid by grant dollars.

1. Authorizing the Office of the Union County Prosecutor's Office to enter into a professional services agreement with Cortney B. Boccardi, a DNA Consultant, for the period of July 30, 2012 through July 29, 2013 at an hourly rate of \$50 in an amount not to exceed \$90,000.00. (Chairman Alexander Mirabella)

Freeholder Estrada asked for an explanation for the DNA Consultant. Mr. Cernadas stated that Ms. Boccardi, the DNA Consultant validates the studies and the DNA testing. He added that they are converting to international standards.

2. Authorizing the Union County Prosecutor's Office to enter into a contract with Thermo Electron Corporation c/o Ahura Scientific Inc., to provide to The Union County Lab a Refurbished AhuraFD with a two year warranty in the amount of \$31,800. (Chairman Alexander Mirabella)

Director DiRado stated that in the past item #4 was broken down into three separate parts. Some changes have been made, and now it is all one Resolution.

Resolution authorizing employee tuition reimbursement for Kean University for the following programs: Certificate in Public Administration Program, Certificate in Public Administration and Certificate in Public Administration Enhancement Program. The County will partially reimburse the cost of tuition and course fees, excluding books and miscellaneous expenses for qualified employees from January 1, 2012 through December 31, 2012 in a total amount for the programs not exceed \$40,000.  Amending the contract with Tom Moore of Cranford, NJ (BA-86-2009) to accept the option to renew for an additional 24 months for the Warinanco Ice Skating Center Snack Bar at the rate of \$1,805.00 per month from October 6, 2012 through October 5, 2014. (Revenue Producing Contract) (Freeholder Daniel P. Sullivan)

Vice Chairman Carter asked for an explanation of item #1.

Director Zuber explained that it is a contract renewal, as it is at the end of the second year of the contract. The contract is for the snack bar at the ice skating rink at Warinanco Park, which runs from October to April 1st and for carts throughout Union County. He stated over the two year contract period, they have received \$43,000 in revenue.

- 2. Authorizing the County Manager to enter into a contract with the Union County Economic Development Corporation, Union, New Jersey, for the purpose of providing general economic development services to the County of Union for the year 2012 in an amount not to exceed \$80,000. (Freeholder Daniel P. Sullivan)
- 3. Authorizing the County Manager to enter into a contract with the Union County Economic Development Corporation, Union, New Jersey, for the purpose of providing procurement training/technical assistance to private businesses in Union County for the year 2012 in an amount not to exceed \$80,000. (Freeholder Daniel P. Sullivan)

County Manager Faella stated that the amounts in items #2 and #3 have remained the same for this year.

4. Amending Resolution Number 2010-507 to reflect a change in a HOME Program Project from Renaissance Apartments, 170-174 First Street, Elizabeth, New Jersey to Russel C. Block Apartments, 217-219 First Street, Elizabeth, New Jersey Rental Project in the amount of \$300,000.00. (Freeholder Daniel P. Sullivan)

Freeholder Estrada asked if item #4 is changing from Renaissance Apartments to Russel C. Block Apartments, and asked if is the same owner.

Director Zuber replied yes, the owner is Brand New Day.

DEPARTMENT OF PUBLIC SAFETY

1. Authorizing the County Manager to enter into an Emergency Subscriber List Service Agreement with Verizon, for a three (3) year period, at the rate of \$262 per month, beginning on August 1, 2012 through July 31, 2015 in the total amount of \$9,432.00, to update the Emergency Alert Response System. (Chairman Alexander Mirabella)

Freeholder Hudak asked how many subscribers there are for item #1.

Director Moran stated that there are 16,000 subscribers, and said it is to allow for weekly updates on calls from land lines into the County, and will allow for reverse 911 calls.

- 2. Authorizing the County Manager to auction off unclaimed personal property, obsolete property and surplus property. The sale of the property will be conducted through Auction Liquidation Services and DBA USGOVBID.COM. (Chairman Alexander Mirabella)
- 3. Authorizing the County Manager to enter into a contract with Atlantic Diagnostic Laboratories, Bensalem, Pennsylvania, for the purpose of providing toxicology services for the contract period of August 1, 2012 through July 31, 2013 in an amount not to exceed \$60,000.00. (Chairman Alexander Mirabella)
- 4. Authorizing the County Manager to accept two (2) pieces of Homeland Security Equipment, purchased by Morris County through the Urban Area Security Initiative grant initiative in the combined amount of \$159,480.75, to enhance the County of Union's response capabilities. (Chairman Alexander Mirabella)

Freeholder Hudak asked if the County will be purchasing equipment with grant dollars in item #4.

Director Moran stated that Morris County is acting as the purchasing agent. They purchased a generator and forklift.

Freeholder Sullivan asked where the generator and forklift will be used. Director Moran stated that it is part of a commodity distribution plan.

County Manager Faella interjected and said during Hurricane Irene these items helped deliver

items such as food and water to the victims.

RUNNELLS SPECIALIZED HOSPITAL

Joan Wheeler, Administrator

1. Authorizing the County Manager to award a contract to Sodexo, Inc., Gaithersburg, Maryland, to provide dietary and housekeeping services for Runnells Specialized Hospital for a contract period of 16 months, effective September 1, 2012 through December 31, 2013, in an amount not to exceed \$8,428,872.00; representing an anticipated total cost savings of \$2,040,728.00. This contract offers the County of Union an initial option to extend for an additional 24 months (through December 31, 2015) and a second option to extend for an additional 20 months (through August 31, 2017). (Freeholder Vernell Wright)

Freeholder Sullivan asked if item #1 will be discussed during Executive Session. Acting Chairman Carter, replied, yes.
