 Authorizing the County Manager to enter into a contract with Millennium Strategies, Caldwell, New Jersey, for the purpose of providing grant procurement services for the period of January 1, 2012 through December 31, 2012 in an amount not to exceed \$36,000. (Freeholder Bette Jane Kowalski)

Chairman Mirabella asked what type of grants will be secured for item #1.

Director Guzzo stated that it is a full service grant agency, adding that there is a reduction from last year. He said Federal and State monies are no longer available, so they had to look at other services that are available.

Chairman Mirabella asked about last year's contract. Director Guzzo stated that last year the contract amount was more than \$50,000.

2. Authorizing the County Manager to approve the Substantial Amendment to the current Fiscal Year (FY) 2011 Consolidated Plan to reflect the expansion of services and increase in Hearth Emergency Solutions (HES) Grant, formerly Emergency Shelter Grant (ESG), funding in the amount of \$133,247, bringing the total HES/ESG award to \$370,130, and further authorizing the administration and disbursement of HES/ESG funds as permitted under the US Dept of Housing & Urban Development (HUD). (Freeholder Bette Jane Kowalski)

- Authorizing the County Manager to enter into a Memorandum of Understanding with the North Jersey Transportation Planning Authority and to join the North Jersey Sustainable Communities Consortium and member of the Consortium Steering Committee. (Freeholder Angel G. Estrada)

Chairman Mirabella asked for an explanation of item #3.

Director Zuber stated that in 2011, a group consisting of Rutgers University, the North Jersey Transportation Authority, NJ Transit and Office for Planning Advocacy and others received a \$5 million grant from the U.S. Department of Housing and Urban Development to create the North Jersey Sustainable Communities Consortium which will guide the development of a Regional Plan for Sustainable Development for the 13 County NJTPA region to join 2 cities, 5 educational and 2 institutional agencies.

Freeholder Estrada stated that there is no cost to the County and it is good for the County to participate.

Director Zuber stated that upon approval of this Resolution, the County will be eligible for a \$10,000 grant.

- Authorizing the County Manager to enter into a contract with Mareth Advisors, LLC of Arlington, Virginia to perform a feasibility study of Watchung Stables in the amount of \$16,000. (Freeholder Daniel P. Sullivan)
- 5. Authorizing the County Manager to enter into an agreement with the Elizabeth Development Corporation for the purpose of providing assistance to underserved people with training and gaining access to summer employment in the amount of \$25,000. (Freeholder Daniel P. Sullivan)

The Office of the Comptroller of Currency, the NJ State Historic Preservation Office and the Advisory Council on Historic Preservation, has required TD Bank to dedicate 1.09 acres of property for Open Space and is required to provide a conservation easement to the County of Union to insure that this property will not be developed in the future.
