REORGANIZATION MEETING AGENDA

The Honorable Karen M. Cassidy, Assignment Judge, Superior Court of the County of Union, called the meeting to order, and made welcoming comments. Honorable Judge Cassidy said it was a pleasure to have the courtroom open for the Installation and Reorganization Meeting. She thanked the Board for their efforts on behalf of the judiciary for the construction of the new family court building on Cherry Street. She said she is looking forward to working with them in 2015. She wished everyone a Happy New Year and turned the meeting over to Chairman Jerry Green.

Chairman Green thanked Honorable Judge Cassidy for the use of her courtroom chambers and wished her a Happy New Year. He added that he was happy to be working with a Judge, that he feels that is the best in New Jersey. He thanked her for the use of the courtroom.

Chairman Green announced that some adjustments will be made to the Agenda as there are some guests who are running late. He said he would like to give them an opportunity to speak.

HONORED GUESTS

Chairman Green introduced his friend, Senator Raymond Lesniak of the 20th District, and recognized the fine job he has done for the residents of Union County. He said this is the first time in over 20 years that the State of New Jersey will have a housing policy because of Senator Lesniak.

Senator Lesniak wished everyone a Happy New Year. He noted that it was the first year without having Sheriff Ralph Froehlich making the Call of the Colors at the Installation and Reorganization Meeting. He said Sheriff Froehlich was the finest human being who walked the face of the earth.

Senator Lesniak congratulated Freeholder Estrada, Freeholder Hudak, Freeholder Wright, Surrogate LaCorte and new Sheriff, Joseph Cryan on their election. He also congratulated Chairman Green for continuing to preside over democracy in Union County led by the Democratic Party. He wished everyone a Happy New Year.

Chairman Green introduced Chairman of the Democratic Committee of Middlesex County, Kevin McCabe. He said that they have come together in the last 2 years and they will be a voice in the State for Central Jersey. He said Union and Middlesex Counties share many things in common and will, together, be a force in New Jersey politics.

Chairman McCabe congratulated the Constitutional Officers and the Freeholders on their elections. Assemblyman Bramnick congratulated the winners of the election and said they will work together and support leadership, adding that there will be respect and civility. He said those who want to divide us have no place in Union County. He thanked Chairman Green and congratulated Sheriff Cryan. He said Sheriff Cryan will be missed in the Assembly.

Chairman Green thanked everyone who attended the Installation and Re-Organization Meeting. He said he is proud of Freeholder Jalloh and wished him the best of luck as the nominated Chairman of the Board of 2015. He believes everyone should have the opportunity to be treated equally and fairly. He thanked everyone in the room. There are a lot of issues that need to be resolved that in the State. He said he would like to start with programs in the County and then eventually at a national level. He made comments relative to the fact that no one in Union County should be homeless or without food. He made comments relative to race related issues and job opportunities. He said he has a good relationship with both parties and thanked everyone for having trust in him. He congratulated Sheriff Cryan and stated that he believes he will do a tremendous job. Chairman Green stated that his grandson was asking him how he became successful and his answers were he was given opportunities. He stated that he considers the residents of Union County as family, and is looking forward to an even better year 2015.

The Honorable Alfred J. Faella, County Manager, led the Pledge of Allegiance.
Mrs. Marie Oakie sang our National Anthem, the Star Spangled Banner.

Union County Sheriff Cryan asked the Honor Guard to Post the Colors.



Clerk of the Board Pellettiere recognized various elected officials among the audience and thanked them for attending the Re-organization Meeting.

Mr. Pellettiere stated that on behalf of Chairman Green, it was his pleasure to introduce the honored guests who were in attendance and thanked them for attending.

Chairman Green called upon the honored guest speakers.

The Honorable Carl L. Marshall, JMC, Elizabeth and Roselle Municipal Court Judge administered the Oath of Office to Vice Chairman Mohamed S. Jalloh.

Chairman Jalloh asked for nominations for the Office of Vice Chairman of the Board of Chosen Freeholders. Freeholder Kowalski nominated Freeholder Bergen. The motion was seconded by Freeholder Wright. Roll call showed nine members of the Board voted in the affirmative.

The Honorable Joanne Rajoppi, Union County Clerk administered the Oath of Office to Vice Chairman Bruce H. Bergen.

Holding the Bible for Vice Chairman Bruce H. Bergen was his wife, Jodi, joined by his son, Ross.

ANNUAL MESSAGE

CHAIRMAN MOHAMED JALLOH DELIVERED THE FOLLOWING ANNUAL MESSAGE:

James E. Pellettiere, Clerk of the Board, introduced Chairman Mohamed S. Jalloh who gave his annual message.

Chairman Mohamed S. Jalloh announced a comprehensive series of initiatives for 2015, entitled "Investing in Union County" that includes new announcements in

economic development, arts, education, quality of life improvements and public safety.

Chairman Jalloh touched upon a number of tough governmental decisions made by the Freeholder Board over the past several years necessitated by the global recession. Chairman Jalloh noted the County is rebounding and must continue to “play offense” through a series of strategic initiatives for the New Year.

Chairman Jalloh said those steps proved very effective and we have emerged a stronger County government because of it.” He stated that “It is time again for the County to focus on making the investments in our future that will help boost the economy and enhance the quality of life for our residents.”

Chairman Jalloh went on to outline his “Investing in Union County” initiatives:

- **“Road map to success”** - The County will commission a report, conducted through the Bloustein School at Rutgers, that will examine trends in Union County’s overall economy, find strengths and synergies to focus its resources upon, and effectuate positive outcomes.
- **“Build a Community of The Arts”** - this set of initiatives would build a County-wide arts ecosystem that will grow and stimulate Union County’s economy, including:
 - An Arts Master plan, with assistance from former Rahway Mayor Jim Kennedy, which would catalogue the County’s Arts resources and determine how to best utilize them, market them and move forward with a plan for advancing the arts;
 - The Union County Advancing Community Theatre initiative (UCACT), through which the County would sponsor and promote five or more theatre events at the Union County Performing Arts Center (UCPAC). This program builds on the recent success of RENT – a pilot of this program that the County initiated in November through a partnership with UCPAC;
 - A new partnership with Union County College to offer classes in acting, dance, and public speaking at UCPAC that will be open to all residents;
 - A “creative place-making initiative,” which will involve covering traffic control boxes with the artistic expressions of local Artists, aimed at enhancing community arts and revitalization.
- **“College Readiness Now”** – Develop a partnership with Union County College to expand this pilot program which tests juniors near the end of the academic year to ensure they are prepared for college and help avoid costly remediation courses.
- **“Families First initiative”** – which includes a partnership involving the United Way of Greater Union County, the Workforce Investment Board, and our Department of Human Services, that would lead to additional after school programs, workforce investment training and support for families;

- A pilot program with **Community Coordinated Child Care** (also known as “four C’s”) to serve those who don’t meet eligibility for State subsidized child care;
- Work with various partners including the Court Administration, the Sheriff’s office, Human Service agencies and the Prosecutors Office, to ensure safety and better services for families affected by domestic violence.
- A series of **economic development and workforce initiatives** meant to boost the economy and create new opportunities, including:
 - A **\$2.3 million expansion of the Union County Workforce Investment Board (WIB)** program at the Jersey Gardens Mall in Elizabeth to boost job training, job creation and employment programs for County residents;
 - **The Entrepreneurship Training Program**, which just began through the WIB, is aimed at assisting individuals who want to start and manage their own business; and a partnership with the New Jersey State AFL-CIO (community services agency) to screen and assist qualified, legal, permanent residents who live in Union County with their naturalization;
 - The creation of a **Union County economic development response team** to approach each Union County municipality about their needs. This would open a dialogue on sharing services, identifying opportunities and maximizing our resources in spurring economic growth;
- **Public safety and recreational announcements** aimed at improving the quality of life, including:
 - The creation of a new **street crimes unit** through the Sheriff’s Department that would focus on emerging public safety concerns;
 - Action on a recently completed assessment of our parks, public works and motor vehicle locations to **install safety cameras** as a deterrent to crime in those locations;
 - Continuing the successful **Union County Gun Buyback program** with another round coming later this summer;
 - Enhanced development of our parks, such as continuing the “turf and build” program and bike path improvements, as well as roads and infrastructure measures with the goal of increasing recreational opportunities in the County;

Chairman Jalloh closed by saying that in discussing last year’s developments in Ferguson, Missouri, and Staten Island, he added that it is incumbent upon all of us as government leaders to assist in the effort to maintain or restore the bond of trust between our different communities and our police departments.”

Chairman Jalloh has initiated conversations with Assemblyman Green, the Prosecutors office, the Sheriff's office, and the County's Public Safety Director regarding **programs that could be offered at our Police Academy and through County Police.**

"We want to raise the bar of tolerance and professionalism for those in the line of duty, and in turn we hope to create an atmosphere of renewed respect that our officers deserve to make the ultimate sacrifice of putting their own lives on the line," Chairman Jalloh stated.

The Freeholder Chairman closed his speech by quoting President Obama:

Change will not come if we wait for some other person or some other time. We are the ones we've been waiting for. We are the change that we seek.

Chairman Jalloh said he looks forward to working with his colleagues, County staff and members of the community to effect this change.

Chairman Green said he is proud of the job we have done and thanked Congressman Sires for the opportunity to be one of his speakers in Trenton. He said it is all about team work and working together. He has been in Washington, D.C. with Senator Menendez. He said he is extremely proud of the Freeholders and a job well done and mentioned that during the campaign he never received any negativity in the mail and hope it continues this year.

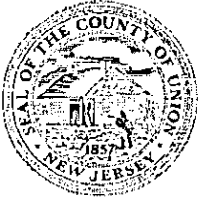
Reverend David Holmes of Ruth Fellowship Ministries delivered the Benediction.


