#### OFFICE OF THE UNION COUNTY CLERK

Director of the Division of Purchasing Michael Yuska represented the Office.

Mr. Kobitz added that items #1 and #2 is the same amount as last, but is split 80% and 20%. He explained further that Main Street Movers are former employees of The Liberty Group. They formed their own company and is Office is giving them an opportunity to provide services.

# Ron Charles, Director

Freeholder Mirabella thanked Acting Director George Blaskiewicz for filling in as Acting Director upon the retirement of former Director Riordan. He said Mr. Blaskiewicz has been a terrific employee and a strong leader.

- 1. Authorizing the County Manager to enter into a contract with Catholic Charities of the Archdiocese of Newark, Newark NJ to provide Alcohol and Drug Treatment Program for the female inmate population at the Union County Jail for the contract period of January 1, 2016 through December 31, 2016 in an amount not to exceed \$81,332.00. (Chairman Mohamed S. Jalloh)
- 2. Authorizing the County Manager to approve a pre-qualification agreement for Education and Health Centers of America, Inc., Wall, NJ to provide comprehensive inmate substance abuse treatment and residential correctional facility services for the period of January 1, 2016 through December 31, 2016. The Proposal Review Committee recommends that Education and Health Centers of America, Inc. be deemed pre-qualified. (Chairman Mohamed S. Jalloh)
- 3. Authorizing the County Manager to enter into an agreement with Education and Health Centers of America Inc., Wall, NJ, to provide comprehensive Inmate Substance Abuse Treatment and Residential Correctional Facility Services for up to 200 Union County Jail inmates daily for a two year period starting January 1, 2016 through December 31, 2017 with an option to extend for two years in an amount not to exceed \$1,752,000.00 from January 1, 2016 through December 31, 2016 and \$1,752.000.00 from January 1, 2017 through December 31, 2017. Director Charles stated that The Keefe Group has been the vendor providing these services for the County for the last seven years. He said in 2015 the estimated revenue was \$180,000, adding there is a 2 year option to extend the contract period. The commission rate is 38.5%.

Freeholder Mirabella asked if the vendor is paid on a commission basis.

Director Charles replied yes.

## DEPARTMENT OF ECONOMIC DEVELOPMENT

# William Reves, Deputy County Manager / Director

1. Deputy County Manager Reyes stated that last year NJ AFLCIO was paid \$240,000 to host the program.

Chairman Jalloh asked why there is an option for renewal. He also asked if there is an option to be removed.

Deputy County Manager Reyes stated that the option to exercise an additional year extension is for the savings.

Chairman Jalloh asked if they are anticipating a savings from the prior year having an automatic renewal.

Deputy County Manager Reyes replied yes.

1. Director Graziano said there are bids out to three qualified engineering firms for the design only. He said to date they have not received the bids. Therefore, there is no dollar amount at this point.

Director Graziano explained further that a CVS was built in Berkeley Heights at the intersection of Springfield Avenue and Lone Pine Drive. He said the owner of CVS asked for a traffic light to be installed. He stated that a study was performed and it was deemed warranted. Director Graziano stated that the County is involved because it is located on a County road. He said a shared service agreement for the signal is needed involving the owner, Berkeley Heights and the County. He said

the owner has agreed to pay for the installation of the traffic light and the Township of Berkeley Heights will pay for its maintenance and there is no cost to the County.

Director Graziano replied that it was Harbor Consultants.
