1. Authorizing the County Manager to award a contract as an exception to bidding for proprietary software support to Dominion Voting Systems, Denver, Colorado, for the purposes of providing licensing, maintenance and support for the WinEDS voting system to conduct elections in an amount not to exceed \$25,000. (Chairman Bruce H. Bergen)

Freeholder Estrada made comments relative to a national concern relative to the integrity of the elections and of the voting machines. He asked Administrator Kobitz to speak on the security efforts with our system.

Administrator Kobitz advised nothing regarding the machines, nor do the computers that hook up to the machines involve any interaction with the internet. He made general comments relative to the security seals on the machines which are recorded and provided to the State. He assured the Board that removing the chip from the machine is virtually impossible. He added that his office was more worried with the state voter registration system, noting the time and effort the office monitored those recordings. He stated that the County has over 329,000 registered voters.

- 2. Authorizing the County Manager to enter into an agreement with The Liberty Group, Berkeley Heights, New Jersey, for the purpose of transporting Dominion voting machines to and from polling places throughout the County for the contract period January 1, 2017 through December 31, 2017, in an amount not to exceed \$60,000. (Chairman Bruce H. Bergen)
- 3. Authorizing the County Manager to enter into an agreement with Main Street Movers, Irvington, New Jersey, for the purpose of transporting Dominion voting machines to and from polling places throughout the County for the contract period January 1, 2017 through December 31, 2017, in an amount not to exceed \$15,000. (Chairman Bruce H. Bergen)
- 4. Authorizing the County Manager to enter into an agreement with Royal Printing, West New York, New Jersey, for the purpose of printing voting authority books, poll books and all other printing needed to run an election in the County for the contract period of January 1, 2017 through December 31, 2017, in an amount not to exceed \$120,000. Administrator Kobitz advised that they requested a 2 year RFQ, but advised that only one vendor (Royal Printing) had responded.

Freeholder Jalloh stated that the director's previous two predecessors discussed the possibility of extending this program to include other degrees to advance their knowledge in their specific field, and inquired if he has considered this as a possibility.

Director Yuska stated that he would continue researching the matter and get back to the Board.

- 2. Amending Resolution Number 2015-76, a contract with Elizabeth Truck Center, Elizabeth, New Jersey, for the purpose of providing Collision Repair Services, to reflect the contracted term of initial agreement to be 36 consecutive months with the option for one (1) 24 month option. (Chairman Bruce H. Bergen)

Freeholder Jalloh inquired if there is a specific vendor involved with this resolution.

Director Wagner stated that this involves a network of vendors already established by the Union County College at no cost, adding that this is the third contract the County has entered into.

2. Authorizing the County Manager to enter into an agreement with The United Way of Greater Union County, Elizabeth, New Jersey, to continue to provide annual support and operation of the Family Success Center in Rahway (of the Family Strengthening Network), Multicultural Family Success Center in Elizabeth, and the continuation of the Focus on Families Task Force, Community Conversations and the Parent Advisory Boards for the period of January 1, 2017 through December 31, 2017 in an amount not to exceed \$266,000. (Chairman Bruce H. Bergen)

Vice Chairman Granados inquired as to the success rate of the Family Success Centers.

Director Wagner stated that 465 unique services were offered at the Rahway Center and 954 unique services were offered in the Elizabeth Center.

3. Authorizing the County Manager to award a contract pursuant to a fair and open process, "Request for Proposals" (RFP), to Millennium Strategies for the purpose of grant writing and procurement services in an amount not to exceed \$36,000. (Chairman Bruce H. Bergen)

Freeholder Estrada inquired as to some of the details of their 2016 performance.

Director Wagner stated that they had written 5 grants for the County, and the County received a \$30,000+ grant to help combat the Zika Virus. She stated that the County is still awaiting response on two grant; one pertaining to participate with the ICE program to hold immigration detainees and another one pertaining to a ROID grant. She added that they have done a lot of research on some of the initiatives the County is considering for next year. She added that the County's contract with Millennium Strategies was only for 9 months, equating to \$27,000.

Freeholder Estrada inquired as to the timeframe in which the County should hear back on the outstanding grants.

Director Wagner advised that the ROID grant is expected any day; no decisions have been made on the ICE grant, but that Director Guzzo may have additional information; and finally a trials grant notification is due sometime in the winter of 2017.

- 4. Authorizing the County Manager to award a contract pursuant to a fair and open process, "Request for Proposal" (RFP), for the purpose of providing Comprehensive Federal Government Relations/Lobbying services to the County of Union, for a period of January 1, 2017 through December 31, 2017, in an amount not to exceed \$150,000 to Winning Strategies, Washington/Hoboken Strategy Group. (Chairman Bruce H. Bergen)
- 5. Authorizing the County Manager to enter into an agreement with We Are One New Jersey Inc., Trenton, NJ, to provide social and human services that educate, empower and uplift working families, under the We Are One New Jersey Project, for the period commencing January 1, 2017 through December 31, 2017, exercising the option of an additional year extension from the December 2015 RFP, in an amount not to exceed \$245,000. (Chairman Bruce H. Bergen)

Freeholder Estrada inquired as to the timeframe in which the County should hear back on the outstanding grants.

Director Wagner advised that 517 people have sought service through November 30, 2016. She added that of the 517 individuals, 474 have sought to become citizens. She advised that 210 have already become citizens. She added that the balance of individuals are in various stages of the process; noting that 76 area awaiting fingerprints, 172 are awaiting for interviews, which can take 6 to 18 months, 8 have their process pending and 5 have failed (3 have to re-take the test).

## DEPARTMENT OF HUMAN SERVICES

#### Frank Guzzo, Director

Director Guzzo asked the Board for its indulgence to add two additional resolutions.

Chairman Bergen asked the Director to provide the Board with an overview of those two resolutions.

Director Guzzo advised the first resolution would enter into a new lease agreement for the Probation office (as required by the State) on Front Street in Plainfield. He advised that the County went out to RFP in June for a ten year lease with 2 five year renewals. He advised the backup will be sent to the Board, as we are waiting for the details to be finalized by the attorneys.

Director Guzzo advised the second resolution would enter into an agreement under a state contract for the inmate phone system, advising that GTL is the only vendor on the state contract, and further advised that of the 19 county jails, 14 utilize GTL as their provider. He advised that the rate charged to families will drop from \$0.25 to \$0.04.

- 1. Authorizing the County Manager to award professional services contracts in an amount not to exceed \$63,000.00 for the period of January 1, 2017 through December 31, 2017 to provide additional professional psychiatric medical services to patients of Cornerstone Behavioral Health Hospital. (Freeholder Bette Jane Kowalski)
- 2. Authorizing the County Manager to certify to the NJ Department of Human Services, Division of Mental Health Services that there have been no changes to the plan for the delivery of mental health services and that the County will continue to operate a psychiatric facility during calendar year 2017. (Freeholder Bette Jane Kowalski)
- 3. Authorizing the County Manager to award professional services contracts in an amount not to exceed \$5000 for the period of January 1, 2017 through December 31, 2017 for Specialty Medical Consultants to provide services to patients of Cornerstone Behavioral Health Hospital. (Freeholder Bette Jane Kowalski)
- 4. Authorizing the County Manager to renew a revenue agreement with Bridgeway Rehabilitation Services, Elizabeth, New Jersey, for the period of January 1, 2017 through December 31, 2017 for reimbursement in the amount of \$7.00 per one way trip to the County of Union for the provision of Transportation Service through the Union County Paratransit System for Partial Care clients attending their programs, based upon scheduled trips provided by the County on Mondays through Fridays. (Freeholder Vernell Wright)
- 5. Authorizing the County Manager to continue a Lease Agreement with Runnells BH Operating Inc., for the operations of Cornerstone Behavioral Health Hospital including 44 beds and office space with a 2% increase as per sale agreement for the period January 1, 2017 through December 31, 2017. (Freeholder Bette Jane Kowalski)

Freeholder Estrada inquired as to the current cost of the lease agreement for Cornerstone, noting that this contract calls for a 2% increase.

County Counsel Barry advised the lease rate is \$400,000, however he clarified that the rate is inclusive of the space and a number of services.

Freeholder Estrada inquired if the cost is broken down by square footage, and expressed concerns to the level of service they are providing Cornerstone as per the contract.

Director Guzzo admitted there have been issues relative to the agreement, and advised they have met with Runnells BH over the past year to ensure they comply with the terms of the contract pertaining to those services (housekeeping, dietary, etc). He assured the Board that they do adjust and comply with those standards due to the lease agreement; as opposed to the rest of the hospital proper.

Freeholder Estrada inquired as to the length of the lease agreement.

Director Guzzo advised that the lease is for ten years, noting that he believe this the third year. He advised that the "opt-out" clause is contingent upon many factors, and spoke to some of those clauses.

- 6. Authorizing the County Manager to enter into an agreement with Language Line Services, Inc., Dallas, Texas on an as needed basis not to exceed the total amount of \$38,500 to provide translation services for the large volume of non-English speaking refugee clients of the Division of Social Services and the Department of Public Safety for the period of January 1, 2016 through December 31, 2016. (Freeholder Bette Jane Kowalski)
- 7. Authorizing the County Manager to enter into an agreement with Language Line Services, Inc., Dallas, Texas on an as needed basis not to exceed the total amount of \$38,000 to provide translation services for the large volume of non-English speaking refugee clients of the Division of Social Services for the period of January 1, 2017 through December 31, 2017. (Freeholder Bette Jane Kowalski)
- 8. Amending Resolution Number 2016-915, approving the 2016-2018 Area Plan Spending Plan, to reflect an increase in funding only in an amount not to exceed \$2,080 for a new grand total not to exceed \$4,931,312 to be allocated as outlined and charged to account numbers specified for the same contract year one period of January 1, 2016 through December 31, 2016 with no other changes to the 2016-2018 Area Plan. (Freeholder Vernell Wright)
- 9. Amending Resolution Number 2016-64, approving the 2016 Youth Services Commission Comprehensive Spending Plan, to extend the termination date an additional three (3) month period through March 31, 2017 for all 2016 grant funded subcontracts and program management funds as permitted by the New Jersey Juvenile Justice Commission; to reallocate \$5,355.85 in funds from the UC Juvenile Detention Center detention alternative services contract to the UC Division of Youth Services detention alternative case management contract to be charged to account numbers specified, with no change in the total amount nor further changes to the 2016 Youth Services Commission Comprehensive Spending Plan. (Freeholder Vernell Wright)

10. Authorizing the County Manager to award subcontracts under the 2017 Community Services Block Grant (CSBG) Spending Plan in a total amount not to exceed \$218,304 for the period of January 1, 2017 through March 31, 2017 for the purpose of providing community programming for low income residents of Union County as permitted by NJ Department of Community Affairs (DCA) regulations; further authorizing a one-time advance payment of up to one month of the agency award amount to prevent undue hardship for the agency to carry out program activities; and further authorizing the transfer of funds among awarded agencies during the contract period should service needs change and/or if any of the agencies fails to meet its contractual obligation. (Frecholder Bette Jane Kowalski)

Vice Chairman Granados inquired as to the different organizations that participate in the CSBG Spending Plan, and inquired as to some of the services they provide.

Director Guzzo stated some of the organizations, inclusive but not limited to: the Arc of Union County, Community Access Unlimited, Family Promised, Jewish Family Services, Plainfield Y, Gateway Family, Salvation of Elizabeth and Salvation Army of Plainfield, and Trinitas Regional Medical Center.

Director Guzzo advised that they provide a wide array of services including, but not limited to, support services, rental assistance, wrap around services for case management, and food for constituents deemed eligible from the federal government.

11. Authorizing the County Manager to award the proposed contract obtained through advertised public bidding in accordance with the Local Public Contracts Law, NJSA 40A:11-1 et seq: Department of Human Services/Paratransit System: Shepard Bros, Inc., Canandaigua, New York, for the purchase and replacement, of two (2) ten passenger buses with two wheelchair positions and one (1) 16 passenger bus with two wheelchair positions, in the total amount not to exceed \$163,831. (Freeholder Vernell Wright)

Freeholder Kowalski inquired as to the usage of the vehicles.

Director Guzzo advised that the county would normally purchase vehicles to replace older vehicles. He stated that he had unused funds from the capital budget from previous years and decided to use now. He added that they did not ask for funds in this capital budget.

- 12. Authorizing the County Manager to enter into a shared services agreement with Morris County to house Union County juvenile detainces on an as needed basis by providing a maximum of five (5) secure beds at a per diem cost of \$215 per juvenile per day for a total amount not to exceed \$50,000 per year nor \$250,000 for the five (5) year period of January 1, 2017 through December 31, 2021. (Freeholder Bette Jane Kowalski)
- 13. Authorizing the County Manager to enter into a shared services agreement with Bergen County to house Union County juvenile detainees on an as needed basis by providing secure beds at a per diem cost of \$225 per juvenile per day for a total amount not to exceed \$150,000 per year nor \$750,000 for the five (5) year period of January 1, 2017 through December 31, 2021. (Freeholder Bette Jane Kowalski)
- 14. Authorizing the County Manager to enter into a Uniform Shared Services and Consolidated Act, N.J.S.A. 40A:65-1 et seq. agreement with Hudson County to provide custody and care to its juvenile detainees at the Union County Juvenile Detention Center at a per diem rate of \$245 for Year 1 2017, \$250 for Year 2 2018, \$255 for Year 3 2019, \$260 for Year 4 -

2020, and \$265 for Year 5 - 2021 with Hudson County guaranteeing payment for a minimum of 20 secure beds for the five (5) year period of January 1, 2017 through December 31, 2021. (Freeholder Bette Jane Kowalski)

#### DEPARTMENT OF PARKS AND RECREATION

Ronald Zuber, Director

Armando Sanchez, Director of Recreational Facilities, represented the Department.

1. Approving the operational budget for golf course operational expenses for the period of January 1, 2017 through December 31, 2017 in the amount of \$4,492,114. (Vice Chairman Sergio Granados)

Freeholder Mirabella inquired what the 2016 budget.

Director Sanchez advised the 2016 operational budget was in the amount of \$4.3 million, noting that they anticipate expending \$4.2 million by the end of the year (\$100,000 less than budgeted). He stated that they anticipate utilizing the total \$4.3 million in 2017, as they anticipate the increase due to the requirement of a trailer during the construction. He also noted that they intend to do some additional "in house" upgrades at the two golf courses.

#### OFFICE OF THE COUNTY COUNSEL

Robert E. Barry, Esq., County Counsel

There were neither any questions nor comments from the Board.

1. A resolution appointing John R. Boles as the Public Agency's Compliance Officer (P.A.C.O.) for a term effective January 1, 2017 through December 31, 2017. (Chairman Bruce H. Bergen)
