# THURSDAY, JUNE 2, 2016 MINUTES OF THE AGENDA SETTING MEETING

Chairman Bruce Bergen presided and called the meeting to order at 7:00pm. Roll call showed, Chairman Bruce Bergen, Vice Chairman Sergio Granados, Freeholder Linda Carter, Freeholder Mohamed S. Jalloh, Freeholder Bette Jane Kowalski, Freeholder Alexander Mirabella and Freeholder Vernell Wright were in attendance, with Freeholders Angel G. Estrada and Christopher Hudak not present.

Also present were County Manager Alfred Faella, County Counsel Robert E. Barry, Esq. and Clerk of the Board James Pellettiere.

The Prayer and Salute to the Flag were led by the Clerk of the Board.

The statement of compliance with the Open Public Meetings Act was read by the Clerk of the Board.

#### PRESENTATION FROM THE BOARD

A resolution presentation will be made by Vice Chairman Sergio Granados to the members of the Elizabeth Portugal Day Committee recognizing their work in enriching the cultural perspective within our communities, as well as congratulating them on their Flag-Raising ceremony on Friday, June 3, 2016 and their Annual Portugal Day Parade on Sunday, June 5, 2016.

Vice Chairman Granados, joined by Freeholders Carter and Kowalski, called upon the Portugal Day Parade Committee. He thanked them for their service to the Portugal community and for ensuring that the Portugal heritage lives on. He congratulated Carla Rodriquez for her fine work as President, noting that her pregnancy didn't slow her down.

#### OFFICE OF THE UNION COUNTY PROSECUTOR

Grace H. Park, Acting Prosecutor

First Assistant Prosecutor Tim Isenhour represented the office.

1. Authorizing the County Manager to award the proposed contract obtained through advertised public bidding to STRmix software, NicheVision Forensics, LLC, 526 S. Main Street, Suite 714G, Akron, OH 44311, in an amount not to exceed \$93,300.00. (Chairman Bruce H. Bergen)

Vice Chairman Granados asked Mr. Isenhour to elaborate on the software.

Mr. Isenhour stated that the software will be able to differentiate the different DNA samples in cases where there is more than one trace of DNA. He stated that this software is the preferred choice of the Federal Bureau of Investigations.

Chairman Bergen asked the Clerk to note Freeholder Hudak joined the meeting (7:13pm).

#### DEPARTMENT OF ADMINISTRATIVE SERVICES

#### Michael Yuska, Director

- 1. Renewing the Accident and Health Insurance for Watchung Stables with QBE Insurance Company, New York, New York, from July 1, 2016 through June 30, 2017 in an amount not to exceed \$12,241.00 per year; representing no increase from last year's policy. (Chairman Bruce H. Bergen)
- 2. Resolution authorizing the approval of the Board for proposed changes to NJ Counties Excess Joint Insurance Fund by-laws pursuant to N.J.S.A. 40A:10-39. (Chairman Bruce H. Bergen)

Freeholder Carter asked the Director to elaborate on Agenda Item #3.

Director Yuska stated the software is customized to the County's ABBRA system, which is used to document time and attendance of County employees. He stated that it is a one-time software support contract, noting that every year the County requires this support. He stated that the County has used this software for 5 years.

Freeholder Carter asked if there is a savings by utilizing the maintenance contract, and inquired as to how often the support is utilized throughout the year.

Director Yuska stated that he would provide the Board with a listing of hours of support provided by the previous contract.

4. Resolution declaring various goods as surplus and no longer needed for use by the County, and further authorizing the County Manager to advertise and hold public auction for said surplus goods. (Chairman Bruce H. Bergen)

# DEPARTMENT OF ENGINEERING, PUBLIC WORKS & FACILITIES MANAGEMENT <u>Joseph Graziano, Director</u>

1. Concurring with the Township of Berkeley Heights Ordinance Number 7-2016 establishing parking regulations on portions of Springfield Avenue (CR512), Township of Berkeley Heights, County of Union, New Jersey. (Freeholder Linda Carter)

Freeholder Carter asked if there were any issues that prompted the municipal ordinance.

Director Graziano stated that there were issues regarding parking near the train station that prompted the ordinance. He said that people were parking on Springfield Avenue near the local businesses and walking to the train station. He stated that the ordinance establishes a time limit for parking, which would eliminate this problem. He advised that they have the right to change the parking, but because it is along a County road, the Board must pass a concurring resolution.

- 2. Authorizing the County Manager to award a Professional Architectural Service Contract, through a Request for Proposal (RFP) process, to The Musial Group Architecture of Mountainside, New Jersey to provide Conceptual Design Services/Space Reconfiguration for the Union County Clerk's Office, City of Elizabeth for an amount not to exceed \$5,995.00. (Union County Engineering Project Number 2016-021) (Freeholder Linda Carter)
- 3. Authorizing the County Manager to award the proposed contract obtained through advertised public bidding in accordance with the Local Public Contracts Law, NJSA 40:A11-1 et seq to: Tri-County Termite & Pest Control, Inc., Carneys Point, NJ (BA-24-2014) for the purpose of providing Extermination & Pest Control Management Services for the Department of Engineering, Public Works & Facilities Management, Division of Facilities Management for twenty-four (24) consecutive months commencing June 30, 2016 through June 30, 2018, contract amount not to exceed \$64,009.00. (Freeholder Linda Carter)

Vice Chairman Granados inquired if any companies from Union County had submitted a bid.

Director Graziano stated that this is an extension on a previously awarded bid. He stated that he didn't have the bid responses on this specific bid, noting that the County has used this company for a number of years.

Vice Chairman Granados asked Director Graziano to provide him with the name of the closest Union County bidder and the difference between the awarding bid and their bid.

4. Resolution authorizing the County Manager to enter into a contract with Foley, Inc., Piscataway, NJ, for the purchase of various Caterpillar Equipment; One (1) 2016 CB64B Asphalt Compactor, \$158,809.75; One (1) 2016 323FL Hydraulic Excavator, \$218,864.00; One (1) 2016 930M Wheel Loader, \$184,337.28, for the Division of Public Works through the Middlesex County Regional Education Services Commission MRESC 15/16-08 ID #65 MCESCCPS, in the amount not to exceed \$562,011.03. Freeholder Carter asked if the Director could elaborate on Agenda Item #4.

Director Graziano stated that the County is trading in a 1985 asphalt roller and a 1989 Fiat front end loader. He advised these pieces of equipment to be purchased through this resolution will replace those two pieces of equipment.

- 5. Resolution concurring with the Township of Springfield regarding road closures and a banner for the 4th of July Day Festivities. The 4th of July Day Festivities will be held on Monday between the hours of 3:00 p.m. and 11:00 p.m., (in case of rain on the next clear day) and the Township is requesting permission to close Meisel Avenue from the intersection of Linden Avenue to the intersection of Milltown Road. Also, granting permission to hang a banner across Mountain Avenue at North Trivett from May 15, 2016 to July 4, 2016. (Freeholder Linda Carter)

Resolution concurring with the City of Summit granting permission to the Overlook Foundation for their 5K Run, which will be held on Wednesday, June 22, 2016 from 3:00 p.m. to 9:30 p.m. to close certain county roads for the event. Freeholder Carter asked the Director to elaborate on Agenda Item #2.

Director Zuber advised that the Laser Grading Box is a box that is attached to the back of a tractor and has a blade on it which cuts and levels the playing surface. He advised that right now the leveling is done by eye. He advised that this attachment will allow the driver to see, while he is grading the field, exactly how level the field is. He advised that it can be used for basketball and volleyball courts.

#### **DEPARTMENT OF PUBLIC SAFETY**

#### Andrew Moran, Director

1. Authorizing the County Manager to enter into an agreement obtained through advertised public bidding in accordance with the Local Public Contracts Law, NJSA 40:A11-1 et seq with I. Miller Precision Optical Instruments, Feasterville, PA., (BA 26-2016) for the procurement of an FSC Comparison Macroscope, in the amount not to exceed \$65,229.00. (Freeholder Angel G. Estrada)

Freeholder Carter asked the Director to elaborate on Agenda Item #1.

Director Moran stated the County's eleven year old microscope, which is used in the ballistics lab, continues to have maintenance issues. He advised that this new microscope has higher quality optics and a high definition camera that will benefit the ballistics examinations and will aide in presentations in court. He added the new microscope will have a better zoom as well. He advised the Board that the ballistics lab is very active, as they prepare a ballistics examinations on every firearm that is confiscated in the county.

- 2. Authorizing the County Manager to enter into an agreement with Trinitas Regional Medical Center Mobile Intensive Care Unit(MICU), 225 Williamson Street, Elizabeth, NJ, in accordance with Local Public Contracts Law, NJSA 40A:11-1 et seq., for the provision of advanced life support dispatching services, in the amount of \$80,000.00 for the contract term of five (5) years, with a 2% increase per year for the remaining four (4) years. (Freeholder Angel G. Estrada)
- 3. Authorizing the County Manager to enter into a Shared Services Agreement with the Township of Clark to provide 9-1-1 Emergency Medical call screening and EMS Dispatch services in an amount of \$9,550.87 for the first year, with a subsequent two percent (2%) increase in each additional year for the remaining four (4) years of the five (5) year term of the agreement. (Freeholder Angel G. Estrada)

Chairman Bergen asked the Director to explain Agenda Items #3 and #4.

Director Moran stated that both Agenda Items #3 and #4 are renewals of contracts for dispatch services in Mountainside and Clark, noting that in both municipalities the County provides Emergency Medical Dispatch, and dispatch their local First Aid Squad. He stated that the County has provided the service for the past three years.

County Manager Faella asked Director Moran to elaborate on the County celebrating 5 years of Emergency Dispatch Services.

Director Moran stated that on June 4, 2016 the County celebrated the 5<sup>th</sup> Anniversary of the launch of the Countywide EMS Dispatch program. He noted that when they started the program, the County provided one ambulance, Monday through Friday. He stated that currently the County staffs five ambulances Monday through Friday with 24-hour service for EMS. He stated that over the past 5 years, the County has responded to over 16,000 emergency calls.

- 4. Authorizing the County Manager to enter into a Shared Services Agreement with the Borough of Mountainside to provide 911 Emergency Medical call screening services in the amount of \$5,953.37 for the first year, with a subsequent two percent (2%) increase in each additional year for the remaining four (4) years of the five (5) year term of the agreement. (Freeholder Angel G. Estrada)
- 5. Authorizing the County Manager to accept and expend a New Jersey Department of Environmental Protection, County Environmental Health Act (CEHA) Grant Funds in the amount of \$180,000 to support CEHA activities for the contract period of July 1, 2016 through June 30, 2017 and match in the amount of \$180,000 through in-kind funds. (Freeholder Angel G. Estrada)
