The Honorable Karen M. Cassidy, Assignment Judge, Superior Court of the County of Union, called the meeting to order at 12:07pm.

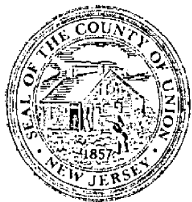

Senator Scutari recognized and called upon Senator Raymond Lesniak.

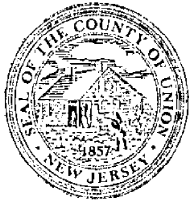

Honored Clergy, fellow Freeholders, elected officials, family, friends, and citizens of Union County:

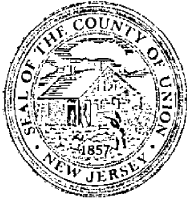
Happy New Year to all, and thank you for being here today. In particular, thanks to the Jets fans who will be missing the beginning of their very important game against the Bills.

I also want to thank my friends who have joined us today including, of course, the members of the Springfield Democratic party who have accompanied me through most of my 35 years in local politics and government, which has brought me here today. In particular I must mention my late friend Bill Cieri, former Springfield Mayor, who took me under his wing and taught me so much.

I would be remiss if I did not thank my friend and mentor, former Democratic County Chairman, Charlotte DeFilippo for all that she did to teach me and guide me over the course of more than 30 years of friendship.

Also, congratulations to my dear friend from Springfield, and our distinguished County Clerk, Joann Rajoppi, for her overwhelming re-election.

I would like to acknowledge and thank my predecessor, Chairman Mohamed Jalloh for his leadership of the board in 2015. In fact, during my three years on the Board I have had the benefit of learning from three excellent Chairs, Freeholder Carter, Freeholder Hudak and Freeholder Jalloh, all of who are role models for me and have helped bring our County to where it is today.

I also welcome our new Vice Chairman, Sergio Granados. Your energy and enthusiasm continues to be an invaluable asset to this board, and I look forward to serving beside you.

Finally, I would like to thank my colleagues for electing me to serve as Chairman. I look forward to working with each and every one of you in the coming year as we continue the progress.

My story is not unlike others who have Union County roots with working class parents. I was born in Elizabeth, raised in Cranford and made my home in Springfield. I have helped build a long-standing business in Elizabeth and now Cranford, as my father once did.

I learned much from my parents about the importance of hard work and commitment to the community, and that helped inspire me into a life of public service.

As Israeli Prime Minister Golda Meir said about public service, "I never did anything alone. Whatever was accomplished...was accomplished collectively." This Freeholder Board succeeds because we are a team that puts commitment to others and the community above individual interest.

With this in mind, I am announcing a set of initiatives entitled "One County, One Community," that demonstrates this board's commitment to all of our citizens. We will focus on initiatives impacting:

- transportation;
- economic development;
- services for seniors, women and Veterans;
- education; and
- parks and environmental programs.

My first initiative, entitled “Move, Connect, Grow” addresses one of Union County’s greatest assets—our transportation infrastructure.

As part of this, we are drafting an update to our Transportation Master Plan, which is perhaps one of our most important planning documents. After an opportunity for continued public comment a final report will be released by June.

Next, we will once again offer “Infrastructure Grants” to our municipalities. The grant program, which was originally envisioned by Freeholder Hudak, can be used to fund a variety of projects. But because maintenance of roads is a priority of our residents, we will ask municipalities to prioritize local road paving.

Residents have also asked for new bike paths. I am pleased to announce we will be working to create unique paths for cyclists, hikers, and horse riders in the Watchung Reservation. This plan will be unveiled soon.

Along with Freeholder Kowalski on the Raritan Valley Rail Coalition and Freeholder Estrada on the NJTPA, we will continue our advocacy to expand the one-seat ride to New York City and for the construction of the new Gateway Tunnel project.

Both are so critically important to the economic vitality of this region.

This drive to improve our transportation network complements my second initiative “Union County: At Work and Play.” This initiative includes new jobs, business assistance grants, and quality of life improvements, as well as economic development programs.

First, we talk about jobs—and Union County has had a lot of success in this area. At the end of 2014, the Freeholder Board announced a \$2.3 million investment creating the Union County Workforce Innovation Center at the Mills at Jersey Gardens. This has resulted in well over 1,000 job opportunities for County residents in 2015. I am pleased to announce,

with the cooperation of the County College we will continue to create more job opportunities, as the Innovation Center becomes a regional hub.

Coming from a background in small business, I recognize that government has an important role to play in spurring growth with incentives and loans. Thanks in part to a match from the County, the UCEDC was recently awarded a \$1.3 million grant from the federal government to make loans ranging from \$50,000 to \$250,000 to small businesses.

The New Year will also witness a series of ribbon cuttings and special announcements for our County College and our Parks system. You may have noticed various renderings of those projects on display outside the courtroom:

- We will cut the ribbon on the new Warinanco Skating Rink, where we will continue to make memories for future generations. I too have my own memories, as I learned to skate there, as did my son and daughter.
- We will also cut the ribbon on the expanded Watchung Stables, which creates an indoor ring to enable year-round use.
- Just down the road from the Stables, the Union County Trailside Nature and Science Center will be marking its 75<sup>th</sup> anniversary with a series of programs.

This July will also witness two prominent golf tournaments in Union County: The PGA Championship will once again be at Baltusrol Golf Course in Springfield and the 96<sup>th</sup> annual NJ State Golf Association Open Championship will tee off at the Galloping Hill Golf Course—marking the first time ever it has been held at a public course.

We should all take pride that our investment in our Golf Division continues to reap dividends.

With regard to Union County College, we expect to have two ribbon cuttings—one at the refurbished Plainfield Campus in June and then at the expanded Cranford campus in July. These drawings are in the lobby as well.

This past year, the College reported its highest graduation rate in over 20 years, and the largest group of graduates ever.

Union County College educates the largest number of Associate Degree-prepared nurses in the State, which brings me to my next point:

UCC has announced it is seeking to become the first Community College in the state to offer a bachelor's degree in nursing. I will ask my colleagues on the board to put forward a resolution at our next meeting, supporting that effort. Thank you Dr. McMenamin for your partnership with our board.

Our library grant program, which was envisioned by Freeholder Kowalski, began last year and proved to be wildly popular. This year we will double the amount of money we offer for grants, because all Union County communities deserve a great library.

My third initiative addresses the importance of digital technologies and governmental outreach. The past decade has witnessed a dramatic change in how governments communicate with their residents. While this outreach still involves traditional media, it also involves social and web-based media. The County of Union has been a leader in these areas, being one of the first in New Jersey to open a Facebook account, and the first to have an Instagram account.

With the expansion of the use of Apps, I am announcing the creation of the Union County App in 2016. This will help users stay informed and safe with the almanac of information and real-time data it will feature. In fact, today we are taking pictures which will shortly be posted on our social media. And, if you have not yet gotten our new card listing our social media accounts please make sure you get one before you leave.

Also, on Earth Day, the Union County App will feature a special new section on my fourth initiative, "Union County Means Green."

Even as we enjoyed the fabulous weather the past month, it is hard not to wonder if global warming could be at play, and not just the polar vortex.

Since the new millennium, Union County has worked to implement green initiatives through our Open Space Program, through LEED certified buildings, solar panels, recycling initiatives, and composting.

This year brings several new programs including a "Union County Means Green" seminar for businesses. This will be presented through our popular Union County Means Business series. Also, through our Recycling Bureau, we will introduce an educator who will visit our grammar schools to teach recycling in a program ironically titled "Talkin' Trash."

Although we hear it less often, New Jersey is still known as the “Garden State,” because of its rich agricultural tradition. In acknowledgement of this history, UC Means Green will offer a “Community Garden Grant” program for new and existing gardens.

Having grown up in Cranford close to the Rahway River, and then buying a house in Springfield near the river, I know full well the devastation that flooding has created within our towns. As the Rahway River Flood Mitigation plan moves forward, my colleagues on the Freeholder board and I will continue to advocate for the plan and for Federal and State funding.

These initiatives have addressed many issues, but what about taking care of those most in need?

For as a great American and former Vice President, Hubert Humphrey, one of my personal heroes, once said, “The moral test of government is how that government treats those who are in the dawn of life– the children; those who are in the twilight of life– the elderly; and those who are in the shadows of life– the sick, the needy and the handicapped.”

In the past, in spite of cuts in state funding, this Freeholder Board has fully funded the safety net in Union County. We will continue to be prepared to take the necessary steps to restore funding to essential programs that may be cut this year by the state or federal government.

My fifth initiative therefore aims to assist those who have been there for us, and continue to play a vital role in our community: our seniors and Veterans, and also our Union County women.

Following the lead of Freeholder Wright, who has often focused on the needs of our seniors, we declare 2016 as the “Year of the Senior” through two programs last offered in 2000: Seniors in Motion, and the Senior Focus program.

Through Seniors in Motion, the County will provide municipalities with a passenger van to offer senior citizen transportation services. We are aiming to begin the application process through our Human Services Department by the end of March.

We will also re-offer the “Senior Focus” program, which is a grant program dedicated to improving and enhancing senior centers in each of our 21 municipalities. During the last round, Senior Focus awards were used for major brick and mortar projects. This time

around we anticipate funding for smaller items such as new kitchens, new doors, windows, or other interior objects or renovations.

Next, we will create the Union County Division on Women. This one-person office will help provide information women need to access government services and resources. It will also serve as a referral source, an advocate and to coordinate with programs such as “UC Women Means Business,” the Rape Crisis Center, and the UC Commission on the Status of Women.

As the final part of this initiative, we will launch the “UC HERO” program in honor of our Veterans, who have defended our Country. Administered through Human Services and Veterans Affairs, this program will partner with the Workforce Investment Board and the County College to assist our Vets with a variety of programs.

This includes:

- employment services, training and job fairs;
- encouraging businesses to hire-a-Vet; and
- connecting our Vets with the social services they may require.

A strong Union County community must also be a safe one, and we are committed to providing programs to further this objective in 2016. My sixth initiative, addressing public safety includes several items:

- We will shortly unveil a new GIS system that will actively assist first responders in emergencies;
- We will launch the “Fire Mutual Aide Radio project,” an effort to equip the County’s 20 Fire Departments with compatible radios to promote communication during emergencies;
- We will continue to install cameras in various County parks.
- And the Sheriff’s Office will continue to train for active shooter response at our county facilities to better protect our employees and the public.

My final initiative addresses the need for a regional animal shelter that would provide our municipalities with a consistent level of animal control services and promote humane treatment. Previously, the County commissioned a feasibility study for an animal shelter. With many municipalities struggling beneath the weight of this mandated service, we will

now revise this plan and move forward with design and siting. On today's agenda, we will vote to take the next step in the process.

The shelter will provide adoptive services and be run by the County, with volunteers. We are hoping to have plans in place and unveil them this summer during a new event "Bark in the Park" at the Union County Dog Park at Echo Lake.

Taken as a whole, "One County, One Community" initiatives are not only designed to create a vision and game plan for 2016, but also to challenge us to do better for our community. I look forward to working with our County family, our employees, our many private social service agencies and residents in bringing the community together in achieving these objectives.

Once again, I wish you all a very Happy New Year.

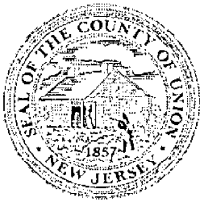


