PUBLIC COMMENT PORTION

The meeting is open to the public for the purpose of commenting on Resolutions being offered for adoption only.

Chairman Scanlon announced that all speakers must refrain from using foul language and the officers must be addressed by title.

Bruce Paterson, Garwood, made comments pertaining to the following Resolutions:

In reference to 2011-943, he claims that it is a substantial amount; 2011-954 he commented on the grant money and services provided by the County; 2011-964, he said he appreciates the Freeholders questions and the Directors responses.

Mr. Paterson commented on the cost pertaining to the installation of the dark fiber as mentioned in Resolution 2011-964. He asked if the City of Elizabeth will reimburse the County. Chairman Scanlon replied, yes.

Mr. Paterson asked if the amounts being modified in Resolutions 2011-970, 971, 972 and 974 will be spent on other programs or if the dollars will offset taxes to the residents. In reference to Resolution 2011-981, he said he appreciates the savings. He said that Resolution 2011-983 appears to be duplicate insurance and on Resolution 2011-984, he claims that the amount appears to be substantial for the services mentioned.

John Bury, Kenilworth, stated that the item mentioned in Resolution 2011-962 was rescinded approximately one month ago and said it is on tonight's Agenda, and added that the vendor does not have a website. In reference to Resolutions 2011-998 and 2011-999, he commented on representation and law suits involving County employees.

Administrator Wheeler responded to Resolution 2011-943. She mentioned the supplies and their costs that are provided by Penn Jersey Paper Company, and added it is a contract through Novation.

Deputy Director Dinsmore responded to Resolution 2011-954. She said the contract has been increased by approximately \$118,000 in grant dollars for additional services for the Paratransit system.

Director Guzzo stated that Resolutions 2011-971, 972 and 974 are existing grants, not new grants.

Director Taylor stated that the purpose of Resolution 2011-975 is to cancel the various grant appropriations. According to Chapter 159, if the grants are not spent, they are required to be cancelled.

Vice Chairman Mirabella explained further the nature of cancelling or rescinding grants. Director Taylor gave a scenario of a lead grant.

Vice Chairman Mirabella asked how often the Finance Department "cleans house." Director Taylor replied when the grants are closed out. Every grant has a different period.

Director DiRado responded to Resolutions 2011-981 and Resolutions 2011-983. He explained that Resolution 2011-981 includes the cost of delivery and fuel. He said the price they received is less than the amount the State is paying. Chairman Scanlon asked if it is for all fuel costs. Director DiRado responded it is for diesel. In reference to Resolution 2011-983, the County insures the construction interests and delay in construction time, if there is a loss in revenue.

Director Graziano stated that Resolution 2011-984 is a "not to exceed" amount. The items are for

high security locations, such as the jail. The amount includes more than keys, like electric locks and card readers. He said the cost is typical for an organization of our capacity.

Freeholder Carter asked it Resolution 2011-984 is to extend the contract. Director Graziano replied, yes, for an additional two years.

County Counsel Barry explained Resolutions 2011-998 and 2011-999. He explained that the County has an obligation to represent former County Manager Devanney, like any other County employee. He said regarding the allegations made, they are not necessarily true and will be defended in a court of law.

Chairman Scanlon made mention of the passing of Helen Hegy, the Deputy County Manager's mother.
