PUBLIC COMMENT PORTION

The meeting is open to the public for the purpose of commenting on Resolutions being offered for adoption only.

George Khatriharitis, Elizabeth, made comments referring to Resolution Number 2011-894, the contract with Aramark, providing his opinion of the quality of the food and advising that because the inmates throw it out, there is no need to enter into the contract. He also made comments regarding extreme, radical Muslim inmates.

Bruce Paterson, Garwood, made comments relative to 2011-884, to provide sports court resurfacing. He asks which courts are being resurfaced, on 2011-885, he asked why only 11 municipalities are receiving grant funds. Resolution 2011-887, 2011-888 and 2011-889 he asked if these funds are to offset the budget. He commented on 2011-893, relative to how insurance companies are compensated. Mr. Paterson commented on 2011-894 on the cost of the meals provided. In reference to 2011-900, he stated that the cost is extreme and asked if it has been competitively bid, if a benefit analysis has been done, asked about the pay-back period and if the amount includes engineering fees. In reference to 2011-904, he asked how many ramps are being installed and the scope of the oversight. Mr. Paterson also asked about the Web Creations Resolution which was pulled after last week's meeting.

Deputy Director Ronald Zuber explained that Resolution 2011-884 is for interlocking surfacing pieces for six different tennis and basketball courts which will be advantageous for maintenance purposes.

Administrator of the Office of Open Space, Recreation and Historic Preservation, Vikki Durbin-Drake advised that the other 10 municipalities did not apply for the grant.

Director Taylor responded to questions about Resolutions 2011-887, 2011-888 and 2011-889. She said these are grant dollars used to offset current County programs, and without these funds, we could not provide these services our constituents.

Director Graziano stated that Resolutions 2011-900 and 2011-904 and fully funded by Community

Block Development Grants, including the engineering services. He said the road resurfacing project amendment includes replacing all handicapped ramps. The Federal government gave the county funding to do the extra work which they are requiring.

Director Riordan explained Resolution 2011-894, stating that the actual budget for meals is currently \$12,000 under the budget, because the population fluctuates. He said they meet periodically with the vendor if there are complaints about the food. He said the complaints are not about the quality of the food, but the lack of condiments and temperature. He said that they put together an inmate council to address group issues.

Director Riordan stated that there are no particular problems regarding Islamic Radicalization, but we do have a thorough and dedicated Intelligence Unit which monitors threats.

Jim Beuttner, Cranford, asked for an explanation of Resolution 2011-879 and Resolution 2011-882. He opposes hydroraking Sperry Pond Park. He asked for an explanation of the Greening Union County Grant and Resolution 2011-886 to Preserve Union County's Matching Grant. He said he does not support Resolution 2011-897, and wishes the County came to Cranford in its' hour of need.

Director Yuska explained Resolution 2011- 879. He stated that there is pending legislation to publish estimates of bids prior to opening. He said the NJAC and the Purchasing Association are opposed and seven other counties approved a similar Resolution.

Administrator of the Office of Open Space, Recreation and Historic Preservation Trust Fund Vikki Durbin-Drake explained Resolution 2011-882. She stated that hydroraking is normal maintenance of ponds. It is a method of removing nuisance vegetation. Sperry Pond consists of approximately three acres. She commented on dredging. Additional, she said that Preserving Union County was established in 2003, 2005, 2007, 2009 and 2011 and is in-line with the intent of the Open Space, Recreation and Historic Preservation Trust Fund for preservation. She said a total of \$500,000 is available in matching grants to local historic preservation groups and municipalities who are eligible.

Ms. Durbin-Drake stated that in reference to Resolution 2011-885. The Greening Union County Program was established in 2004 for the purpose of putting trees back into the community. It is a tree for tree match, and both grants are dollar for dollar matches.

Director Graziano explained that Resolution 2011-897 is to allocate funds for the maintenance of gauges and maps along the Rahway River. Our share of \$25,000 is the cost to maintain the system. He said there is one gauge in Springfield, one in Kenilworth and 2 in Rahway.

Director Graziano spoke about his Department's responses to Hurricane Irene. He said manpower and financing is still ongoing. He said the County has spent hundreds of thousands of dollars on the storm, and provided much manpower. He stated that the Freeholders were in Cranford and the Public Safety, Parks and Public Works Departments were all on hand and no municipality was refused help.

John Bury, Kenilworth, opposes Resolution 2011-879, and supports the pending legislation.

Chairman Scanlon responded regarding the amount of money spent on the hurricane.

Tina Renna, Cranford, asked questions regarding 2011-879, and questions the intent of the

legislation.

Director Yuska said that the purpose of Resolution 2011-879 is to oppose the pending legislation. He said it does not affect local public contracts law in any other way than already specified. There are very strict laws about how to reject bids and they are very well regulated.

Tina Renna, Cranford spoke about the Union County Utilities Authority arrangement and the Harrisburg's bankruptcy situation. She also commented about Musicfest.

County Counsel Barry, Esq. responded to comments relative to MusicFest. He explained that in reference to the handling of funds, Prosecutor Romankow recommended that the Love Hope Strength Foundation dollars are kept in a separate counting room and the funds should not be placed in the same safe as other revenue from MusicFest. He added that the 50/50 raffle is strictly a Love Hope Strength activity and the County has no involvement.

John Bury, Kenilworth, does not support Resolution 2011-879. Mr. Bury made comments opposing the Union County Utilities Authority/Covanta arrangement.

Adina Toescu-Enculescu, Westfield, made comments about a crosswalk and traffic sign built in front of her house and near her driveway. She stated that there have been accidents.

Chairman Scanlon asked Ms. Toescu-Enculescu to speak to Director of Engineering, Thomas Mineo.

Maria Carluccio, Westfield made comments regarding the intersection and light installed on Central Avenue, indicating it is not safe.

Sherry Bolk, Plainfield, made comments regarding political signs on roads that are not picked up after the election. She spoke about the maintenance of the Park Madison building. She indicated that promises to allow parking in the garage over the weekend were not fulfilled. She asked questions regarding Covanta and electricity production to lower costs to residents.

Mr. Guzzo responded to the questions regarding the maintenance of the Park Madison building.

He said under the old contract, the County did not share in profits from electricity generation, but under the new contract, we will. He said the issue in Harrisburg is totally irrelevant to what is going on in Union County. He said the UCUA has paid bonds every month, every year without delinquency. He said the Department of Environmental Protection and the Local Finance Board, both, agreed the deal should go forward.

Freeholder Sullivan commended the resident of Westfield for speaking on behalf of her neighbor regarding the Central Avenue light. He said something does not sound right, and we should look into it.

Freeholder Jalloh congratulated the Union County Vocational-Technical students. He commended his colleagues in supporting Cranford with recovery efforts during and in the weeks following Hurricane Irene. Freeholder Jalloh commended Director Graziano and his staff for their hard work.

Freeholder Jalloh stated that he went to Trailside Nature and Science Center and urges residents to go and also urges all eligible voters to participate in the voting process on November 8th, or get a vote by mail ballot application at the Union County Clerk's Office or in person at the County Clerk's office. The ballot can be filled out and your vote can be cast there. For more information about voting by mail, call the Union County Clerk at 908-527-4996.

Vice Chairman Mirabella said that he enjoyed the Italian Flag Raising event, and announced Red Ribbon Day is October 22, 2011 in Oak Ridge Park, which celebrates keeping kids off drugs and alcohol.
