OFFICE OF THE UNION COUNTY CLERK

Joanne Rajoppi, Union County Clerk

Deputy Clerk Alan Falcone represented the Office.

1. Authorizing the County Manager to enter into a contract with Allstate Information Management, Paterson, New Jersey to provide storage services for Union County restored maps for a period of 24 consecutive months in the amount of \$370 per month for a total amount of \$8,880. (Chairman Deborah P. Scanlon)

Chairman Scanlon asked about the restored maps, as mentioned in item #1.

Deputy County Clerk Alan Falcone stated that they are tax maps and filed maps of subdivisions dated back to the 1800s. They have been restored, and are being housed in an environmentally controlled facility.

Chairman Scanlon asked about the effects of the environment on the maps if they were taken out to be viewed. Mr. Falcone stated that if they are taken out periodically, they will not be affected, however, if they are exposed to the natural environment for a long period of time, they will deteriorate.

Freeholder Estrada asked what is being considered for a long term solution for storage.

Mr. Falcone stated that they are digitized and stored on CDs.

Freeholder Carter asked if this is the first time they are being stored in this fashion. Mr. Falcone replied, no, they have been restored this way for the past 7 years. This is a renewal contract and the same vendor has been used for the past 4 or 5 years. The maps are old and fragile and they should be preserved for the long term. The contract was rebid and this vendor was the lowest bidder.

Freeholder Carter asked what the best and cost effective way is to store these maps. Mr. Falcone stated that acid free box covers are the best for printed materials.

Joseph Graziano, Director

- 1. Concurring with the Borough of Kenilworth, granting permission to the Pride in Kenilworth Committee to close the Boulevard from 23rd Street to 18th Street on Sunday, October 23, 2011 from 7:00 A.M. to 7:00 P.M. for the annual Kenilworth Street Fair. (Chairman Deborah P. Scanlon)
- 2. Authorizing the County Manager to award the proposed contract obtained through advertised public bidding in accordance with the Local Public Contracts Law, NJSA 40A:11-1 et seq: Department of Engineering, Public Works and Facilities, Division of Facilities Management: Bayway Lumber, Inc., Linden, New Jersey, for the purpose of providing lumber and associated materials for twenty-four consecutive months, in the amount of \$302,298.52. (Chairman Deborah P. Scanlon)
- 3. Authorizing the County Manager to award a contract to Pennoni Associates, Inc., of Edison, NJ for the purpose of providing Professional Engineering Services for a Traffic Study for the County Complex at Elizabethtown Plaza, Elizabeth, New Jersey in the amount not to exceed \$70,600.00. (Chairman Deborah P. Scanlon)

Freeholder Sullivan had questions pertaining to item #3, and stated that the garage is expected to open next month. He had questions about the new traffic lights being installed and the new traffic patterns that will be needed to accommodate the 1,500 parking space garage.

Director Guzzo stated that the Sheriff's Office asked that we do a study of the entire area after the garage is open. There will be different traffic patterns and Pennoni Associates will study the entire area to see what other areas will need changing. Once the garage opens, there will be a drastic change in traffic flow.

Freeholder Sullivan said that he would like to be advised of the changes and lot closings.

4. Authorizing the County Manager to award a contract to Neglia Engineering Associates, Lyndhurst, New Jersey for the purpose of providing Professional Engineering Services for 2012 Road Resurfacing Project in the amount not to exceed \$274,893.00. (Chairman Deborah P. Scanlon)

Vice Chairman Mirabella asked for the entire scope of the project as mentioned in item #1415.

Director Graziano stated that \$274,893 is for engineering services, and explained that 11.83 miles of paving will be done throughout the County in 2012, which will come from the County Capital Funding. It will also include handicapped ramps throughout. He said the cost associated is \$3.8 to 4.0 million depening on the cost of the blacktop. He said this firm has been doing work for the County since our layoffs; prior to that, the work was done in-house.

5. Amending Resolution Number 2010-797, 9/16/10; BA#66-10, a contract (through public bidding process) with GPC, Inc., Millburn, New Jersey approving Change Order No. 1, for the

Union County Interior Alterations & Expansion for the Ruotolo Building, Elizabeth, New Jersey, to increase the original contract amount by \$68,083.50 for a new contract amount of \$997,083.50. (Chairman Deborah P. Scanlon)

Vice Chairman Mirabella asked for the scope of the project in item #5 and the purpose of the Change Order.

Director Graziano explained that the former child care center is getting turned into office space for the Prosecutor's Office, and this is the soil which needed to be removed from the site. He stated that there will be an additional change order forthcoming. He said that they anticipated that the County would be doing a lot of the work, such as the erecting walls, doing the electrical wiring and installing ceiling tiles. He said that we will need to purchase our own materials.

Vice Chairman Mirabella asked how the Prosecutor will utilize this space. Director Graziano stated that to his knowledge, it is just office space, but has no specifics. He said he will ask and get back to the Board.

DEPARTMENT OF FINANCE

Chairman Scanlon asked for the purpose of item #5, and if we have used this vendor in the past. She said in the past couple of years, there were questions regarding reimbursements to Runnells Specialized Hospital.

Director Taylor stated that they are working hand in hand with Runnells Specialized Hospital to capture as much as they can from Medicare and Medicaide. She said that there is also an Indirect Cost Plan to recouple monies back to the County for programs that the County runs.

DEPARTMENT OF HUMAN SERVICES

Frank Guzzo, Director

There were no questions pertaining to items on the Agenda.

Director Guzzo stated that he will have an additional Resolution for next week's meeting and he explained that the County received notification from the Federal government that the County will be receiving approximately \$300,000 for workers who have been temporarily, or maybe permanently dislocated as a result of Hurricane Irene. The relief is to assist businesses for job training costs and more.

County Manager Faella stated that the County has been working with Cranford's downtown economic development, and these monies will assist businesses, as a result of Hurricane Irene.

- 1. Authorizing the County Manager to modify Resolution Number 2011-309 to allocate additional Ryan White funds in the amount of \$212,070 for a revised total allocation in the amount of \$379,000 to the various agencies to provide support services to people with HIV/AIDS for the period of March 1, 2011 through February 29, 2012 and to further authorize the County Manager to transfer funds among various agencies during the contract period should service needs change and/or if any of the various agencies fails to meet its contracted obligation. (Freeholder Bette Jane Kowalski)
- 2. Authorizing the County Manager to modify Resolution Number 2011-308 to allocate additional Ryan White funds in the amount of \$976,148 for a revised total allocation in the amount of \$1,666,700 to various agencies for the period of March 1, 2011 through February 29, 2012 for the purpose of providing services to people with HIV/AIDS and to further authorize the County Manager to transfer funds among the agencies listed during the contract period should service needs change and/or if any of the various agencies fails to meet its contractual obligation. (Freeholder Bette Jane Kowalski)
- 3. Endorsing the Union County CY 2012 Alliance Plan, required by the Governor's Council on Alcoholism and Drug Abuse, which details by municipality the Municipal Alliance activities that are planned for the funding period of January 1 through December 31, 2012. To authorize the County Manager to award subcontracts with the municipalities/agency listed on the attached spending plan for the grant period of January 1 through December 31, 2012 under the 2012 Municipal Alliance Program. This resolution would further authorize the County Manager to transfer funds among the municipalities/agencies listed during the contract period should service needs change and/or if any of the listed municipality/agencies fails to meet its contractual obligation. Municipal/agency grant recipients have an obligation to make a matching cash appropriation of 25% of the award and 75% in-kind match. (Freeholder Bette Jane Kowalski)
- Authorizing he County Manager to apply for and accept a grant from the New Jersey Department of Human Services (NJDHS), Division of Mental Health and Addiction Services (DMHAS), for approximately \$929,792 in CY2012 Alcoholism/Drug Abuse Grant funding, for

the grant period of January 1, 2012 through December 31, 2012. The required County match is \$120,345. (Freeholder Bette Jane Kowalski)

- 5. Authorizing the County Manager to award PY 2011 WorkFirst New Jersey (WFNJ) General Assistance (GA) funding to Union County College "Project Achievement" in an amount not to exceed \$ 327,940.00 for the nine (9) month period: October 1, 2011 through June 30, 2012 for providing employment directed services for GA public assistance recipients. - 6. To authorize the County Manager to award contracts to various agencies for the nine (9) month period: October 1, 2011 June 30, 2012 under the Work First New Jersey Temporary Assistance to Needy Families (TANF) Program. Vice Chairman Mirabella asked if this is the first time we are applying for this grant. He also asked for the purpose.

Deputy Director Zuber stated that this is time the first time we are applying for the grant. We requested \$74,000 to be used in Cedar Brook Park, Warinanco Park and Unami Park for tennis courts. He stated that our courts are lying dormant in some cases, and could use some maintenance.

The grant would be used to enhance the facilities, resurface, hire maintenance workers, and provide additional programming opportunities.

Chairman Scanlon asked if pickleball is scheduled for Saturday. Deputy Director Zuber responded, yes.
