RESOLUTIONS

DEPARTMENT OF ADMINISTRATIVE SERVICES

M. Elizabeth Genievich, Deputy County Manager / Director

Director Michael Yuska of the Division of Purchasing represented the Department.

- 1. Authorizing the County Manager to award the proposed contracts obtained through advertised public bidding in accordance with the Local Public Contracts Law <u>N.J.S.A.</u> <u>40A:11-1 et seq:</u> (CHAIRMAN SCANLON)
 - a. <u>Department of Engineering, Public Works and Facilities, Division of Facilities</u> <u>Management:</u> **Positive Attitude Industries, Inc., Marlboro, New Jersey,** to provide and deliver janitorial maintenance chemicals for a period of 24 consecutive months in the amount of **\$463,755**.
 - b. Department of Engineering, Public Works and Facilities, Division of Facilities Management and Runnells Specialized Hospital: AA Electrical Contractors & Design, Inc., Freehold, New Jersey, to exercise an extension option to provide electrical system repairs, maintenance and installation services for the period of July 1, 2011 through June 30, 2013 in the amount of \$712,440. {All terms and conditions remain the same.}
 - c. Department of Parks and Community Renewal, Division of Golf Operations: Agrium Advanced Technologies, North Brunswick, New Jersey in the amount of \$46,743.34; Reed & Perrine Sales, Tennent, New Jersey in the amount of \$521,923.35; Grass Roots Turf Products, Inc., Randolph, New Jersey in the amount of \$3,555 and John Deere Landscape, Cleveland, Ohio in the amount of \$18,768.80 to provide and deliver ground maintenance chemicals for a period of 24 months.
- 2. Authorizing the use of contracts obtained through participation in the **Cranford Police Cooperative** for possible use in 2011 as an exception to bidding. (CHAIRMAN SCANLON)

Vice Chairman Mirabella asked if other towns have been researched for the use of competitive bids. Director Yuska replied that this is strictly to help Union County receive police cars. He said the Crown Victorian will replace the Ford Taurus as the Prosecutor's would like to purchase at least one vehicle. Vice Chairman Mirabella asked about the State. Director Yuska replied that the State chose the Chevrolet Impala.



- 3. Amending Resolution Number 2010-1155, which authorized the possible use of **Somerset County Co-Op** in order to add new vendors and adjust amounts of estimates. **(CHAIRMAN SCANLON)**

County Engineer Thomas Mineo represented the Department.

- Concurring with the City of Summit, granting permission to Our House Foundation, Summit, New Jersey, to close Broad Street from Summit Avenue to Maple Street between 12:00pm and 5:00pm on Sunday May 1, 2011 for the 5-Mile Run Event. (CHAIRMAN SCANLON)
- 2. Granting permission to the **Borough of Roselle Park**, to close Chestnut Street, from Warren Avenue to Grant Avenue on Saturday, June 11, 2011, from 4:00pm to 8:30pm and on Saturday, September 17, 2011 from 3:00pm to 7:30pm for the "Crusin' Night Car Shows." (CHAIRMAN SCANLON)
- 3. Concurring with the Township of Berkeley Heights, granting permission to the Berkeley Heights Youth Soccer Club, Berkeley Heights, New Jersey, to hang a banner across Springfield Avenue from April 25, 2011 to May 14, 2011 to advertise their "Berkeley Heights Travel Soccer Tryouts May 14 for Fall 2011/Spring 2012 Season League Play." (CHAIRMAN SCANLON)
- 4. Authorizing the County Manager to retain Environmental Contractors, Inc., West Orange, New Jersey, to provide asbestos operation and maintenance procedures and mold remediation in the designated areas of the Old Annex boiler room, storage area, in an amount not to exceed \$18,750. (CHAIRMAN SCANLON)
- 5. Amending Resolution Number 982-2001, a professional engineering service contract with **Birdsall Services Group, Cranford, New Jersey,** for the purpose of providing environmental services at the Venneri Complex facility located in Westfield, New Jersey



in an additional amount of \$68,600 for a new contract amount of **\$264,985. (CHAIRMAN SCANLON)**

Freeholder Sullivan asked if the contract in item #5 is to take care of existing environmental issues at the Venneri Complex. Mr. Mineo replied, yes. He explained that the Venneri site had contaminated ground water and during the construction the monitoring wells were removed. He said that they have been replaced in different areas to continue monitoring the water.

Freeholder Sullivan suggested that the name of the Complex be changed. Freeholder Estrada stated that at a Policy Committee Meeting that was held last year, it was discussed, and the new name will be announced in September.

- 6. Authorizing the County Manager to enter into a professional engineering service contract with **CME Associates, Parlin, New Jersey,** for design, construction administration and inspection services for the replacement of Raymond Avenue Bridge over Green Brook (Pl-20), City of Plainfield, New Jersey in an amount not to exceed **\$264,075.** (UC Engineering Project No. 2011-004). **(CHAIRMAN SCANLON)**
- 7. Amending Resolution No. 2010-1090, a contract (through public bidding process) with Drill Construction, West Orange, New Jersey, approving Change Order No. 2 (final) in the amount of \$56,621 for a new contract amount of \$1,024,866 for additional work performed at the Houdaille Quarry Pistol Range. {\$44,924 of the \$56,621 will be reimbursed to Union County by the design consultant T&M Associates.} (CHAIRMAN SCANLON)

Freeholder Sullivan asked for the purpose of out-stationing the staff as mentioned in item #2. Director Guzzo stated that this is done annually and has been done for many years. The purpose is to do mobile applications for Medicare/Medicaid patients. Freeholder Sullivan asked why this agreement needs the Board's approval. Director Guzzo stated that since it is a contract with Robert Wood Johnson University Hospital and since the County will be allocating money, a Resolution approving a contract is required.

- 3. Authorizing the County Manager to enter into an Agreement of Understanding between the Union County Division of Social Services and **Trinitas Medical Center, Elizabeth, New Jersey,** for the out-stationing of County Welfare Agency staff (3 full-time employees) to process Medicaid applications for the period of January 1, 2011 through December 31, 2011. {State funding: 100%} (FREEHOLDER KOWALSKI)
- 4. Authorizing the County Manager to enter into an Agreement of Understanding between the Union County Division of Social Services and Overlook Hospital, Summit, New Jersey, for the out-stationing of County Welfare Agency staff (1 part-time employee) to process Medicaid applications for the period of January 1, 2011 through December 31, 2011. {State funding: 100%} (FREEHOLDER KOWALSKI)
- 5. Establishing the Union County Homeless Trust Fund Advisory Board, a voluntary committee to advise local government on the creation of a local homeless housing plan and participate in a local homeless housing program. The Board will be comprised of the following 15 positions: three from municipalities with the largest populations of homeless people in Union County (Elizabeth, Plainfield, and Linden); one representative from the Office of the County Clerk; three homeless or formally homeless persons; four local non-profit organizations with experience assisting the homeless or providing housing; two from the local planning committee to end homelessness; one representative from the Union County Division of Planning and Community Development; and one representative from the Board of Chosen Freeholders. (FREEHOLDER KOWALSKI)
- 6. Authorizing the County Manager to award subcontracts to various agencies for the period of March 1, 2011 through February 29, 2012 for the purpose of providing services to people with HIV/AIDS in the amount of **\$690,552**. This resolution would further authorize the County Manager to transfer funds among various agencies during the contract period should service needs change and/or if any of the various agencies fails to meet its contracted obligation. {Federal funding: **\$690,552}** (FREEHOLDER KOWALSKI)
- 7. Authorizing the County Manager to award subcontracts to various agencies for the period of March 1, 2011 through February 29, 2012 for the purpose of providing services to people with HIV/AIDS in the amount of \$166,930. This resolution would further authorize the County Manager to transfer funds among the various agencies during the contract period should service needs change and/or if any of the various agencies fails to meet its contracted obligation. DEPARTMENT OF PARKS AND COMMUNITY RENEWAL Alfred Faella, Director

1. Vice Chairman Mirabella asked if item #1 is to allow for the County's participation in the CDBG Grant and the HOME Programs. Director Faella, replied, yes, and explained that in order for the County to participate, we need to recertify and to advise HUD that we want to participate, and at which level. He said that they anticipate a 7% to 20% reduction from last year.

- 2. Authorizing the County Manager to enter into a professional architectural and engineering services contract with USA Architects, Somerville, New Jersey, to construct a new Echo Lake Park Maintenance Building in the amount of \$68,500. (FREEHOLDER SULLIVAN)
- 3. Authorizing the County Manager to enter into a professional architectural and engineering services contract with **USA Architects, Somerville, New Jersey,** to restore the exterior and interior of the Comfort Station Building and to redesign the Water Park at Warinanco Park, City of Elizabeth in the amount of **\$46,000. (FREEHOLDER SULLIVAN)**

Vice Chairman Mirabella stated that he is happy to see the project referenced in item #3 moving forward. Director Faella stated that the Department of Public Works are implementing the plans and will have them for the Board in the near future.
