PRESENTATION FROM THE BOARD

Resolution Presentations were made by Freeholder Linda Carter to those individuals involved in the successful 2013 Union County Human Services Holiday Gift Giving Drive.

Chairman Hudak asked Freeholder Carter, Freeholder Mirabella and Freeholder Estrada to present a Resolution to the individuals that were involved in the 2013 Union County Human Services Holiday Gift Giving Drive.

Freeholder Carter stated that it was truly a pleasure to thank those involved. She said they went above and beyond to make the drive so successful.

Freeholder Mirabella called upon Mr. & Mrs. Watterson who hosted a party which included music, gifts and a magician. He said they are the owner's of Nick's Pizzeria, which he believes is the best

pizza in Union County. He said the Watterson's are always very generous to the community and are great friends. He congratulated him for his efforts and for giving back to the community.

Mr. Watterson thanked the Board for the recognition.

Freeholder Carter acknowledged Lt. Dean Russamano of the Cranford Fire Department, and the Kenilworth Fire Department for providing gifts to needy families. She also thanked County Manager Faella for his gift giving contributions on behalf of his family's Foundation.

Freeholder Carter also presented a Resolution to Union County Comptroller Melinda Zito and her husband, Mike for adopting a needy family in Union. She commended them and congratulated them for partaking in such a needy cause, and for being so generous.

Freeholder Carter stated that there were more organizations who participated and were given their Certificates at an earlier date.

OFFICE OF THE UNION COUNTY CLERK

Joanne Rajoppi, County Clerk

- 1. Authorizing the County Manager to enter into an agreement with Dominion Voting Systems, Denver, Colorado, for the purposes of providing licensing, maintenance and support for the WinEDS 4.0 voting system for the contract period April 1, 2014 through March 31, 2015 in the amount of \$27,703. (Chairman Christopher Hudak)
- 2. Authorizing the County Clerk to make any and all purchases of goods and/or services required in the process of preparing and conducting an election to be provided by various vendors and to provide miscellaneous election services which might arise, in an amount not to exceed \$30,000 for the 2014 elections. (Chairman Christopher Hudak)
 - . Freeholder Estrada asked if the Board has approved similar Resolutions in the past relative to item #2.

Ms. Rajoppi stated that it is for miscellaneous services involved in the Elections. She said for example, if an election is being challenged, then a transcriber is involved, a translation firm to translate the ballots into Spanish and for Federal Express costs for ballots to be sent to civilians overseas.

Freeholder Estrada asked how much was spent last clear. Ms. Rajoppi stated it was close to \$30,000, but it depends upon the type of election. She said the cost of a Federal Express packet to be sent overseas is \$30 to \$40 and this is the only way to guarantee the receipt of the package. It also allows for the ballot to be returned within 2 to 3 days.

Chairman Hudak asked if a similar Resolution for "miscellaneous" has been passed by the Board in the past.

Ms. Rajoppi stated that she was uncertain. The Resolution typically states "other expenses," as it is an umbrella Resolution to cover these kind of items. It is a "not to exceed" amount for \$30,000.

Chairman Hudak asked if the Resolution is specific, would there be a limit in terms of what can be spent.

Ms. Rajoppi stated that they are delineated, it can be used for such items, provided it is within the structure of the Resolution.

- 3. Approving a pre-qualified list of vendors for the provision of Election Mail Fulfillment Services for the period February 1, 2013 through January 31, 2016. (Chairman Christopher Hudak)
- 4. Approving a list of pre-qualified vendors to provide Election Printing Services for the period February 1, 2014 through January 31, 2016. (Chairman Christopher Hudak)
- 5. Authorizing the County Manager to enter into an agreement with Full Service Mailers, Hackensack, New Jersey for the purposes of providing mail fulfillment services for sample ballots for Primary, General and Special Elections for 2014 and 2015 for a contract amount not to exceed \$134,336.60. (Chairman Christopher Hudak)
- 6. Authorizing the County Manager to enter into an agreement with B&B Press, Lebanon, New Jersey for the purposes of providing print services for Mail in Ballots and Provisional Ballots for the 2014 and 2015 Primary and General Elections in the amount of \$486,406.76. (Chairman Christopher Hudak)
- 7. Authorizing the County Manager to enter into an agreement with Royal Printing Services, West New York, New Jersey for the purpose of providing sample ballots, official ballots, emergency ballots and emergency ballot tally sheets for the 2014 & 2015 Election cycles in an amount not to exceed \$1,025,337. (Chairman Christopher Hudak)
- 8. Authorizing the County Manager to enter into an agreement with Wisolmerski Associates, Inc., Pembrook Pines, Florida for the purpose of providing technical support to the recording, indexing and accounting systems of the Office of the County Clerk for the contract period January 1, 2014 through December 31, 2014 in an amount not to exceed \$41,350.00. (Chairman Christopher Hudak)

Freeholder Mirabella asked if there is an anticipated savings in item #8.

Ms. Rajoppi responded yes. She explained that it is much more efficient this way, and in 2016, it will be State mandated to have the files electronically filed.

Freeholder Mirabella asked for the percentage of the files that are currently electronically filed.

Ms.Rajoppi stated that her office just began filing electronically. It is currently about 5% of the files. She said templates and fields need to be worked on and should be done by the end of this year.

OFFICE OF THE UNION COUNTY PROSECUTOR

Grace H. Park, Acting Prosecutor

1. Authorizing the County Manager to apply for and accept funding from the Division of Criminal Justice, State Office of Victim Witness Advocacy for the project entitled Victims of Crime Act (VOCA) Grant Program for the period of December 1, 2013 through November 30, 2014 in the amount of \$225,465. There is a required county match of \$56,366. (Chairman Christopher Hudak)

Freeholder Granados asked for an explanation of the Victims Crime Act in item #1.

First Assistant Prosecutor Mr. Isenhour said the Victims of Crime Act was created to allow victims to have advocates on their behalf. The advocates will arrange to have counselors for victims and their families, to explain the judicial system to them and to accompany them to court.

2. Authorizing the County Manager, through the Union County Prosecutor's Office, to enter into a Professional Services Contract with various experts for litigation support and transcription services for the period of January 1, 2014 through December 31, 2014 in the amount of \$100,000.00 (Chairman Christopher Hudak)

Vice Chairman Jalloh asked how much was spent last year, referring to item #2.

First Assistant Prosecutor Tim Isenhour stated that there was \$180,000 difference in leftover costs for DNA experts out of state. The County does not incur the extraordinary expenses.

3. Authorizing the County Manager, through the Union County Prosecutor's Office, to purchase surveillance equipment from Crimepoint of Camarillo, CA. for the amount of \$21,000. (Chairman Christopher Hudak)

OFFICE OF THE UNION COUNTY SHERIFF

Ralph Froehlich, County Sheriff

Undersheriff Joseph Cryan represented the Office.

- Authorizing the County Manager to enter into an agreement with Kanen Psychological Associates, PA, Ridgewood, New Jersey, to provide psychological examinations to Sheriff's Officer candidates for the contract period of January 1, 2014 through December 31, 2014 in the amount of \$10,000.00. (Chairman Christopher Hudak)
- 2. Authorizing the County Manager to enter into an agreement with Iselin Veterinary Hospital, Iselin, New Jersey, to provide veterinary services and food to the Sheriff's K-9 Unit for the contract period January 1, 2014 through December 31, 2014 in the amount of \$25,000.00. (Chairman Christopher Hudak)

Freeholder Mirabella asked how these amounts compare to last year, referring to item #2.

UnderSheriff Cryan said that they are right in line; stating the two amounts, \$8,000 and \$23,093

DEPARTMENT OF ADMINISTRATIVE SERVICES

Norman W. Albert, Esq., Director

1. Authorizing the County Manager to award a contract to Fishman McIntrye, East Hanover, New Jersey, to provide Worker's Compensation Counsel Services for the period of January 1, 2014 through December 31, 2014 with any sums to be paid through the Third Party Administrator. (Chairman Christopher Hudak)

Freeholder Estrada asked if item#1 is an addition to another attorney firm.

Director Albert responded yes. He said last year \$121,000 was spent on defense counsel for workman's compensation cases. These are County dollars that are paid to the attorney via the Third Party Administrator. The attorney is paid on a per case basis.

2. Amending Resolution Number 2013-1067, a contract with Practice Associates Medical Group, Clark, New Jersey, (Atlantic Health Systems) for the provision of pre-employment physicals and other related medical exams, to include the Office of the Sheriff in an amount not to exceed \$10,000 for a new total contract amount not to exceed \$55,000.00. (Chairman Christopher Hudak)

Freeholder Carter asked about the contract period in item #2.

Director Albert stated it is for this calendar year; January to December 2014.

Freeholder Carter asked why it is being done now.

Director Albert explained that it is for the Sheriff's Department for pre-employment physicals and other medical exams; which were not part of the original Resolution.

Freeholder Granados asked if all the departments are now included in the contract with this vendor. Director Albert responded yes.

3. Authorizing the County Manager to purchase two (2) Ford Expedition Police Vehicles from Beyer Ford, Morristown, New Jersey, through the Cranford Co-op# 47-CPCPS for a total amount of \$63,828.00. (Chairman Christopher Hudak)

Freeholder Mirabella asked if the funding for item #3 is from the 2013 Capital Budget.

. Director Albert responded yes.

County Manager Faella confirmed that the funding is coming from last year's budget.

DEPARTMENT OF CORRECTIONS

Brian Riordan, Director

 Authorizing the County Manager to enter into an agreement between the County of Union and Monmouth County Police Academy, Freehold, New Jersey, to provide basic training courses for Union County Correctional Officer Recruits for the contract period of March 1, 2014 through December 31, 2014 in an amount not to exceed \$25,000.00. (Chairman Christopher Hudak)

Director Riordan highlighted item #1. He said last year there was a similar Resolution, where he committed to do an assessment of having our correction officers trained at the Stamler Academy. He said he met with Prosecutor Grace Park and they assessed the situation. They discovered that a 12 week training session would take 480 hours. Hence 480 x 12 weeks. The use of our staff would be much greater in cost than using an outside source due to overtime costs.

Chairman Hudak thanked him for the assessment, and agreed to use an outside source to save money.

There were no questions.

DEPARTMENT OF ECONOMIC DEVELOPMENT

William Reyes, Deputy County Manager/Director

1. Authorizing the County Manager to award a Professional Engineering Service Contract to T&M Associates, of Middletown, New Jersey, for the purpose of providing Construction Administration and Inspection Services for the Intersection Improvements to Vauxhall Road (CR630) and Pine Avenue/Barbara Avenue; Vauxhall Road (CR630) and Caldwell Avenue/Glenn Avenue, Township of Union, New Jersey in an amount not to exceed \$59,506.00. Freeholder Kowalski asked what the basis for the reduction is in item #2.

Director Reyes stated that the contingency was not as much as anticipated for the Nomahegan Park Dam. There is an \$8,059 credit.

Freeholder Kowalski asked if the damage was storm related.

. County Engineer Mineo responded. He said it is not storm related.

3. Authorizing the County Manager to award the proposed contract obtained through advertised public bidding in accordance with the Local Public Contracts Law, NJSA 40A:11-1 et seq: Department of Economic Development, Division of Engineering: Ritacco Construction, of Belleville, New Jersey, for the purpose of providing 2013 Dam Repair Project, one hundred twenty (120) calendar days from the date of the notice to proceed, in the amount of \$494,997.00. Freeholder Bergen asked if the repairs to the dams are a result of the inspections of a Resolution that was approved last year.

Mr. Mineo responded yes. The contract is to repair 9 of the 12 dams.

Director Albert stated that these two improvements include traffic lights, curbing, traffic box signals and various improvements for crossing.

Frank Guzzo, Director

Freeholder Mirabella asked for an update of the Code Blue Program.

Director Guzzo stated that Union County is the only County in the State that has a Code Blue Program in place. He said he is hopeful that it could be part of the budget permanently. He said during the extreme cold, a Code Blue alert was called 60 times since November, compared to last year, there were 38. They were able to shelter over 1,500 homeless from the cold. He said the Point-in-Time count is done one night every year in Plainfield, Elizabeth, Rahway and the Summit Train Station to count the homeless. The count is taken during the day and at night, adding that more the more homeless that are serviced, the more dollars are allocated by the State.

Freeholder Kowaski thanked Director Guzzo, the volunteers and his staff. She commended Freeholder Granados and County Manager Faella for participating.

Director Guzzo said the homeless are brought to a school and they are given peanut butter and jelly sandwiches. There is a "Cinderella's Closet" for coats and such and volunteers cook dinners for those who come in from the cold.

Chairman Hudak said that he appreciates Overlook, JFK and Trinitas Regional Medical Center and the work of Director Guzzo and staff.
