BE IT ORDAINED by the Board of Chosen Freeholders of the County of Union that the "Laws of Union County" are hereby amended as follows:

CHAPTER 2, -\(107-ARTICLE IV - FEES FOR RECREATION FACILITIES

The Director of the Department of Parks and Community Renewal is hereby authorized to set fees and one time charges not specifically included in the fee schedule. The Director of the Department of Parks and Community Renewal is hereby further authorized to amend or modify any fee set forth in the fee schedule for special promotions and events. In the event that the Director shall asses, amend or modify any fee he shall file a notice of said assessment, amendment or modification with the Clerk of the Board and the Director of the Department of Finance, no less than five days prior to the effective date of the assessment, amendment or modification.

This concludes the Public Hearing on Ordinance 744-2013.

Bruce Paterson, Garwood, asked for the fees and the revisions.

Director Zuber stated that there are nominal increases at the Warinanco Ice Skating Center,

Trailside, Watchung Stables, Maskers Barn and Park Reservation.

He said there have been no fee increases at the County pools. He said Watchung Stables will now be comparable to other stables in the area.

John Bury, Kenilworth, stated that a 20 to 25% increase at Watchung Stables is not considered to be a nominal increase. He asked if golf fees are separate and if they could expect more increases at a later date.

Freeholder Mohamed S. Jalloh, Policy Chairman, moved Ordinance Number 744-2013 for Final Reading and authorized the Clerk of the Board to advertise same in accordance with the law.

745-2013 REFUNDING BOND ORDINANCE PROVIDING FOR THE REFUNDING OF \$40,960,000 AGGREGATE PRINCIPAL AMOUNT OF OUTSTANDING BONDS OF THE COUNTY OF UNION, STATE OF NEW JERSEY, APPROPRIATING A SUM NOT EXCEEDING \$41,000,000 TO PAY THE COST THEREOF AND AUTHORIZING THE ISSUANCE OF NOT EXCEEDING \$41,000,000 AGGREGATE PRINCIPAL AMOUNT OF REFUNDING BONDS OF SAID COUNTY TO FINANCE SUCH APPROPRIATION.

BE IT ORDAINED by the Board of Chosen Freeholders of the County of Union, State of New Jersey, as follows:

Section 1. The County of Union (the "County"), State of New Jersey is hereby authorized to refund \$40,960,000 aggregate principal amount of outstanding bonds (subject to redemption prior to their stated maturities) dated March 1, 2004 and maturing on or after March 1, 2015 (the "Outstanding Bonds").

The Outstanding Bonds consist of the following two issues of bonds, bearing interest at the rates per annum, payable on March 1 and September 1 of each year until maturity or prior redemption, and maturing in annual installments on March 1 in each year, as follows:

The Outstanding Bonds are subject to optional redemption on or after March 1, 2014 at a redemption price of 100%.

The Board of Chosen Freeholders may determine by subsequent resolution not to refund a portion of the Outstanding Bonds.

Section 2. The Board of Chosen Freeholders of the County has ascertained and hereby determines that the Outstanding Bonds set forth in Section 1 of this ordinance have not been paid or discharged and that the County is authorized by Section 51(a) of the Local Bond Law of New Jersey (Chapter 2 of Title 40A of the New Jersey Statutes Annotated, as amended; the "Local Bond Law") to issue its refunding bonds as hereinafter provided to refund

the Outstanding Bonds. The object of the refunding is to effect debt service savings for the County.

Section 3. A sum not exceeding \$41,000,000 is hereby appropriated (a) to refund the Outstanding Bonds set forth in Section 1 of this ordinance in the aggregate principal amount of \$40,960,000 and (b) to pay an amount not exceeding \$350,000 for the cost of the issuance of the refunding bonds, including underwriter's compensation, printing, advertising, financial and legal expenses therefor, as permitted by Section 51(b) of the Local Bond Law (collectively, the "Purpose").

Section 4. To finance the Purpose, refunding bonds of said County in an aggregate principal amount not exceeding \$41,000,000 are hereby authorized to be issued pursuant to the Local Bond Law (the "Refunding Bonds"). The Refunding Bonds shall be sold at private sale by resolution of the Board of Chosen Freeholders and shall be in registered form and shall contain the "refunding" in their title and shall recite that they are issued pursuant to the Local Bond Law and shall bear such date or dates, mature at such time or times not exceeding 40 years from their date, bear interest at such rate or rates per annum, be payable at such time or times, be in such denominations, carry such registration privileges, be executed in such manner consistent with the provisions of the Local Bond Law for bonds of a county, be payable at such place or places, and be subject to such terms of redemption, with or without premium, as may be hereafter

determined by resolution of the Board of Chosen Freeholders within the limitations prescribed by law.

The Refunding Bonds shall be direct, unlimited Section 5. and general obligations of the County and the County shall be obligated to levy ad valorem taxes upon all taxable real property within the County for the payment of the principal of and the interest on the Refunding Bonds without limitation as to rate or The full faith and credit of the County are hereby amount. pledged to the punctual payment of the principal of and the interest on the Refunding Bonds. Each Refunding Bond issued pursuant to this ordinance shall recite that all conditions, acts and things required by the Constitution or statutes of the State of New Jersey to exist, to have happened and to have been performed precedent to and in the issuance of the Refunding Bond exist, have happened and have been performed, and that the Refunding Bond, together with all other indebtedness of County, is within every debt and other limit prescribed by the Constitution or statutes of said State.

Section 6. The Director of Finance is hereby authorized to execute a certificate addressed to the underwriters of the Refunding Bonds stating that the preliminary official statement to be prepared by the County with respect to the Refunding Bonds is "deemed final" as of its date within the meaning of Rule 15c2-12 of the Securities and Exchange Commission. The distribution

of such preliminary official statement to potential purchasers of the Refunding Bonds is hereby approved.

Section 7. All matters with respect to the Refunding Bonds not determined by this ordinance shall be determined by subsequent resolution or resolutions to be hereafter adopted by the Board of Chosen Freeholders of the County, or the performance or determination thereof delegated by resolution or resolutions, to the Director of Finance.

Section 8. It is hereby determined and stated that the Supplemental Debt Statement required by the Local Bond Law has been duly made and filed in the office of the Clerk of the Board of Chosen Freeholders of said County, and that such statement so filed shows that the gross debt of said County, as defined in Section 43 of the Local Bond Law, is increased by this ordinance by \$41,000,000, but \$40,960,000 (the principal amount of the Outstanding Bonds being paid from the proceeds of the Refunding Bonds) shall be deducted from gross debt pursuant to Section 52 of the Local Bond Law, and that the issuance of the bonds authorized by this ordinance will be within all debt limitations prescribed by said Local Bond Law.

Section 9. It is hereby determined and stated that no sum need be appropriated hereby as a down payment.

Section 10. The County is hereby authorized to enter into any agreements that may be necessary to effect the purchase of

securities, as permitted by Sections 53(c) and 60 of the Local Bond Law, to accomplish the refunding.

Section 11. This refunding bond ordinance shall take effect twenty days after the first publication thereof after final passage as provided by the Local Bond Law.

Final Reading Statement

This meeting is open to the public for the purposes of commenting on Ordinance 745-2013 only.

Robert Rubino, Council Member of the City of Summit, spoke about the County's debt and asked the Board to proceed with extreme caution in fear of the rating agencies downgrading the County's rating.

Bruce Paterson, Garwood, asked if there is any linkage of Ordinance 745-2013 to some Resolutions on the evening's Agenda that pertain to the Juvenile Detention Center and the Linden Projects. He asked if there are any professional fees involved, if so, he asked who the professionals are, and he stated that it seems that there would be a savings resulting in refinancing the bonds. He asked what the savings would be.

Director Taylor stated that this is not new money. They are solely taking advantage of the lower interest rates, which will result in a net savings of 9% which would equal \$400,000 in 2014 and/or 2015.

Director Taylor stated that any professional fees are net of those savings. This is consistent with the new rules of the Local Finance Board. The threshold of 3% far exceeds the Local Finance Board's standards.

Jim Buettner, Cranford, asked about the professional fees and who is involved.

Director Taylor stated that the professional fees are part of the refunding and the savings are net of those savings. She said typically the professional fees are for the Bond Counsel, auditors and advertisement fees. She stated that there are no financial advisors as it coincides with the new rules of the Local Finance Board. She stated that the total cost does not exceed any of the Local Finance Board's standards.

This concludes the Public Hearing on Ordinance 745-2013.

Freeholder Daniel P. Sullivan, Fiscal Chairman, moved Ordinance Number 745-2013 for Final Reading and authorized the Clerk of the Board to advertise the same in accordance with the law.

746-2013 AN ORDINANCE TO AMEND TO THE UNION COUNTY DISTRICT SOLID WASTE MANAGEMENT PLAN TO INCLUDE A CLASS B RECYCLING FACILITY OWNED AND OPERATED BY THE CITY OF LINDEN AT THE SITE OF THE LINDEN SANITARY LANDFILL

WHEREAS, pursuant to the Solid Waste Management Act, <u>N.J.S.A</u> 13:1E-1 <u>et seq.</u>, the County of Union is designated as a Solid Waste Management District and by law did develop and prepare a District Solid Waste Management Plan ("County Plan") that was adopted by the Union County Board of Chosen Freeholders on June 7, 1979, pursuant to and in accordance with the Solid Waste Management Act, <u>N.J.S.A.</u> 13:1E-1 <u>et seq.</u>; and

WHEREAS, the County Plan was approved, with modifications, by the Department of Environmental Protection ("NJDEP") on August 13, 1980, and has since been amended and modified from time to time; and

WHEREAS, on December 11, 1986, the Union County Board of Chosen Freeholders designated the Union County Utilities Authority ("UCUA") as the agency responsible for the implementation of the County Plan, as amended from time to time, and the UCUA is empowered to plan, acquire, construct, maintain and operate facilities for the processing, disposal and/or recycling of solid waste generated in the County; and

WHEREAS, the UCUA has formulated a Plan Amendment, and recommends that this Board set a public hearing for the purpose of taking public testimony on the proposed plan amendment, and review and enact said amendment that is now on file with the Clerk of this Board and available for public inspection and is made a part hereof by reference; and

WHEREAS, the subject amendment is summarized as follows:

This Plan Amendment is prepared as a result of a determination by the UCUA:

1) TO INCLUDE CITY OF LINDEN RECYCLING FACILITY, LOCATED AT THE LINDEN SANITARY LANDFILL, BLOCK 581, LOTS 11.03 AND 17, 1451 LOWER ROAD, IN THE CITY OF LINDEN, INTO THE UNION COUNTY SOLID WASTE MANAGEMENT PLAN AS A CLASS B RECYCLING CENTER TO ACCEPT UP TO 50 TONS PER DAY OF TREE TRUNKS, STUMPS, BRANCHES, LEAVES AND BRUSH AT ITS LOCATION FOR SHIPPING OFF-SITE TO THE UNION COUNTY RESOURCE RECOVERY FACILITY IN RAHWAY, NEW JERSEY FOR DISPOSAL.

WHEREAS, pursuant to the Solid Waste Management Act, the County's Solid Waste Advisory Committee ("SWAC") must be consulted with respect to amendment to the County Plan; and

WHEREAS, by Resolution No. 61-2012, duly adopted July 18, 2012, the UCUA approved the Plan Amendment and recommended that the Plan Amendment be approved by the Board of Chosen Freeholders of the County, after public hearing in accordance with the Solid Waste Management Act; and

WHEREAS, pursuant to and in accordance with the provisions of the Solid Waste Management Act, the Plan Amendment was presented to SWAC:

NOW, THEREFORE, BE IT ORDAINED, by the Board of Chosen Freeholders of the County of Union, that:

- 1. The aforesaid recitals are incorporated herein as though fully set forth at length.
- 2. The Plan Amendment, as prepared and recommended by the Union County Utilities Authority, is hereby adopted as an Amendment to the Union County District Solid Waste Management Plan.
- 3. Any provision of the County Plan that is inconsistent with the Plan Amendment is hereby repealed to the extent of said inconsistency and the provisions of the Plan Amendment shall be fully effective and shall control.
 - 4. A certified copy of this Ordinance, as finally adopted, together with the Plan Amendment, shall be forwarded to the New Jersey Department of Environmental Protection, the County Clerk of the County of Union, and the Union County Utilities Authority.
 - 5. The Clerk of this Board shall publish and disseminate notice of this Ordinance as provided by law.
 - 6. The aforesaid Plan Amendment and a copy of the transcript of the public hearing to be held at such time as may be scheduled by said Board of Chosen Freeholders, and the necessary deliberations shall be submitted to the Commissioner of the New Jersey Department of Environmental Protection.

Freeholder Mohamed S. Jalloh, Policy Chairman, moved Ordinance Number 747-2013 for First Reading and authorized the Clerk of the Board to advertise same in accordance with the law. The Final Reading and Public Hearing are scheduled for March 14, 2013.

PUBLIC COMMENT PORTION

The meeting is open to the public for the purpose of commenting on Resolutions being offered for adoption only.

George Karakitis, Elizabeth, made comments relative to Resolution 2013-143 and 144. He stated that Elizabeth General Medical Center should be considered for a drug rehabilitation facility. He is opposed to privatizing the jail.

Bruce Paterson, Garwood, asked who the principals are relative to Resolution 2013-112. He asked for the square footage of the building and if the facility is leased or owned.

Mr. Paterson spoke about Resolutions 2013-130 and 2013-131, refunding bonds. He is opposed to Resolution 2013-133. In reference to Resolution 2013-138, he said he is pleased about the savings, but asked how long Partner's Pharmacy has been in business and asked for the contract amount that was negotiated two years ago. He also asked about the Change Order mentioned in Resolution 2013-146, being reduced by \$423,000. He asked who checks the quantity. In reference to Resolution 2013-150, he stated that Jury parking should be made available at the J. Christian Bollwage Parking Garage.

Robert Rubino, Council Member, City of Summit, stated that he is opposed to Resolutions 2013-123 and 130. He made comments relative to Resolution 2013-166, stating that the City of Summit is unfunded and full day Kindergarten will create a further burden to the tax payers of the City.

Director Taylor asked Mr. Hudak, Esq. Special Bond Council representing the Union County Improvement Authority to explain Resolutions 2013-130 and 2013-131.

Mr. Hudak, Esq. Stated that Resolution 2013-130, is for the Board's consent for bond issuance for various projects in the City Linden. There is no cost to the County, and it is solely the responsibility of the City of Linden. Relative to Resolution 2013-131, is refunding of outstanding bonds to take advantage of the low interest rates. He stated that 3% is well above the Local Finance Board's requirements and it has been approved by the Local Finance Board.

Director Guzzo stated that Morning Star Community Development Urban Renewal Corporation is a non-profit organization (Resolution 2013-112). He stated that the Division of Youth Services leased this space for 20 years. The contract is for an extension at the same cost. He stated the building consists of approximately 4,500 square foot. Their goal is to vacate the building.

Ms.Wheeler stated that they have used Partners Pharmacy mentioned in Resolution 2013-138 for 8 to 9 years. They have been in business for 15 years and it is a contract awarded through the RFP

process.

Engineer Mineo explained that the Federal Highway Administration reviews and approves dollars that are left over from original contracts.

John Bury, Kenilworth, echoed Council Member Rubino's comments regarding Resolution 2012-123. He asked if Resolution 2013-109 will be funded through the Ryan White dollars. He asked if the amount mentioned of \$522,000 is the total amount of the grant, or if the amount was higher.

Director Guzzo stated that the dollars go to HomeFirst in Plainfield and P.R.O.C.E.E.D. in Elizabeth. He explained that it is for rental and housing assistance for HIV infected individuals. Contracts are with health agencies. There is a large network in Newark due to the high rate of HIV individuals, and services and dollars go where needed. He stated for ten years the County has never taken any administration fees.

Mary Polizano, Westfield, employee of Runnells Hospital made remarks about Resolution 2013-138. She said a large amount of medication is discarded because they are not allowed to keep any medication that is not used.

Mary Ellen Taylor, Berkeley Heights, stated that the she is concerned about the medication that is wasted at Runnells.

Ms. Wheeler explained that in reference to Resolution 2013-138, she stated that since Medicare D was approved by the Federal Government, we cannot receive less than a 30 day dose or give the medication away to donate it to those who cannot afford to purchase medicine. She said there dispensing regulations and she has an administrative responsibility. She urged the public to send letters to the Federal Government and Medicare D.

Lourdes Borhak, Berkeley Heights, Nurse at Runnells stated that pertaining to Resolution 2013-138, a pharmacy should be located within Runnells, this way they could disburse only the medication that is needed.

Chairman Carter made it clear that the nurses are not to blame for disposing of the medication, as it is regulated by the Federal Government.

Jim Buettner, Cranford, also asked why there is not a pharmacy located within Runnells, referring to Resolution 2013-138. He urged the Board to vote no for Resolution 2013-150. He said the J. Bollwage Garage should be used for juror parking.

Engineer Mineo explained that Resolution 2013-151 is a contract for snow plowing, and will be used as a back-up to County employees. It will include the cost of the trucks and manpower.

Freeholder Sullivan stated that the J. Christian Bollwage Parking Garage is a partnership between Union County College, the County of Union and the Parking Authority of the City of Elizabeth, The garage is used for all three entities. The remaining spaces are available to the general public.

Freeholder Sullivan explained further that the County pays for the Jefferson Avenue Parking Garage for the jurors as required by the State. He said the City of Elizabeth Parking Authority has owned the building for more than 20 years and the County leases the spaces.

Ms. Wheeler stated that in reference to Resolution 2013-138, it was determined in 1991 that it was not cost effective to have a pharmacy located within Runnells Hospital. She said there is no nursing home within the State of New Jersey that has a long-term pharmacy.

Ms Wheeler stated that the nurses at Runnells are highly respected.

PUBLIC COMMENT PORTION

This meeting is open to the public for the purpose of commenting on any matter.

Matthew Taylor, Berkeley Heights, stated that he has been seeking transportation from his house in Berkeley Heights (which borders the Township of Warren) to the Warren Public Library. He stated that Director Guzzo has been assisting him with this issue.

Director Guzzo stated that the County has no control over the Township of Berkeley Height's transportation. He said the County's role is to ask the Township of Berkeley Heights if they would accommodate Mr. Taylor. He said Berkeley Heights has not been able to make accommodations. Director Guzzo stated he and his office will continue to work on this issue. He added that effective February 25th, Union County will provide Mr. Taylor with transportation on Mondays, Tuesdays and Fridays to Basking Ridge where he attends an Adult Center.

Jeff Robinson, Rahway, employee of the Division of Social Services, Union County, representative of CW Local 1080, made comments regarding the past layoffs, suggestions to the Board on how to save money. He made comments regarding the County and State's Health Insurance Plans. He stated that the State has a cheaper plan.

Mary Ellen Taylor, Berkeley Heights, asked that her address be redacted from the Freeholder Meeting. She read an article regarding extortion and legal guardianship.

George Karakatits, Elizabeth, said he sympathizes with the Taylor's. He spoke about he study of the Union County Jail to house illegal immigrants and to collect dollars from the State. He said they should be housed separately.

Director Riordan stated that they entered an agreement with Luminosity for a study to reduce the jail population. He said they need to put together a Criminal Justice Committee for a strategy to reduce the jail population. He said it takes a long time for the justice system to process the inmates.

Director Riordan stated that in order to refurbish the shower areas they need to close the housing area. He spoke about using the Old Juvenile Detention Center that has 130 beds and explained the process of temporarily housing the inmates during the renovation.

Councilman Rubino, Summit, thanked the Board for installing traffic signals at Springfield Avenue and Summit Avenue. He spoke about the City's high taxes, while being 4% of the County's population. He said privatizing Runnells will not be enough and he urged merging the County Police and the Sheriff's Department.

Barbara Egger, President of Local 1152, HPAE at Runnells Specialized Hospital. She read an article about the healthcare and high administration pay. She said privatizing the Hospital is not the answer. She said there has already been a decline in working conditions. She made suggestions to have other centers in place, such as an Adult Day Care Center, Acute Care and Mental Psychiatric

Center. She urged the Board to research other Counties to see what they have in place.

Ms. Egger's comments are attached.

Guy Leitsky, Scotch Plains, echoed Ms. Egger's comments. He stated that solutions are needed for individuals to keep their jobs. He said the negative trend has to stop.

Mary Polizano, Westfield, asked the Board to consider Ms. Egger's suggestions. She said the patients receive great care at Runnells.

Joanne Colucci, stated that she provided the Board with a packet for alternate plans to save jobs and to renegotiate the contract with the health insurance company.

Pat Mochetti, New Providence, supports Councilman Rubino's comments. He said County taxes are higher than New Providence's taxes. He asked about the status of the County equipment that is allegedly missing and questioned the use of County generators.

Mr. Mochetti made comments regarding the hiring of former Freeholder Scanlon. He had questions regarding the amount of people who applied for the job, and if it was advertised.

County Manager Faella stated that they have been in contact with Prosecutor Romankow. He said the investigation concerning the generators is not yet complete.

Director DiRado stated that the position Deborah Scanlon filled was not posted because it is an unclassified position. She was selected by the Directors and has 30 years experience in a law office.

Bruce Paterson, Garwood, spoke about the loss of revenue at Runnells Hospital. He spoke about Counsel John Hudak's involvement with Runnells.

County Counsel Barry stated that John Hudak, Esquire is not involved in transactions with Runnells Hospital.

Mr. Paterson made comments relative to Mrs. Scanlon's new position, salary and pension. He also stated that Freeholder Sullivan should not vote on salary increases for employees. He believes it is a conflict of interest, being Chairman of the Fiscal Committee.

Chairman Carter stated that Freeholder Sullivan does not control the budget.

John Bury, Kenilworth, made comments relative to regarding studies for health insurance, solar panels and golf operations. He asked if the golf fees will be increased.

County Manager Faella stated that the golf fees will not be increased.

Tony Tavares of Brown and Brown Insurance explained how the cost for the health insurance was determined.

Jim Buettener, Cranford, asked for the names and fees of those who will benefit from rebonding as mentioned in Resolutions 2013-130 and 2013-131.

value savings of approximately 9% which equals \$3.2 million over the life of the bonds. The professionals include the County's Bond Counsel (Rogut & McCarthy), Moody Rating Agency (Standard & Poor), escrow agents and verification costs.

Director Taylor stated that the costs are not to exceed \$115,000 to achieve a savings of \$3.2 million over the life of the bond. She added that these Ordinances have no correlation with Resolutions 2013-130 and 2013-131. The requesting agent for documents for Resolutions 2013-130 and 2013-131 is the Union County Improvement Authority, not the County.

FREEHOLDER REPORTS AND COMMENTS

Freeholder Sullivan stated that the salary increases are for the Constitutional Officers. Non-contractual employees already received their increases.

Freeholder Sullivan said the main reason for the deficit at Runnells is the result of reductions in Medicare reimbursements by the State. It is not due to employee performance, which has been outstanding. He thanked Mr. Tavares, Broker of Brown and Brown Insurance Company for attending the meeting to explain the County's health insurance plan with Horizon. They got us the best price with Horizon, and they were the cheapest provider, he stated.

Freeholder Kowalski congratulated Freeholder Carter and Freeholder Jalloh on the Black History event. She thanked County Clerk Rajoppi on the Civil War History.

Freeholder Kowalski stated that in the past, destructive storms like Hurricane Irene and Superstorm Sandy were considered to be once in a generation events. Now they are occurring on an annual basis, and with that in mind she wanted to bring the public to date on an important flood control project, which pairs Union County with Essex County.

Freeholder Kowalski stated that our municipalities have been working with the U.S. Army Corps of Engineers and the New Jersey Department of Environmental Protection to mitigate the risk of devastating floods. They have identified the South Mountain Regional Detention Basin as a promising strategy, with significant benefits for both Union and Essex counties. However, before construction can begin this strategy must be thoroughly assessed along with other possible courses of action.

Freeholder Kowalski stated that the Freeholder Board joins with the Mayors' Council on Rahway River Watershed Flood Control in urging that these federal and state agencies receive sufficient funding to move on to the next phase of the project as quickly as possible.

Freeholder Kowalski urged the public to contact the mayors of their town.

Freeholder Kowalski also mentioned that the Board is aware of great care the patients receive at Runnells.

Freeholder Mirabella appreciates the questions by the Council member of Summit regarding refinancing the bonds. He was also pleased that Ms. Wheeler explained the disposal of the medication and the care that is given to the patients of Runnells.

Freeholder Mirabella made comments regarding the Dr. Seuss event and said he is pleased to announce that the Union County Means Business program will continue in March.

County Manager Faella stated that he appreciates the work of the staff at Runnells Hospital. He added that they are working on job creations with Wakefern, Union County Means Business program and the UCEDC.

Freeholder Hudak said that some of our local businesses are still struggling after Superstorm Sandy. He was pleased to announce that the nonprofit Union County Economic Development Corporation is expanding its low-interest Storm Recovery Loan program. This is a two percent, five year loan with no collateral, application or processing fees involved. The program is funded by a generous donation from Investors Bank, and it has just been expanded from a limit of \$15,000, to \$25,000. It can help get you back on your feet and bring your employees back to work again. Freeholder Hudak stated that there has been no mismanagement at Runnells. He said the Executive Budget will be released and they are staying within a 2% cap. They will continue to look at all departments and services.

Freeholder Hudak stated that his father is the Bond Counsel for the Union County Improvement Authority and his father has held this position since, he, Freeholder Hudak, was 15 or 16 years of age. As a result of his father's position, he said he abstains from having any participation with the Union County Improvement Authority.

Chairman Carter asked the public to be courteous during the open forum.

Chairman Carter thanked Freeholder Jalloh for attending the Black History Month event.

Chairman Carter congratulated the Union County Improvement Authority on two recent awards they have received. Last fall, work was completed on the Solar Initiative, for which UCIA made arrangements that enabled 15 local jurisdictions to get clean solar energy while saving money on electricity, with no up-front costs.

Chairman Carter stated that in recognition of its innovative approach to coordinating the Solar Initiative, UCIA received the Photovoltaic Project of Distinction Award from two major solar industry trade organizations. Also, last fall saw the opening of the new Child Advocacy Center, for which the Improvement Authority also arranged financing. This building brings together all of the services and resources we have to assist victims of child abuse and help them to get a second chance in life.

Chairman Carter said for this outstanding community project, the Improvement Authority received the prestigious Audrey Nelson award for best practices in community development, from the National Community Development Association. Though these two projects are very different in nature, together they show that the tradition of working together for the common good is very much alive and well in Union County.

Statement on the re-organization or privatization of Runnells Specialized Hospital Barbara Egger RN, President HPAE Local 5112 February 21, 2013

Thank you for the opportunity to address the Freeholder Board this evening regarding Runnells Specialized Hospital and the presentation made by CHR at the February 7th meeting. My name is Barbara Egger, President of the Health Professionals and Allied Employees (HPAE) Local 5112. HPAE represents 12,000 nurses and health professionals across the state, including the 70 Registered Nurses at Runnells Specialized Hospital.

The presentation by CHR to the Union County Freeholders for the privatization and sale of Runnells Specialized Hospital was entirely focused on cost-saving measures, without any proposals for improving patient care and the delivery of health services to Union County residents. Nor did it propose how to maintain accountability to taxpayers and protect the rights of nurses and health care workers.

The continuing economic crisis in NJ has made an already turbulent health care environment more difficult. It appears the health care industry can appear to operate like Wall Street, chasing profits without proper oversight, accountability or transparency, with high administrative salaries and unnecessary patronage jobs.

Health care delivery has and is changing dramatically. Increasing for-profit owners, declining reimbursements and the Affordable Care Act will create both challenges and opportunities for patients, governments and the healthcare workforce.

However, privatization of health care has not proven to be the answer. In fact, the reverse is true-privatization has more often decreased access and quality of health care and created a decline in working conditions, wages and retirement security of the healthcare workforce. At the same time, accountability and transparency to taxpayers is also diminished or lost entirely.

Before Union County decides the fate of Runnells Specialized Hospital I ask that you consider:

- Has there been a financial assessment regarding the expansion of the psychiatric ward and the potential need, costs and revenue?
- What would be the benefits of adding a geriatric psychiatric unit?
- What is the potential for adding an acute care psychiatric unit?
- Would the county consider using Runnells as an adult day care facility for county residents?

- Middlesex and Monmouth counties have found a formula for not only making their county facilities profitable but are in fact expanding their system. Has this board looked at what these counties are doing to protect patient services?
- What is the interest of CHR in actually buying or managing these facilities and will they be excluded from bidding on the hospital since they have been a consultant?
- What factor will you use to decide the future of Runnells Hospital?
- Will you commit to protect the working conditions and collective bargaining rights of the workforce?
- Will you commit to protecting access to care for Union County residents?

I respectfully ask that before there is any further discussion regarding the sale of the Runnells bed license or selling the entire of the hospital that you consider other methods of gaining revenue that will allow Runnells Specialized Hospital to remain open to the community and perhaps even expanding services.
