# APPROVAL OF THE RESOLUTION TO READ THE BUDGET BY TITLE

Statement of Compliance read by the Clerk of the Board of Chosen Freeholders relative to the public hearing conditions set forth pursuant to N.J.S.A 40A:4-8.

The meeting is open to the public for the purposes of commenting on resolution 2013-312 only.

Bruce Paterson, Garwood, stated that he is happy with the procedures taken by the Board pertaining to the Budget this year. Mr. Paterson questioned the Statement of Compliance to read the Budget by Title.

County Counsel Barry responded. He stated that Resolution 2013-312 allows the Clerk of the Board to read the Budget by Title, and in order to do so, the Resolution Clerk is required to read the Budget by title only and declared the public hearing conditions. This Resolution must be passed, stating the legal and procedural conditions have been met.

**2013-312 FREEHOLDER SULLIVAN:** Determining that the 2013 Union County Budget shall be read by title and declaring that the public hearing conditions set forth pursuant to N.J.S.A. 40A:4-8(1a)(1b) have been satisfied.

The title of the Ordinance was read by the Clerk of the Board.

# PUBLIC HEARING ON THE 2013 BUDGET AMENDMENTS

Statement of Compliance with the Open Public Meetings Act relative to the public hearing conditions set forth pursuant to N.J.S.A. 40A:4-9.

The meeting is open to the public for the purposes of commenting on the 2013 Budget Amendments, as set forth by Resolution #2013-311: A resolution approving the 2013 Budget Amendments, only.

Bruce Paterson, Garwood, refuted Vice Chairman Hudak's claim of a \$14 million savings. He stated that taxes are still being increased by \$15 million. He questioned Sheet 16 of the Budget, declaring a savings of \$2 million and on Sheet 31, declaring of savings of \$2.5 million. He stated that these costs are deferred and claims that they will appear on next year's budget. He said half of the Open Space Trust Fund dollars are for employee costs.

Director Taylor stated that the health insurance line item in the Budget amendment went from \$49 million to \$47 million. She stated that they worked with the health insurance broker for the health insurance costs, and initially when they were contracting with Horizon, the County was aware of an 18% increase in this year's budget. She said but since we implemented some wellness programs, coupled with the lower census and marketing our benefits to various agencies, it was reduced by 10%, resulting in a \$1.7 million savings.

Director Taylor explained that the deferred charges are in consist of 3 segments, which date back to 1985. She said instead of raising those deferred charges in one year, and since they date back a couple of decades, we are going to phase them in. This year, we have \$125,000 in deferred charges, and next year will be included incrementally. These charges were incurred in the capital funds, and we do not anticipate collecting those funds. We may not receive all of the reimbursements because there were changes made by the State midway we had to incur those costs for signs and markings. She said the County assists municipalities with these services. Hence, we had to incur these costs.

Vice Chairman Hudak made a clarification of a previous speaker. He stated that the speaker claimed that there was a \$14.2 million savings, but instead it was a reduction of \$14.2 million in the overall tax levy to the tax payer.

Maria Edgemaria, Elizabeth, made comments referring to the Division of Police.

Chairman Carter stated that this portion of the meeting is for comments pertaining to the 2013 Budget Amendment. She advised Ms. Edgemaria to make comments regarding the police in the "any matter" portion of the Agenda.

John Bury, Kenilworth, stated that there are four items mentioned on the Agenda that are deferred items. He asked for an explanation. He spoke about realized dollars, dollars that were in the Introduced Budget and the dollars mentioned in the Amended Budget. He asked how does one anticipate more then was realized in the year prior.

Director Taylor stated that the rule of thumb is that we cannot anticipate more than realized in the prior year revenue, but it will most likely be approved by the State if it shows a trend and the back up materials show that the revenue can be collected. She stated that approval from the State was granted for the Realtor Transfer Fees and the County Clerk's budget.

Director Taylor also explained that there were medicare/medicaid reimbursement cuts made to Runnells Hospital.

Director Taylor stated that in reference to the emergency appropriation of initially in there for \$1 million, they were asked by the Board to lower the tax levy as much as possible. We went back to the 2012 budget, and instead of raising it in 2013, all departments were reviewed for savings. She said they were left with \$161,000 that could not be charged to any department and that is the amount being carried over into the 2013 budget.

Director Taylor stated that Ordinance due to capital expenditures not collected dating back to 1985, 1991 and 2010 as outlined in the audit, we would not recoup those dollars on these items. State changed policies and there, the deferred charges will be phased in.

Jim Buettner, Cranford, appreciated the handout, but suggested it be included last year's Budget in order to see the difference. He also suggested more cuts to be made.

# ADOPTION OF THE COLA / CAP BANK RESOLUTION

The meeting is open to the public for the purpose of commenting on Resolution 2013-313 only.

Bruce Paterson, Garwood, spoke about the 2% tool kit cap. He said it appears that there could be additional increases of taxes if needed. He urged the Board to vote no.

Mr. Paterson asked for an explanation of the first half of the sentence.

Director Taylor explained that the Cap the county works off is very different from what municipalities work off. Counties are required to work off the more restrictive of the two Caps: the 1977 Cap or the 2010 Cap. Hence, the 1977 cap is reflected in the 2013 budget. It is less than the 2% Cap than most municipalities are familiar with. The levy being utilized includes the Cap Bank Resolution that increases our appropriations over \$3.4 million. Anything not utilized up to that \$3.4 million goes into the subsequent budget year. She said it is important to note that the 2013 budget does not utilize any cap from the prior year. The budget presented as well as the Cap calculations haves been approved by the State and the outline of the Cap was in the budget document. It goes through the summary of the levy cap in lei terms, it shows the deferred and allowable charges that can be used. It is approximately 8 pages into the Budget. It shows the positives and negatives and the net result. The net result says under the 1977 Cap the tax levy is up to \$317 million and under the 2010 Cap the tax levy is up to \$324 million. She stated that taxes are not being raised up to \$324 million. The resolution provides flexibility. It is a planning tool for the next budget year.

Freeholder Bergen disagreed with Mr. Paterson's remarks. Freeholder Bergen stated that he supports the Resolution, adding that it provides the County flexibility.

#### **PUBLIC COMMENT PORTION**

The meeting is open to the public for the purpose of commenting on Resolutions being offered for adoption only.

Dr. McMenamin, Springfield, President of Union County College stated that she is in favor of Resolution 2013-314 and thanked the Board for their continued support. She said their support allows a great education for children, teens and adults, returning students and retraining and/or training individuals with programs the College provides. She stated that the Board also allows them to service businesses, industries and seniors with the programs they provide and this could not happen without the Board's support.

Dr. McMenamin stated that on behalf of nearly 40,000 Union County residents and the Board of Governors and Board of Trustees, she thanked the Board of Freeholders.

Bruce Paterson, Garwood, spoke about the debt and insurance and urged the Board to vote no on the Budget. He spoke about Resolution 2013-322, and was not pleased with Freeholder Hudak's comments about the ARC Tunnel. He stated that in reference to Resolution 2013-338, the cost is too high for fencing. He made comments about political donations pertaining to Resolutions 2013-343, 344 and 345.

Mr. Paterson stated that he was sad to hear about the death of former Mayor of Winfield, David Wright.

Director Graziano stated that Resolution 2013-338 was supposed to be for a Change Order to amend the original contract in the amount of \$133,000. He said the original contract amount was for \$200,000 for a total of \$333,000. He said the original contract was for fencing of acres and acres of parks and adding park maintenance. He said there are several parks that will be fenced, along with basketball courts throughout the County.

Director Graziano stated that the additional \$133,000 is for fence repairs and installation of fences caused by Storm Sandy, which will be reimbursed by the Federal Government.

Chairman Carter asked the Clerk of the Board to correct Resolution 2013-338 to reflect a Change Order in the amount of \$133,000.

Maria Edgemaria, Elizabeth, thanked the Board for supporting the YWCA. She asked for an explanation of Resolution 2013-324. She said the Board should provide more funding for the

#### YWCA.

Director Zuber stated that the program mentioned in Resolution 2013-324 offers workforce entrance training for victims of domestic violence. It will encourage financial independence and courage to victims of domestic violence at the YWCA.

County Manager Faella added that there are additional grants through the Community Development Block Grants for the YWCA. He said he did not have the figures in front of him, but is sure that it amounts to hundreds of thousands of dollars.

Jim Buettner, Cranford, stated that he supports Resolution 2013-322, stating that he is in support of dual powered locomotives are needed. He asked for an explanation of Resolution 2013-330. In reference to Resolutions 2013-317 and 332, he said he would appreciate County Counsel's office makes vendors aware of the truck specifications and hopes it goes to the lowest bidder.

Director Guzzo stated that this is the first time they have a Resolution for this type of service, referring to Resolution 2013-322.. He explained that the Spectrum Ultra Violet light is to detect certain substances and it is grant funded. He stated that the purchase of the truck is through the Prosecutor's Office and used for variance surveillance activities and the funding is through their grant. It is a specific truck for a specific purpose.

# **PUBLIC COMMENT PORTION**

This meeting is open to the public for the purpose of commenting on any matter.

Maria Edgemaria, Elizabeth, had a question on the OPRA application. She asked if she could receive the Minutes from a Freeholder Meeting when she spoke about her son.

Ms. Edgemaria also made comments about a Union County Police Officer at the Social Service Office. She said she was not pleased with the way he spoke to her son who suffers from Autism.

Chairman Carter stated that the matter is under investigation and advised Ms. Edgemaria to speak to Director Moran.

County Counsel Barry stated that to his knowledge if there was an incident and a police report, and it does not rise to the level of a felony, it does not pertain to the bottom of the application of the OPRA form.

Bruce Paterson, Garwood, spoke about the legal case set by the Union County Watchdog Association. He added that an email for OPRA documents is satisfactory.

Mr. Paterson read titles from recent articles in various newspapers relative to Union County. He made comments regarding legal service fees and donations.

Mr. Paterson also spoke about Prosecutor Romankow and Ms. Renna. He noted the City of Summit offered to help the County with their budget and they were refused. He spoke about the

Executive Director of the Improvement Authority's salary and Mr. Neff of the Local Finance Board.

John Bury, Kenilworth, mentioned DeCotiis law firm's contributions to various entities. He said he agrees that the Cap Bank allows flexibility, but by not voting for it, the Board would have shown more discipline.

Jim Buettner, Cranford, spoke about political campaigns and a Legislative Bill that is sponsored by the State and is supported by Steven Sweeny and Loretta Weinberg. He asked that Freeholders Mirabella, Bergen and Jalloh be proactive in discussions concerning political donations. He spoke about the buy-out program for health insurance and urged the Board to seek expertise on reducing the budget.

Mr. Buettner asked for the status of the missing chain saws and the misuse of County generators.

Chairman Carter stated that the Board has not received any notification from the Prosecutor's Office regarding the chain saws and the generators.

Director Taylor stated that the opt-out provision of the health insurance plan is for employees who are entitled to family coverage is in an amount of up to \$5,000. It represents a savings of not less than 75% savings for County costs and \$2,500 for single coverage, otherwise they would be entitled to receive full time employee coverage, which would cost the County more than the opt out amounts. This is based upon proof that they have coverage elsewhere.

## FREEHOLDER REPORTS AND COMMENTS

Freeholder Kowalski thanked County Manager Faella, Directors and staff for the work on the budget, stating it is a long and difficult process. She said she also appreciates the public's comments. She explained that the County Budget is not the same as Municipal Budgets. She said the County has costs associates with the Courthouse, Hospital, Jail and Detention Center, and are all included in the Budget.

Freeholder Kowalski thanked all involved in the Adopt-A-Park. She mentioned several organizations; Merck, Kean University, Boy Scouts and Girl Scouts. She also thanked the students who planted trees in honor of Arbor Day.

Freeholder Kowalski extended her sympathy to the family of former Mayor of Winfield David Wright and to former Administrator of Runnells Hospital, Joan Wheeler, on the passing of her daughter, Elizabeth.

Freeholder Wright congratulated Chairman Carter for being recognized by the Salvation Army of Plainfield. She stated that she attended an event last evening with Chairman Carter and Freeholder Kowalski for Outstanding Women Leaders. They will be hosting its first annual Title IX celebration and the 40th Anniversary of the Federal Law through remembrance and education and will acknowledge female athletes of Union County. The event took place at Union County College.

Freeholder Mirabella stated that on Friday, April 26th, applications to municipalities and non-profit organizations, for the sixth round of Preserve Union County grants under the Union County Open Space, Recreation and Historic Preservation Trust Fund. As Chair of the Trust Fund, he said he is proud of the voters of Union County, who overwhelmingly approved Trust Fund by popular referendum in the year 2000. Since then, despite the economic crisis of 2008, Preserve Union County has continued to help Union County residents save some of their most treasured and

historically valuable civic landmarks. He thanked all of those who have supported the Trust Fund throughout the years, and extended his well wishes to all of our Preserve Union County grant applicants this year.

Freeholder Mirabella thanked Freeholder Sullivan, Chairman of the Fiscal Committee, and all the Directors, especially Director Taylor and County Manager Faella on their timeless work on the Budget. He said the budget process is now a 12 month process and they are driven to save dollars.

Freeholder Bergen stated that there have been no improper donations made. He sent his condolences to former Mayor David Wright's family and thanked the Board for supporting Resolution 2013-315, stating that Newark Airport's flight pattern has been a long-time problem.

Freeholder Bergen stated that there is a very special installment of our Sensory Friendly Theater series coming up at the Union County Performing Arts Center in June, in the downtown Rahway Arts District. He said we will be hosting the family-friendly rock and roll of Ralph's World, the musical creation of Ralph Covert. Mr. Covert is a nationally renowned recording artist and advocate for children's music education, and we are delighted to welcome him to Union County.

Freeholder Bergen stated that the Sensory Friendly Theater is especially designed for persons with autism and other forms of sensitivity to enjoy the enriching experience of a live performance, in a relaxed, "judgment-free" atmosphere. Freeholder Estrada stated that in reference to the budget, there are guidelines that need to be followed. We have saved dollars, but there is always room to improve. It is difficult and said that the needs of children, seniors and disabled need to be serviced. He commended the Fiscal Committee and specifically Director Taylor for her expertise and patience. Vice Chairman Hudak was pleased to announce that trained staff from our Department of Human Services will be out in the community this spring to conduct a series of four information sessions for senior citizens. These events are designed to help seniors learn about all of the forms of assistance for which they qualify, and our staff will also provide one-on-one help in navigating through the application process. The sessions will start on May 9th at the Summit Public Library. They will continue through June at the Westfield, Mountainside and Linden libraries. Persons with disabilities may also qualify for some of these programs, even if they are not seniors. Vice Chairman Hudak commended the Fiscal Committee and the Board, stating thankfully, there were no layoffs this year.

Vice Chairman Hudak spoke about the ARC Tunnel's previous speakers' comments. He said beyond the fact that we are decades away from a one-seat train ride to Manhattan, we are at best a decade away from the expansion of rail service in this part of the County and New Jersey. The Governor claimed that he "pulled the plug" because instead of costing \$12 billion dollars it would have been \$14 billion. He said but in 10 years, that amount will triple, plus the loss of jobs. He said homes located near the train station would increase property values. He spoke about Governor Christie's many other cuts.

Vice Chairman Hudak spoke about the passing of former Mayor David Wright. He said Mr. Wright was proud of Winfield and those 400 voters that he represented.

Chairman Carter stated that they are mindful of the money spent. She thanked Director Taylor, County Manager Faella and all the directors and employees who are working to save dollars. He said they will continue to reduce costs, and will continue to work on the budget.

Chairman Carter stated that the second session of our 2013 Union County Means Business networking series was held earlier this week, and she thanked the Union County Development Corporation for making it another successful event.

Chairman Carter also thanked Anthony Silva, Vice President of Business Lending at Investors Bank, who joined in sharing his considerable experience with the Union County business community. She stated that they are looking forward to the next session, which will be a full afternoon of programming on Wednesday, June 19th. The theme will be "Union County Women Mean Business." This will be a great opportunity for women to network and learn more about key fundamentals such as re-entering the workforce, social media, and the glass ceiling. As always, this event is free and open to all business owners and managers in Union County. It will be held at the new Clubhouse at Union County's Galloping Hill Golf Course.
