# CALL TO ORDER

Chairman Bruce H. Bergen presided over the meeting and called the meeting to order at 7:01pm.

# ROLL CALL

Roll call showed Chairman Bruce H. Bergen, Freeholder Linda Carter, Freeholder Angel G. Estrada, Freeholder Mohamed S. Jalloh, Freeholder Bette Jane Kowalski, Freeholder Alexander Mirabella, and Vernell Wright were present, with Freeholder Christopher Hudak and Vice Chairman Sergio Granados absent.

Also present were County Manager Alfred J. Faella, County Counsel Robert E. Barry, Esq., and Clerk of the Board James E. Pellettiere.

# PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

# STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

#### APPROVAL OF COMMUNICATIONS

Note and File

Chairman Bergen noted that the Board would approve the communication at the next Regular Meeting of the Board.

#### PRESENTATION TO THE BOARD

A presentation will be made to the Board by Maryanne Preztunik and Sam Crane, of Pre-K Our Way; a nonprofit, nonpartisan statewide organization focused on expanding New Jersey's existing high-quality pre-kindergarten.

Chairman Bergen called upon Freeholder Mirabella to introduce the night's presenters.

Freeholder Mirabella spoke on a local presentation in Roselle that he heard relative to the Pre-K Our Way initiative and invited them to make a presentation to this Board in an attempt to gather more information and potentially offer a resolution for consideration by this Board. Freeholder Mirabella called upon Maryanne Preztunik and Sam Crane to make their presentation.

Maryanne Preztunik stated that eight years ago New Jersey promised to expand pre-k to more communities. She stated that 50,000 New Jersey kids are still waiting, and in particular to Union County, more than 3,000 kids are waiting for pre-k programming.

A two minute video was presented on the meeting room television monitors.

Maryanne Preztunik stated that Pre-K Our Way is a non-profit, non-partisan statewide advocacy organization, noting that they are not a school. She advised that they started eighteen months ago with the goal of expanding the existing high-quality state funded full day pre-k to 3 and 4 year old communities which was promised by law. She spoke to the number of advocacy organizations that have joined their leadership group, noting that both former Governors Florio and Kean are active within the leadership group. She stated that Pre-K Our Way is a "New Jersey only" organization, with the exception of the Bill and Melinda Gates Foundation. She stated that in less than 18 months, Pre-K Our Way established pre-k expansion as a legislative and public priority. She introduced Sam Crane to speak on the legislative portion of the organization.

Sam Crane, former New Jersey State Treasurer, stated that Pre-K Our Way believes that where a child lives should not determine whether or not they have access to high-quality preschool. He stated that in Union County, Plainfield and Elizabeth have access to the Pre-K programming through the 2008 law. He spoke to a Star Ledger report that New Jersey Pre-K education programming is a national model, and spoke to the success. He stated that they will be spending the next two years working with the legislature and the entire advocacy groups to ensure the expansion of pre-k programming gets started.

Freeholder Estrada stated that all can agree starting children in pre-k provides for immediate results in the children's education, noting the issue has always been the ability to pay for the programming. He stated that there are 31 Abbot Districts, but people want to chip away from these 31 districts in order to make it accessible to the whole state. He asked how they intend to fund this initiative.

Sam Crane stated that while there are 31 Abbot Districts and 4 other school districts that receive state funding, there are 102 school districts that would qualify for funding under the 2008 law. He stated, between State funds, Federal funds and local property tax, New Jersey spends approximately \$28 billion per year on Kindergarten through Grade 12 education. He stated that funding this initiative would cost is less than one percent; adding that the cost not to do it includes increasing special education costs and increased costs to retain students. He said this is a small investment with a long term dividends. He spoke of a Rutgers study that supports this initiative, and cited success stories in Texas and Georgia.

Maryanne Preztunik referenced an independent law enforcement group "Fight Crime Invest in Kids" which issued a report that documented the cost of the program (\$550 million) for pre-k and save \$1.2 billion in law enforcement costs.

Freeholder Estrada agreed that the State needs to fund this programming, and suggested that this issue could be put on the ballot as a Referendum Question.

Sam Crane spoke of a debate that suggests that we should take money from one community and give it to another; stating that is the last thing the state should do.

Freeholder Mirabella stated that education has been a hallmark of this Board; noting the membership of the Board: former principal Freeholder Wright, teacher Freeholder Carter, adjunct professor Freeholder Jalloh, former Board of Education member Freeholder Estrada. He noted the support the Board has given to both Union County College and Vocational-Technical Schools over the years. He thanked them for the night's presentation and will be asking the Board to sponsor a resolution supporting Pre-K Our Way's initiative.

Chairman Bergen asked the Clerk of the Board to prepare such a resolution for the next Regular Meeting agenda.

Clerk of the Board Pellettiere also noted that Vice Chairman Granados entered the meeting during the presentation for the record.

# OFFICE OF THE UNION COUNTY PROSECUTOR

Grace H. Park, Acting Prosecutor

First Assistant Prosecutor Tim Isenhour represented the Office.

- 1. Authorizing the County Manager to apply for and accept funding from the State of New Jersey, Police Training Commission, for the 2016 Law Enforcement Officers Training and Equipment Grant, for the period of January 1, 2017 through December 31, 2017, in the amount of \$27,402. (Chairman Bruce H. Bergen)
- 2. Authorizing the County Manager, through the Union County Prosecutor's Office, to award a contract with Qiagen, Inc., Valencia, CA, for the purchase of laboratory equipment For DNA extraction, in an amount not to exceed \$21,855.00. (Chairman Bruce H. Bergen)
- 3. Authorizing the County Manager to enter into a professional service contract with Dr. Louis B. Schlesinger, Maplewood, New Jersey, to provide expert services in the fields of forensics, DNA and psychology for the period of September 1, 2016 through December 31, 2016 in the amount of \$11,000.00. (Chairman Bruce H. Bergen)

Freeholder Estrada asked how much time county employees in the DNA laboratories spend relative to the needs of the Courts.

First Assistant Prosecutor Isenhour noted that this was a mistake, that Dr. Schlesinger is a forensic psychologist who is used primarily in homicide and child abuse cases dealing with competency with a defendant. He is very well regarded. He stated that the Office has used him on six or seven cases this year and has exceeded the pay to play laws, necessitating this resolution request.

4. Authorizing the County Manager, through the Union County Prosecutor's Office, to enter into an agreement with Spincube Inc., of Jersey City, NJ, for the purchase of software, licenses and installation services for virtualization of servers, in an amount not to exceed \$38,697.89. (Chairman Bruce H. Bergen)

Freeholder Carter asked if First Assistant Prosecutor Isenhour can explain in more detail the goals of the contract are and what the continual costs associated with the contract would be.

First Assistant Isenhour explained that the software to be purchased would allow the Office to store data on multiple servers. He noted that Superstorm Sandy highlighted the need for such a service. He stated that this would allow the Office to download to one server and share with multiple servers.

Freeholder Carter asked if the Office has considered a cloud based backup server that may not be as costly.

First Assistant Isenhour advised that their Office does in fact utilize cloud based servers for some data, however due to the volume the Cloud Storage would not be a viable option. He stated that he did not have the annual maintenance cost of the software, but would provide such to the Clerk of the Board to share with the Board.

#### DEPARTMENT OF ADMINISTRATIVE SERVICES

Michael Yuska, Director

Freeholder Carter asked if the Director could provide more detail to this resolution request.

Director Yuska advised that this particular resolution is required by the JIFF three months in advance of the start of the year. He stated that his office will come before the Board in December when the financing amounts are released and made available for both the JIFF and the Self Insured portion.

- Amending Resolution 2016-559, a contract awarded to Practice Associates Medical Group, a Subsidiary of Atlantic Health Systems, of Clark, New Jersey for the provision of 2016 Pre-Employment Medical Exams for the period of January 1, 2016 through December 31, 2016, to increase the amount by \$50,000.00, for a total amount not to exceed \$147,000.00. Authorizing the County Manager to initiate a "Request for Competitive Contract" (RCCP #6-2016) in order to identify a provider to provide software and services for the Citizens Notification System by the Division of Information Technologies. On August 31, 2016 a "Request for Competitive Contract Proposals" (RCCP #6-2016) was issued and responses were received on September 20, 2016 with a Five Year contract option. (Chairman Bruce H. Bergen)

DEPARTMENT OF ENGINEERING, PUBLIC WORKS & FACILITIES MANAGEMENT loseph Graziano, Director 1. Authorizing the County Manager to execute a Joint Funding Agreement with the United States Department of the Interior, U.S. Geological Survey, Water Resources Division, W. Trenton, New Jersey, for a joint funding agreement for the period of October 1, 2016 through September 30, 2017 in a sum not to exceed \$15,920.00. (Freeholder Linda Carter)

Freeholder Estrada asked if the US Geological Survey have expanded any other waterways, and ask of the current locations.

Director Graziano advised there are stream gauges in the Rahway River in Rahway and Springfield; there is another gauge in different section of the Rahway River; there is another gauge in the Robinson Branch; and another gauge in Kenilworth. He advised they have not expanded it since last year, or the year before (as far as location).

2. Director Graziano advised this 24 month contract has been reduced by \$652,000 due to the fact that the previous contract included extensive work by the Sheriff's Office's work with the Active Shooter and the Runnells portion. He stated that the County would see how much was spent on this contract before considering the next 24 month contract (or if the County would prefer to go back out to bid).

Freeholder Kowalksi asked if the Director could explain the Area Plan in more detail.

Director Guzzo advised the Area Plan provides money for all senior services provided by the County, including respite care, meals on wheels, etc. He explained the State releases the money incrementally, noting that this is the sixth installment this year, and noted that it amounts to a reduction of approximately \$18,000 from the previous year's funding.

Freeholder Mirabella noted that the Bylaws apparently haven't been updated since 1998 and asked why that was the case.

Director Guzzo stated that he was correct, and noted that they should have been updated by the Board of Managers of Runnells Specialized Hospital. He noted that the changes are a result of the County receiving a survey recently by the State asking for a "chain of command" and organizational chart. He noted that Cornerstone is a Division within the Department of Human Services.

17. Congratulating Silkies Hike NYC, and Irreverent Warriors for creating a support network to prevent veteran suicide. (Chairman Bruce H. Bergen)
