### DEPARTMENT OF ECONOMIC DEVELOPMENT

Amy Wagner, Director

1. Authorizing the County Manager to enter into an agreement with Development Directions LLC, Rahway, New Jersey, for administration of the Union County Home Improvement

Program and Senior Home Improvement Grant, which provide assistance to lower income homeowners for repair and rehabilitation of their homes, through a fair and open process for the procurement of services in the form of an RFP issued on June 1, 2016 and responses received on June 23, 2016, in an amount not to exceed \$335,000 for the period of September 1, 2016 through August 31, 2017, with the potential for two one year extensions. Freeholder Kowalski inquired as to the number of senior citizens that take advantage of the program.

Director Wagner advised that there were twelve senior grants awarded along with an additional twelve loans among sixteen municipalities, noting that the City of Elizabeth and Township of Union receive their own CDBG funds, and that the City of Linden, the City of Rahway and the City of Plainfield have their own programs.

2. Authorizing the County Manager to award a contract to Union County College for the period of September 1, 2016 through June 30, 2017, to provide computer literacy, adult education, and English as a Second Language training to a minimum of twenty-four (24) participants in an amount not exceed \$24,000.00. 1. Resolution Modifying the 2016 Union County Adopted Budget in the amount of \$489,653 as a result of notification received from the State of New Jersey, Department of Community Affairs for a program entitled: Community Services Block Grant - CSBG. (Freeholder Alexander Mirabella)

Freeholder Carter inquired as to the comparison in funds to previous years' allocations.

Director Taylor stated that the County typically receives \$800,00 and noted that her office anticipates receiving additional funds.

2. Resolution Modifying the 2016 Union County Adopted Budget in the amount of \$166,644 as a result of notification received from the State of New Jersey, Department of Law and Public Safety for a Program Entitled: Gangs, Gun and Narcotics Grant. (Freeholder Alexander Mirabella)

### DEPARTMENT OF HUMAN SERVICES

Frank Guzzo, Director

1. Authorizing the County Manager to enter into a lease agreement with The Gateway Family YMCA, Elizabeth Branch, to rent space for the Intoxicated Driver Resource Center (IDRC) education classes to be held at 1564 Irving Street, Rahway, New Jersey, at a rate of \$520 per day, for a minimum of 52 scheduled days scheduled during the period of January 1, 2017 through December 31, 2017 in the total amount not to exceed \$27,040. (Freeholder Bette Jane Kowalski)

Freeholder Mirabella asked for additional clarification relative to the program.

Director Guzzo advised that IDRC program, which is operated by the County, and is mandated if an individual loses their license due to a DUI. He added that this program provides the required training and in addition provides counseling services. He advised that the program is self-sustaining due to the fees that are collected.

He advised that this resolution is for the cost of the lease of the space for the program, and that it is in the same amount as last year.

2. Authorizing the County Manager to apply for and execute the FY2017 Community Services Block Grant (CSBG) agreement in the amount of \$307,191 from the State of New Jersey, Department of Community Affairs (NJDCA) for the grant period of October 1, 2016 through June 30, 2018 for the purpose of providing community programming for low income residents of Union County; and to recognize and accept that the Department may offer a lesser or greater amount and therefore, upon receipt of the grant agreement from NJDCA, does further authorize the execution of any such grant agreement. (Freeholder Bette Jane Kowalski)

Vice Chairman Granados asked the Director to elaborate on this resolution request.

Director Guzzo stated that the program is designed to help assist residents to move towards permanent housing. He stated that last year, the County provided services to 537 households. He stated that money is allocated by a RFP process to various agencies to provide various services within the community.

3. Amending Resolution Number 2016-129, pursuant to a Request for Proposal awarded subcontracts under the 2014 SuperNOFA Continuum of Care (CoC) competitive grant award, to reflect an increase of \$5,888.98 in funding award for a new grand total of \$4,246,618.98 and to extend the one year time frame for three projects to be allocated as outlined and charged to account numbers specified on the spending plan; all other terms remain the same. (Freeholder Bette Jane Kowalski)

Freeholder Carter asked for additional clarification relative to the resolution request.

Director Guzzo advised that this resolution would allow for additional funds for one agency and extend three contracts in order to fulfill services. He advised that the City of Plainfield had some issues relative to its housing vouchers as a result of funds not being distributed where they normally

are; noting that these funds stabilized those individuals which prevented them from becoming homeless.

Freeholder Carter asked if the extension is needed to ensure that the County receives the necessary paperwork to meet the deadlines.

Director Guzzo stated that she was correct.

4. Authorizing the County Manager to enter into an agreement with Jacqueline Napper, PsyD, MSCP, Plainfield, New Jersey, to provide psychological services to the patients of Cornerstone Behavioral Health Hospital for the period of August 1, 2016 through July 31, 2017 in an amount not to exceed \$9,600.00. (Freeholder Bette Jane Kowalski)

Freeholder Wright asked if this resolution provides for additional staff or a replacement.

Director Guzzo advised that this resolution would provide for a renewal of a contract with an individual the Department has had to provide services at Cornerstone at the same previous rate.

5. Authorizing the County Manager to enter into a Shared Services Agreement with Essex Regional Educational Services Commission, Fairfield, New Jersey, to provide state mandated education programs for the residents housed in the Union County Juvenile Detention Center for the period of September 1, 2016 through August 31, 2017 in the total amount not to exceed \$960,000. (Freeholder Bette Jane Kowalski)

Freeholder Carter asked for additional clarification relative to the resolution request.

Director Guzzo stated that this resolution would allow the county to hire a new vendor to provide educational services in the juvenile detention center. He reminded the Board that the Union County Educational Services Commission had provided these services for the past 15 years. He noted that they notified the County in the middle of the summer that they were not going to renew the program. He advised that the regulating agency, Juvenile Justice Commission, recommended the County consider this agency. Director Guzzo advised that the Essex Regional Education Services Commission is a school district that has provided these same services to the Essex County Juvenile Detention Center for the past twenty years. He noted that they received recognition in 2014 for their program with an Education Program of the Year award. He advised that the draft proposal sent to the Board earlier in the day will be replaced on Monday with the actual proposal, noting that the funding has already been approved for in the budget and is actually at a lower contract amount than that of the Union County Educational Services Commission.

Vice Chairman Granados asked the Director to elaborate on this resolution request.

Director Zuber called Director Sanchez to answer, as he is the project manager for the project.

Director Sanchez stated that the resolution request is for a construction administration extension for the Warinanco Ice Skating Center. He advised the County had to extend the project out four additional months due to unanticipated delays in weather and permitting delays. He advised that there are some additional architectural changes as a result of findings out in the field.

County Manager Faella stated that this item has been discussed in a Fiscal Committee meeting, where a number of questions were asked and a detailed explanation was provided. He advised that those minutes will be forwarded to all other Freeholders not on the Fiscal Committee. He advised that he would be available to answer any further question any Board member may have.
