## PUBLIC COMMENT PORTION

(Freeholder Sullivan entered the meeting)

Chairman Mirabella thanked everyone for attending the Special Meeting to consider two items. He stated the following:

First, as you may have read in the paper or heard, while we were going through the process of seeking to privatize the dietary, housekeeping and laundry services at Runnells Specialized Hospital, it became clear the County should utilize competitive contracting to select a vendor.

The County's statement on this is as follows: We believe competitive contracting will increase the likelihood of a better outcome for everyone involved for some of the following reasons:

Competitive Contracting provides greater flexibility to establish the terms, length and conditions of a contract

Competitive contracting is not limited to price only, and allows for the consideration of other factors including experience and relevant service qualifications

More competition increases the likelihood of a better outcome

As part of the competitive contract, the County will require the vendor to give current employees, in good standing, the first right of refusal for any employment opportunities that arise as a result of the contract. It should also be noted that employees and/or their representatives shall be permitted to respond to the competitive contract proposal.

If employees are represented by an organization that has negotiated a contract with the contracting unit (meaning the County), only the bargaining unit shall be authorized to submit such recommendations or proposals.

Finally, our decision to procure a vendor through this method will necessitate extending the employment of 101 Runnells employees in these areas who otherwise would have been impacted by a layoff on June 1<sup>st</sup>. Their new layoff date is August 31<sup>st</sup>.

Second, after months of work, we have identified a vendor to provide health and prescription benefit coverage for the County of Union.

As you may be aware, Cigna has been the County's carrier since July 1st, 2009. Cigna's initial renewal increase for our plan represented an approximate 18.41 percent increase year over year for an overall difference of \$10.4 million.

Through the hard work of our County Manager, Director of Administrative Services, Director of Finance, staff and our health insurance consultant, we went out into the marketplace and found a far better deal with Horizon Blue Cross Blue Shield of New Jersey.

The proposed resolution before us for consideration tonight only represents an increase of 2.94 percent, well below the current health care trend average of 10%. Of further note, It is also cheaper than the state health benefits plan by approximately 3 percent or \$2.2 million.

Therefore, we are considering this resolution to change carriers and award the health and prescription coverage to Horizon Blue Cross Blue Shield of New Jersey.

This meeting is open to the public for the purposes of commenting on resolutions being offered for adoption only.
