PRESENTATION TO THE BOARD

A presentation was made by Maureen Tinen, President of Union County Economic Development Corporation (UCEDC), regarding the services provided to Union County Businesses through the UCEDC.

Deputy Director of Parks and Community Renewal Cherron Rountree introduced Ms. Tinen of UCEDC. Deputy Director Rountree stated that Ms. Tinen would provide the Board with an update and overview of programs it has hosted in the past and what they have done to partner with us this year. She stated that the UCEDC has been a good partner for many years.

Ms. Tinen thanked the Board for their commitment and partnership. She thanked Freeholder

Sullivan for serving on the Board of Trustees and the Executive Committee.

Ms. Tinen provided the Board with a packet and highlighted two areas where Union County partners with the UCEDC: US Dept. Of Defense Procurement Technical Assistance Center and general economic development services for Union County (loans, reports, training and mentoring in English and Spanish). She gave an overview of both programs.

Ms. Tinen stated that in 2012 they secured more than \$220 million in contracts with 6,600 Union County businesses and 4,400 jobs retained. Union County supports 17% of the budget. She stated that there are no County dollars involved in lending. The loans are via banks, and the State and Federal Government. She said should there be a default, the County has no responsibility. She added that lending is down. She spoke about Storm Sandy loans and the high-tech training that is provided.

Ms. Tinen thanked Director of Public Information Seb D'Elia and Deputy Director Tina Casey for their assistance in promoting the program. She also spoke about Union County Means Business and stated that the UCEDC provides leadership to 10 Union County organizations.

The entire packet is attached.

Freeholder Mirabella stated that he is in support of the UCEDC. They are true partners in the community and they bridge a gap between the community and business. They also facilitated loans during Storm Sandy. He said fully supports the UCEDC and its programs.

Freeholder Estrada stated that he is also in support of the UCEDC. He believes they are very successful in providing a critical road map and thanked them for their efforts. He said he hopes they are able to engage many people in the programs.

County Manager Faella asked Ms. Tinen to disclose the UCEDC's new location.

Ms. Tinen stated that they purchased a building on Chestnut Street in Cranford. She thanked the Freeholders and stated that their clients' success stories are located within the packet. She also thanked the Board for the compliments.

Deputy Director Rountree recognized Vice President of the UCEDC, Adam Farrah.

DEPARTMENT OF ENGINEERING, PUBLIC WORKS AND FACILITIES

Joseph Graziano, Director

- 1. Amending Resolution Number 2012-226, a contract through a competitive contracting evaluation process, with EMSA Solar, Parlin, New Jersey, approving Change Order No. 1 (final) for the design and installation of Multiple Solar Photovoltaic Systems at Runnells Specialized Hospital, Berkeley Heights, New Jersey, in the amount of \$22,921.25 for a new total contract amount not to exceed \$1,496,921.25. (Chairman Linda Carter)
- 2. Amending Resolution Number 2008-779, a Professional Architectural Service Contract with Netta Architects, LLC, Mountainside, New Jersey, approving Amendment No. 5 for additional architectural/engineering services associated with the Union County Correctional Facility in the amount of \$214,083.00 for a new contract amount not to exceed \$512,173.00. This amendment

will extend this contract for an additional eleven (11) months from September 2013 through July 2014. (Chairman Linda Carter)

3. Amending Resolution Number 2011-634, a Professional Construction Management Service contract with Pinnacle Consulting, Newark, New Jersey, approving Amendment No. 2 for additional construction management services associated with the Union County Justice Complex Alterations - Phase I & II project in the amount of \$416,000.00 for a new contract amount not to exceed \$1,254,404.52. This Amendment will extend the contract for an additional sixteen (16) months from April 20, 2013 through to August 2014. (Chairman Linda Carter)

Freeholder Estrada asked for an explanation of the Change Order items.

Director Graziano explained that items #2 and #3 are combined and both involve the Correctional Facility project. He explained that they are not adding any new capital to this project. There are various vendors involved in this contract. It all consists of old capital money. Changes were made to these two items to provide an extension in contract for each vendor. Phase II consists of additional work on the pods. It would make sense to do it now, rather than closing the pods at a later date. The Old Jail will have repairs done, such as hardware, security and doors; which held up the project for six months. It needs new design work.

Freeholder Estrada asked why item #2 referenced the Union County Correctional Facility and item #3 states the Union County Justice Complex. He asked if it is the same facility.

Director Guzzo interjected. He said one is the Old Jail and the other is the Oriscello Correctional Facility.

Director Graziano stated that Phase III will begin while Phase II is being improved.

Freeholder Estrada asked about the results of the project.

Director Graziano stated there will be a new lobby, kitchens, security cameras, etc. He said the project will take about 18 months and will cost approximately \$6 million. The entire project is estimated to cost \$22 million and the construction management percentage is 5.5%. The architect's percentage is 7.5%. Director Graziano stated that based the project on 10% percent for each service.

Freeholder Estrada asked if these renovations will address the people waiting outside to visit inmates in the winter.

Director Riordan stated that the jail is being refurbished and it has always been over used due to its population. It was originally built for 517 inmates, but that number has always been exceeded. He said the camera control center will be modernized, and they are discussing a video visitation system to decrease the amount of people standing outside in the winter.

Freeholder Estrada asked if the project will be completed in 18 months.

Director Riordan stated that the project goes back to 2008 (with letters dating from 2002). He explained the difficulties of a construction project within a jail facility. This opportunity has presented itself, he said, so we need to take advantage of it.

Chairman Carter stated that the project has been started, and there are no new dollars involved.

Director Riordan added that the pod project will take 18 months and the control center will take longer.

- 4. Authorizing the County Manager to award the proposed contract obtained through advertised public bidding in accordance with the Local Public Contracts Law, NJSA 40A:11-1 et seq: Engineering: Tiffany Electric, Inc., Fairfield, New Jersey, for the purpose of providing Intersection Improvements Project Vauxhall Road and Valley Street, Township of Union, one hundred eighty (180) days from Notice to Proceed in the amount of \$290,660.50. This is a Federal Funded Project. (Chairman Linda Carter)
- 5. Authorizing the UC Board of Chosen Freeholders to award the proposed contract obtained through advertised competitive contracting in accordance with the Local Public Contracts Law, NJSA 40A:11-1 et seq: Engineering, Public Works & Facilities; Division of Facilities Management: Keemo Cafeteria, LLC, for the purpose of providing Food Concession Services and Vending Space, April 1, 2013 through March 31, 2018, in the amount to be paid to the County of \$450,000. (Chairman Linda Carter)
- 6. Authorizing the County of Union to exercise the option to extend their contract, awarded through Open Public Bidding, with Radiac Research Corporation, Brooklyn, New York, for an additional twenty-four (24) month period from June 28, 2013 through June 27, 2015 for the collection, packaging, transportation and proper disposal of all wastes collected at Union County Household Hazardous Waste Programs in the amount of \$279,752.00. Contract is funded in full through the Recycling Enhancement Grant. (Chairman Linda Carter)

Freeholder Sullivan asked about item #6.

Director Graziano stated it is to pay contractors for collection and disposal of hazardous household waste.

Freeholder Sullivan asked where the recycling dollars come from. He also made comments regarding the Governor's budget message on rescinding the recycling grant dollars.

Director Graziano explained that the County receives the dollars from the State. However, if the recycling budget passes in 2014, we will not be receiving any money from the State towards recycling.

Freeholder Sullivan stated that we need to recycle as much as possible now, adding that the State pressures to recycle yet are rescinding the dollars.

Chairman Carter stated that a Resolution will be prepared and sent to Governor Christie's office.

Freeholder Mirabella stated that we should notify the municipalities.

Director Graziano stated that the notification memo from the State was not only forwarded to each Freeholder, but to each municipality.

Freeholder Hudak stated that the Legislators should be contacted.

DEPARTMENT OF HUMAN SERVICES

Frank Guzzo, Director

Director Guzzo explained the purpose of the Resolutions.

(Freeholder Bette Jane Kowalski)

- 2. Amending Resolution Number 2013-109, to allocate additional HOPWA Spending Plan funds in the amount of \$12,907.00, for a revised total allocation of \$534,907.00, for the period of January 1, 2013 through December 31, 2013 for the provision of long term rental assistance to people with HIV/AIDS. (Freeholder Bette Jane Kowalski)
- 3. Authorizing the County Manager to approve the 2013 Coordinated Community Care Spending Plan in the total amount, not to exceed, \$100,000.00; entering into agreements with various agencies, pursuant to a Request for Proposal for contract year one of a three year cycle with renewal contingent upon receipt of additional grant funding from New Jersey Department of Human Services, Division of Aging Services, to provide Home Care and Nursing services to Union County residents 60 years or older for the period of January 1, 2013 through December 31, 2013; further authorizing the County Manager to transfer funds among the funded agencies, during the contract period, should services needs change and/or if any of the funded agencies should fail to meet its contractual obligation. **(Freeholder Bette Jane Kowalski)**
- 4. Authorizing the County Manager to approve the 2013 Statewide Respite Care Spending Plan in the total amount, not to exceed, \$326,460.00; entering into agreements with various agencies, pursuant to a Request for Proposal for contract year one of a three year cycle with renewal contingent upon receipt of additional grant funding from New Jersey Department of Human Services, Division of Aging Services, to provide Respite Care services to unpaid caregivers of Union County senior and disabled residents for the period of January 1, 2013 through December 31, 2013; further authorizing the County Manager to transfer funds among the funded agencies, during the contract period, should services needs change and/or if any of the funded agencies should fail to meet its contractual obligation. (Freeholder Bette Jane Kowalski)

DEPARTMENT OF PARKS AND COMMUNITY RENEWAL

Ronald Zuber, Director

1. Authorizing the County Manager, through the Office of Cultural and Heritage Affairs, to execute any and all agreements for the Fiscal Year 2013 Union County Arts Grant Program in the amount of \$58,500. (Freeholder Bette Jane Kowalski)

Director Zuber stated that they have received \$1,100 more this year. The funding comes from the State of New Jersey, Department of Cultural and Arts and that the Cultural Affairs Advisory Board reviews, approves and awards the grants.

Authorizing the County Manager to enter into an agreement with the Union County Economic Development Corporation for the purpose of providing general economic development services to private businesses in Union County for the period of January 1, 2013 through December 31, 2013 in the amount of \$60,000.00. (Freeholder Daniel P. Sullivan)

Authorizing the County Manager to enter into an agreement with the Union County Economic Development Corporation for the purpose of providing procurement training/technical assistance to private businesses within the County of Union and associated general economic development services to the County of Union for the period of January 1, 2013 through December 31, 2013 in the amount of \$100,000.00.
