Section 1. Section 4.O of Ordinance No. 687-2009 entitled:

"BOND ORDINANCE TO AUTHORIZE THE MAKING OF VARIOUS PUBLIC IMPROVEMENTS AND THE ACQUISITION OF NEW ADDITIONAL OR REPLACEMENT EQUIPMENT AND MACHINERY, NEW AUTOMOTIVE VEHICLES, INCLUDING ORIGINAL APPARATUS AND EQUIPMENT, NEW ADDITIONAL FURNISHINGS, NEW COMMUNICATION AND SIGNAL SYSTEMS EQUIPMENT AND NEW INFORMATION TECHNOLOGY AND TELECOMMUNICATIONS EQUIPMENT IN, BY AND FOR THE COUNTY OF UNION, STATE OF NEW JERSEY, TO APPROPRIATE THE SUM OF \$43,371,808 TO PAY THE COST THEREOF, TO APPROPRIATE A STATE GRANT, TO MAKE A DOWN PAYMENT, TO AUTHORIZE THE ISSUANCE OF BONDS TO FINANCE SUCH APPROPRIATION AND TO PROVIDE FOR THE ISSUANCE OF BOND ANTICIPATION NOTES IN ANTICIPATION OF THE ISSUANCE OF SUCH BONDS."

adopted by the Board of Chosen Freeholders of the County of Union, New Jersey (the "County") on July 30, 2009, as previously amended by Bond Ordinance No. 699-2010 adopted on February 11, 2010 (the "Prior Ordinance"), is hereby amended to add the design and construction of the Galloping Hill Learning Center and various improvements to Galloping Hill and Ash Brook Golf Courses to the County golf course improvements authorized, and shall hereafter read as follows:

"[Section 4.]O. Department of Parks and Community Renewal, Division of Parks Administrative Support – (i) Design and construction of a new club house at Galloping Hill Golf Course, (ii) construction of workshop and storage buildings and open air truck garages at Galloping Hill Service Yard and (iii) the design and construction of the Galloping Hill Learning Center and various improvements to Galloping Hill and Ash Brook Golf Courses.

Down Payment Appropriated	\$ 206,000
Bonds and Notes Authorized	\$ 3,914,000
Period of Usefulness	20 years."

Section 2. The capital budget is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Clerk of the Board of Chosen Freeholders and is available for public inspection.

Section 3. This ordinance shall take effect twenty days after the first publication thereof after final passage.
