On-going case management will be provided to include 24 hours of on-call emergency support in conjunction with direct linkage to other community resources, such as Social Services: Welfare; WIB One Stop; Planned Parenthood; WIC; Social Security; Unemployment; Trinitas Hospital; and public transportation. In addition to case management, CAU will provide Support Services to help residents identify their current and future needs and strategically plan for their future. Services may include: life skills training; job readiness; educational training/assistance and linkage to UC Vocational School; health care linkages and money management training. On-going tracking and updating of efforts made by the participant toward self-sufficiency will be recorded and combined into monthly reports. Referrals will be made primarily from the NJ Division of Child Protection and Permanency (DCP&P)located in Union, Middlesex and Essex counties. DCP&P will be able to refer persons originating from UC back to UC for permanent supportive housing. CAU will also work closely and collaboratively with other existing agencies helping at-risk youth and their families. The project anticipates serving a minimum of eight individuals who are homeless with a documented disability. In addition, this project includes a budget to pay a portion of HMIS user group fees for the Union County CoC.

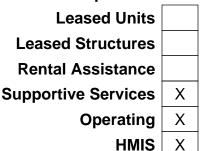
