THURSDAY, DECEMBER 14, 2017 MINUTES OF THE AGENDA SETTING MEETING

Vice Chairman Sergio Granados called the meeting to order at 7:01 pm. Freeholders Linda Carter, Angel G. Estrada, Christopher Hudak, Mohamed S. Jalloh, Bette Jane Kowalski, Alexander Mirabella and Vernell Wright were in attendance. Chairman Bruce H. Bergen was absent.

Also present were County Counsel Robert E. Barry, Esq., County Manager Alfred Faella and Clerk of the Board James E. Pellettiere, RMC, MPA.

The Prayer and Salute to the Flag were led by the Clerk of the Board.

The Statement of Compliance was read by the Clerk of the Board.

PRESENTATION FROM THE BOARD

A Resolution Presentation was made by Freeholder Mohamed S. Jalloh & Freeholder Vernell Wright to Dasia Edmund, of Burnett Middle School in Union, both recognizing her achievement and commending her on the publication of two books.

Freeholder Jalloh stated that every so often the Board has the opportunity to give stellar students recognition. He called upon Dasia Edmund AKA: Déjà Vu; a 12 years old student who sold 1,000 copies of her book "Uniquely Made-Girls Don't Play Football." The book was released when she was only 11. She wrote it after being told that she could not play football; and not only made the Pop Warner Football team, but played for 3 years. Deja Vu has a second book. She has been on with ABC 7, Channel 12, Rebel Radio and he believes is going to excel even more in years to come.

DeJaVu thamked Freeholders Jalloh and Wright for the recognition. She said her second book is called "Hair Chronicles," about how she hates to have her hair done. She said by writing these books, she wanted to inspire her peers and to show they could accomplish anything they put their minds to.

Freeholder Jalloh asked if there was anyone in the room that encouraged her, and she responded by saying it was her mom and sister.

Freeholder Jalloh congratulated her on a job well-done, and presented her with a Resolution acknowledging her success.

Déjà vu's mom said that Déjà vu was honored at the Devil's game and was the "Play Maker of the Game" and she is very proud of her daughter. She said her peers could relate to her, and she thanked the Board for supporting the young people.

OFFICE OF THE UNION COUNTY CLERK

Deputy County Clerk Nicole L. DiRado represented the Office of the Union County Clerk.

- 1. Authorizing the County Manager to make any and all purchases of goods and/or services required in the process of preparing and conducting an election to be provided by various vendors and to provide miscellaneous election services which might arise, in an amount not to exceed \$35,000 for the 2018 elections. (Chairman Bruce H. Bergen)
- 2. Authorizing the County Manager to enter into an agreement with Wisolmerski Associates, Inc., Boca Raton, Florida, for the purpose of providing technical support to the recording, indexing and accounting systems of the Office of the County Clerk for the contract period January 1, 2018 through December 31, 2018 in an amount not to exceed \$41,350.00. (Chairman Bruce H. Bergen)
- 3. Approving the 2018 Union County Clerk Five Year Plan. (Chairman Bruce H. Bergen)

Deputy County Clerk DiRado stated that in reference to item #3, it is a five year plan that is a Statutory Requirement and outlines the properties of the County Clerk's Trust Fund of the County Clerk's Office. The \$2 fee for documents that are recorded in Clerk's office is directed to the Trust Fund. She said the limitations of the Trust Fund is also Statutory for technical advancements, election matters, enhancements and education. She said a number of priorities are outlined in the plan, including back scanning so that documents can be viewed as far back as 1977 on the County's website and also title searches, education, conferences, and technical infrastructures. All servers purchased a few years ago were purchased through the Trust Fund.

Freeholder Estrada asked if there is a fee to view the records, and also asked if the entire document is viewable.

Deputy County Clerk DiRado stated that there is no fee for this service, and that they are all public documents. She stated that currently, the deeds and mortgages go back to the 1980s, and there are 3 more years that need to be scanned to be ready for the website, but anyone is able to visit the records room in the County Clerk's office. She said they are able to view the records back to 1857, free of charge. Adding, the staff will also show them how to use to view the records.

- 4. Authorizing the County Manager to enter into an agreement with Intersection, Secaucus, New Jersey for the purpose of providing design and advertising space for the Union County Votes App at NJ Transit train stations in advance of the 2018 Primary and General Elections in an amount not to exceed \$21,000. B and B Press has been responsible and a responsive vendor for these service, both by mail and providing services. She said this is a 2 year contract for the Primary and General elections for 2018 and 2019. The contract also includes provisions for 2 special elections, if needed.

Thomas Koundry represented the Office of the Prosecutor.

Freeholder Kowalski mentioned that the shelving in item #5 is pricey and asked for an explanation.

Mr. Koundry stated that there is currently a major problem with storage due to the influx in evidence submission of 30%. He stated that evidence needs to be kept for a long time and sometimes indefinitely. He said they currently have steel shelving with wooden tops and the new shelving will consist of automatic collapsible shelving, which will allow them room for over 70% storage space in one room and 80% in another room. He said the process is quite involved, but it will allow them a substantial amount of space.

Freeholder Kowalski asked if the life of the evidence will be extended. Mr. stated no, but it will extend the packaging of the life of the evidence with no crushing or damage, which inturn could extend the life.

Freeholder Estrada how much time would the new shelving allow.

Mr. Koundry stated that it was hard to determine, but based upon the current rate of submission, this could take them through many more years, but if there is an even more dramatic increase of submission, say 50 or 70%, then that will allow less time.

Freeholder Estrada asked if these are County dollars. Mr. Koundry stated no, they are forfeiture funds.

Department of Administrative Services

Michael Yuska, Director

Freeholder Carter asked for an explanation for item #3. Director Yuska stated that the past 15 years, the County has a diverse amount of equipment, so this allows the County to have we hire an underwriter to oversee the machines and to make sure that we are not overcharged. This way an expert knows to say we are being overcharged for all stuff that is not under warranty. We have a lot of the print shop machines on. We save money this way. It is for all our equipment that is not under warranty.

- 4. Authorizing the County Manager to renew the Cornerstone Behavioral Health Hospital-Medical Malpractice Policy, General and Professional Liability Umbrella Policy, and Excess Umbrella Liability Policy with Princeton Insurance for the period of December 15, 2017 through December 14, 2018 in an amount not to exceed \$110,881.02. Freeholder Mirabella was happy to see that this plan is being renewed. He said he is interested in the number of employees that are using the plan.

Director Yuska introduced Deputy Director Claudia Martins to provide the information. Deputy Director Martins stated that the last quarter from July 1st to September 30th, 487 employees used the program, which is 20% of our workforce (one quarter's worth). She said it was the highest of the quarters.

Freeholder Mirabella asked for a year to date amount and for last year's total when she is able to provide him with the numbers.

Faella interjected and stated that wellness is very important. He said they try to tell our employees to use this service before it turns into a crisis.

Ron Charles, Director

Freeholder Mirabella stated that he sees that many of the listed items are for religious services for the inmates, but asked why are there some from outside of the County.

Director Charles stated that there are volunteers from in-county, but some have been using some from outside of the county for the past 8 to 10 years. They understand the security of the institution and the rules that we have to govern. He said they are certainly not excluding anyone from this County, adding, if there is anyone else interested, they would look into it.

- 1. Authorizing the County Manager to enter into a contract with Deacon Michael DeRoberts, Mountainside, NJ to provide 5 hours of religious services and counseling per week for the Catholic inmates in the Union County Jail for the contract period January 1, 2018 through December 31, 2018 in an amount not to exceed \$3,418.80. (Chairman Bruce H. Bergen)
- 2. Authorizing the County Manager to enter into an agreement with Patricia Kane, Newark, New Jersey to provide 5 hours of religious services and counseling per week for the Islamic female inmates in the Union County Jail for the contract period January 1, 2018 through December 31, 2018 in an amount not to exceed \$3,418.80. (Chairman Bruce H. Bergen)
- 3. Authorizing the County Manager to enter into an agreement with Minister Richard Hogans, Linden, NJ to provide 10 hours of religious services and counseling per week for Protestant

Director Charles stated that item #6 is for an automation system of reports of the jail. He said currently, they do not have one and they still use the old fashioned pencil and paper. He said this system will manage the incident and grievance reports and will be accessible at a "push of a button," without taking days or hours of research.

DEPARTMENT OF ENGINEERING, PUBLIC WORKS & FACILITIES MANAGEMENT

Joseph Graziano, Director

Director Graziano gave a brief overview of item #4. He stated that the County will be receiving \$7 million as State aid and this is the first time in a very long time that they will be receiving such a substantial amount. He said they have been typically receiving \$3 to \$4 million. He said it is directly related to the gas tax.

Director Graziano said items 5,6,7 and 8 total \$2.2 million, which is normally \$1 million. He said item #9 is a new grant. The State is giving out \$30,000 in total and Union County is applying for \$750,000 through the TTF for any roads that lead to any ports or redistribution centers. He said this item is for Lower Road that runs towards Tremley Point in Linden where there are some bridges.

Director Graziano also gave a brief overview of item #11, stating this is for the Jury waiting room for the new stair tower for the court house. He said it will run through the existing jury room and will be done between the County staff and the outside contractor. He said the old jury room held 160 people with one form of egress and no restroom, and this one will be in the new annex for 260 people with restrooms, new hall, new ceilings, walls and trim. He said it will be done in-house, which will cut down costs.

Director Graziano stated that the County's in-kind will total \$314,000, which will be basically splitting the work with the contractor.

Chairman Granados commended Director Graziano and his staff for being able to keep the costs down.

Freeholder Estrada asked how much money was allocated for item #11. Director Graziano stated that this project number was tagged in engineering when they first started talking about it.

Freeholder Estrada asked about the Hillside Bridge. Director Graziano stated that the parts have been ordered for that bridge.

Freeholder Estrada asked about the Deer issue in Hillside? Mr. Dan Bernier stated that they looked at the topography and it is not an easy area to deal with as there is not enough of wooded space. He said a good first step would be is to have Hillside as for the County's support. He said Plainfield did just that and a program was just approved by Plainfield's City council and the program will start shortly ???????? and use archery equipment.

Freeholder Estrada asked why there is an \$853,000 Change order for item #9.

Director Sanchez explained that they have been working on the Change Order since April when they started to close out the Warinanco Park Ice Rink Renovation project. He stated that 84% of the \$853,000 is directly related to unforeseen conditions, like the unsuitable soils that were discovered during excavation to set the foundation for the building. Since there was already an existing building, they were unable to see to find this earlier. That alone was over \$200,000. He stated when they designed the building, they designed the electric up to code, however, PSE&G suggested that the electric system be upgraded because the load was not sufficient and a similar situation happened with the water supply. The water company suggested running a separate line from the street to run the potable water and fire suppressant systems separate from the chiller system.

Freeholder Estrada asked for the dollar breakdown.

Director Sanchez stated the electric is approximately \$224,000; unsuitable soil is \$190,000, \$146,000 is for the water, hot box, main and fire suppression. He stated that the changes caused delays for the contractor, as well.

Director Sanchez stated that this is in the best interest of the County and for the building to run more efficiently and long-term. He stated that because of these changes they ran into some delays. He said that he was able to negotiate with the contractor and they were able to lower his price to half.

Freeholder Estrada asked about the chimney in the middle of the floor and some painting that he previously asked to be addressed. Director Sanchez said it will be all taken care of and it is included in this amount.

Freeholder Kowalski asked about the usage of the new Center.

Director Sanchez stated that there has been a high volume of use. He said the work is being scheduled not to interfere with the public, which has become a challenge. He said they did not anticipate this type of volume. He said the 15, 16 and 17 year olds have been using it on the weekends, as they predicted.

Director Sanchez also noted that the contractor is the same contractor that is being used for the Ash Brook Golf Course renovations, so he is confident that he is dependable.
