THURSDAY, DECEMBER 21, 2017 REGULAR MEETING AGENDA

CALL TO ORDER

Chairman Bruce Bergen presided and called the meeting to order at 7:00pm.

ROLL CALL

Roll call showed Chairman Bruce H. Bergen, Vice Chairman Sergio Granados, Freeholder Linda Carter, Freeholder Christopher Hudak, Freeholder Mohamed S. Jalloh, Freeholder Angel G. Estrada, Freeholder Bette Jane Kowalski, Freeholder Alexander Mirabella and Freeholder Vernell Wright were in attendance.

Also present were County Manager Alfred Faella, County Counsel Robert E. Barry, Esq. and Clerk of the Board James Pellettiere.

PRAYER AND SALUTE TO THE FLAG

The Prayer and Salute to the Flag were led by the Clerk of the Board.

STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by the Clerk of the Board.

APPROVAL OF COMMUNICATION

Note and File

Chairman Bergen called for a motion to approve the Communications. On a motion made by Freeholder Mirabella and seconded by Freeholder Kowalski, roll call showed nine members of the Board voted in the affirmative.

PRESENTATION FROM THE BOARD

A presentation will be made by the Freeholder Board to Freeholder Vernell Wright, acknowledging her dedication and commitment to Union County residents.

Chairman Bergen called upon all Freeholders to join him for a special presentation to Freeholder Vernell Wight.

Chairman Bergen noted that this meeting would be the last meeting as Freeholder for Freeholder Vernell Wright. He stated that it was important to give her the recognition she is entitled to for the wonderful job she has done on the Freeholder Board.

Freeholder Carter and Freeholder Kowalski provided her with a bouquet of flowers.

Bruce Patterson, of Garwood, asked the Board to vote in the negative. He stated that last year the Board provided 5-6% increase in raises. He advised that raises should not have been in excess of 2% raises. He stated the various raises (2%-7%) of each of the Directors. He inquired why the Directors are deserving of these raises.

Seeing no other speakers, Chairman Bergen closed public comment.

FINAL READING STATEMENT

Freeholder Alexander Mirabella, Fiscal Subcommittee Chairman, will move Ordinance Number 790-2017 for Final Reading and authorize the Clerk of the Board to advertise same in accordance with the law.

On a motion made by Freeholder Mirabella and seconded by Freeholder Kowalski, Ordinance Number 790-2017 was moved for Final Reading and authorized the Clerk of the Board to advertise same in accordance with the law. Roll call showed nine members of the Board voted in the affirmative.

PUBLIC COMMENT PORTION

The meeting is open to the public for the purpose of commenting on Resolutions being offered for adoption only.

Anthony Esposito, of Roselle, commented on Resolution Number 2017-1102, inquiring if the hiring of a grant writing firm is necessary as opposed to using the talents of County employees.

Deputy County Manager Wagner advised that the hiring of this company was done through an RFP process, noting that none of the respondents were based in Union County. She advised further that the grant firm has been working for the County for a number of years. She advised that they successfully obtained \$6.5 million in grant fund in 2017, and another \$500,000 outstanding for awards to be announced in the spring of 2018. , 2017

Roy Carcia, Vice President of local union 1199 SEIU, representing approximately 150 workers at Aristacare at Delaire in Linden, thanked the Board (specifically Freeholder Estrada and Freeholder Hudak) for its quick response. He commended the Board for considering 2017-1115 and urged the Board to vote in favor of its passing. He advised that with their assistance, the workers can avoid a strike and the workers can focus on taking care of the families and residents that need their help.

Monalise Jeamoute, of Elizabeth, spoke on Resolution Number 2017-1115. She thanked the Board for their support.

Sandra Lopez, of Elizabeth, spoke on Resolution Number 2017-115. She thanked the Board for their support.

Gerda Dorley, of Linden, spoke on Resolution Number 2017-115. She thanked the Board for their support, noting that the workers do not have much needed health insurance.

John Burry, of Kenilworth, made comments or inquires relative to a number of resolutions. Regarding Resolution Number 2017-1112, he inquired if Union County was named in the lawsuit. He asked what services Schwartz, Simon, Edelstein & Celso will be providing. Relative to Resolution Number 2017-1052, he inquired as to how many employees will be getting the 2% raises and how many in total are eligible. Relative to Resolution Number 2017-1102, he inquired if Assemblyman Holley is still a principal at the firm. Relative to Resolution Numbers 2017-1102 and 2017-1103, he stated that governments shouldn't be using specialized grant writers to seek funding.

Relative to Resolution Number 2017-112, Chairman Bergen advised Schwartz, Simon, Edelstein & Celso was hired to provide advice to the Board relative to the Mind and Body project, not to any potential litigation.

Relative to Resolution Number 2017-1052, County Manager Faella stated that he did not have an exact number of employees, but noted that they are indeed all employees not represented by a collective bargaining unit.

Bruce Patterson, of Garwood, made comments or inquires relative to a number of resolutions. Relative to Resolution Number 2017-1035, he asked for an overview of the project. Relative to Resolution Numbers 2017-1048 and 2017-1050, he inquired as to the dollar amount. He also asked if this will be included in next year's budget and offset the tax burden. Relative to Resolution Number 2017-1051, he asked for an overview of the positions controls. Relative to Resolution Number 2017-1053, he inquired if the cost includes the buses. Relative to Resolution Number 2017-1060, he asked for an overview of the project, noting his cost. Relative to Resolution Numbers 2017-1060, he asked for an overview of the inquired as to who was the recipient of the funds. Relative to Resolution Number 2017-1061 and 2017-1062, he inquired why it was a two year contract. Relative to Resolution Number 2017-1091, he stated that there is no dollar amount listed and made comments relative to the principal of the company. Relative to Resolution Number 2017-1121, he inquired who read the tax plan.

Relative to Resolution Number 2017-1121, Chairman Bergen advised that there are very few Senators and Congressman that have read the details of the plan. Relative to Resolution Number 2017-1091, Director Yuska advised that they have been the broker for the past 27 months. He advised of the payment structure, noting that Horizon (the health insurance, prescription and stop-loss insurance broker) provides Acrisure a standard commission. He advised they receive \$16 per employee for the medical and prescription plans, a 10% commission on the \$1.5 million premium on the stop-loss insurance, \$43,000 for dental premium, 10% commission on the disability insurance. He stated that their total commission per annum is \$850,000. He advised that over the past 27 months, Acrisure has saved the County \$2.6 million in reducing fees, renegotiating contracts, and in ensuring the prescriptions are charged properly. He advised that initial projections are estimated at future savings between \$3 million to \$4 million over the next 36 months.

Relative to Resolution Number 2017-1078, County Clerk Rajoppi advised that the contract was awarded with a 2 year option. She noted they have proven themselves over the years.

Relative to Resolution Number 2017-1061, Parks Facilities Director Sanchez advised the amount is for the County's operational budget for the golf courses under KemperSports. Relative to Resolution Number 2017-1062, he advised that is for the County's operational budget for the Warinanco Sports Center under Sports Facilities Management. He noted that the Warinanco Sports Complex will now be a year-round facility.

Relative to Resolution Number 2017-1060, he stated that the contractor represents the lowest bidder (by \$80,000). He advised that the project includes a modern street scape look; inclusive of a bowl.

Relative to Resolution Number 2017-1051, County Manager Faella advised the position controls are for the Department of Human Services, the Office of the Sheriff, the Department of Economic Development, the Department of Public Works, and the Department of Corrections. He advised that the vast majority of them involve individuals taking on additional duties.

Relative to Resolution Number 2017-1048, Director Taylor advised that the County will be moving funds from an area of excess to an area in need of additional funds within the budget. Relative to Resolution Number 2017-1049, Director Taylor advised these cancellations of funds are for funding the County typically anticipates to provide to the State, however the State notified the County to cancel the transfer and simply provide the funds that are due. Relative to Resolution Number 2017-1050, Director Taylor advised the cancelation of funds concern funding from a previously adopted ordinance. She advised that it has no impact on the levy, but rather reduces the County's gross debt.

Relative to Resolution Number 2017-1035, Director Graziano advised that the project is necessary due to the new stair tower plans to go to the top floor. He advised it goes through the current jury room that only seats 160 people. He advised the new jury room will accommodate 260 people, and include new bathrooms and air-conditioning and plumbing. He noted that not only is this a low bidder, but that the County was doing approximately \$300,000 of in-kind work. County Manager Faella advised that this work is required by the State of New Jersey.

Maria Echavaria, of Elizabeth, asked for more details relative to Resolution Number 2017-1081. Tom Kaundry, of the Prosecutors Office, advised that the resolution authorizes the Prosecutor's Office to accept state funding for the Victims of Crime grant; which funds the County's sexual assault response team.

Dan Bernier, of Roselle, clarified that the past speaker did have a question relative to the shelving in Resolution Number 2017-1083.

Tom Kaundry, of the Prosecutor's Office, advised that the shelving would replace static shelving for both the CDS and Biology section. He advised that these new shelving is aimed at saving space through mechanical assist system that collapses on top of each other. He advised that by using this new system, they will gain approximately 70% more space. He advised that evidence guidelines dictate how long items have to be saved.

Seeing no other speakers, Chairman Bergen closed public comment on resolutions being offered for adoption.

PUBLIC COMMENT PORTION

This meeting is open to the public comment on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Phillip, of Rahway, made comments on behalf of Citizens Going Forward. He read a statement relative to funding request, detailing its mission statement, and advised of a number of the organization's endeavors.

Freeholder Carter left the meeting.

Chris Ellison, of Elizabeth and of Citizens Going Forward, thanked the Board, Director Zuber, Ellen Chase, Sean Faughnan, Rhoshana Crosby (parks department), Captain Black (county sheriff office), and the Union County parks maintenance employees. He received a proclamation from Senator Booker (relative to Citizens Going Forward) and read it aloud.

Brendan Bernier, of Roselle, thanked the Board for pulling the Ordinance pertaining to the Mind and Body project. He advised the borough needs to go back to the drawing board and then potentially go before the Freeholders in the future.

Anthony Esposito, of Roselle, inquired as to the insurance benefits provided to the county employees, and questioned how it is managed. He questioned if the County has examined the potential of being self-insured. He made comments relative to the GOP Tax Plan that caps the deduction at \$10,000 in property taxes, noted that most County residents are above the tax cap.

Chairman Bergen advised that the County is in fact self-insured, and noted the Director's comments relative to the County's stop-loss plan.

Denise Wilkerson, of Roselle, offered her congratulations to Freeholder Wright for her dedicated service to the community. She stated she was pleased to see the Ordinance was pulled and questioned if the Board would assure the public that the project wouldn't move forward until the Borough re-assesses the project.

Chairman Bergen advised that the Ordinance that was introduced (in 2017) will not move forward and will essentially "die" for not being adopted in the same year as it was introduced. He advised that the Board intends to revoke the Ordinance passed earlier in the year which guaranteed the other portion of the project; clarifying that there will be nothing pending from the county relative to the project. Bruce Patterson, of Garwood, offered his thanks to the Board for the Kids Recreation Grant in the amount of \$55,000. He thanked Freeholder Wright for her service. He made comments relative to the upcoming budget cycle; focusing on funds returned to the State of New Jersey, UCIA financing as it relates to the Mcenroe Report, the Infrastructure Grant, county surplus, and the request to cut the budget.

Chairman Bergen asked Director Taylor to clarify the \$24 million in grant funds to be returned to the State of New Jersey (Resolution Number 2017-1049).

Director Taylor advised that the State assumption appropriation equates to \$31 million. She advised that the revenue equates to \$25 million. She advised that the State essentially says the County has to transfer over the excess (the difference between the appropriation and the revenue), which equates to \$5.2 million. She advised that the State notified the County to transfer the difference, rather than the entire \$31 million and then receive the \$25 million. She explained this is the reason she is cancelling the \$24 million from the program. She further advised that this transfer represents a net zero effect on the County's budget.

Chairman Bergen asked Director Taylor to confirm that the County is not returning money, but rather this is solely an accounting mechanism.

Director advised that was correct. She reminded the Board the State did the same thing last year with the County's DYFS funding.

Director Taylor offered to make a clarification relative to the proceeds from the sale of Runnells Specialized Hospital; noting that as of the end of the 2017, the County has \$15.4 million. She added that those funds are set aside as a reserve on the County's balance sheet.

Seeing no other speakers, Chairman Bergen closed public comment.

FREEHOLDER REPORTS AND COMMENTS

Freeholder Hudak made comments relative to the GOP Tax Plan; stating that New Jersey receives 74 cents on the dollar and noted one of the equitable tools used was the deduction on state income and property taxes (as they are higher in New Jersey). He stated that the GOP Tax Plan is a blatant grab of wealth from one part of the country to another.

Freeholder Hudak made comments relative to the County's infrastructure program; adding that he is proud of the Board for finding an innovative measure to stretch local tax dollars where the County has seen a consistent decrease in aide.

Freeholder Hudak made comments relative to the new jury room (as he served as a juror). He made comments relative to the Roselle Mind and Body project, stating that he was disappointed as the school project is not going to happen (at this point). He added that he hopes the Board of Education and the Borough work together on revisiting the plan.

Freeholder Hudak congratulated Freeholder Wright on her service as Freeholder. He congratulated Chairman Bergen on a successful two-year chairmanship. He wished everyone a happy holiday.

Freeholder Wright made comments relative to discounted loans (up to \$50,000) for women business owners.

Freeholder Kowalski thanked Freeholder Wright for her service, and thanked her family for attending the evening's meeting. She thanked Chairman Bergen for his leadership over his tenure over the past 2 years. She thanked the residents from Elizabeth, Linden and Roselle for attending the meeting.

Freeholder Kowalski made comments relative to the County's Aging Services Kiosk event on December 27, 2018. She noted that on Friday, December 22, 2018 the County was holding its annual Holiday Sing-A-Long around the Christmas Tree in the Courthouse . rotunda. Freeholder Kowalski wished all a happy, healthy and safe holiday.

Freeholder Estrada wished all a happy holiday.

Freeholder Mirabella made comments relative to the Union County Relations Commission and their acceptance of nominations for the 2018 Unity Achievement Award; noting that the Unity Achievement Awards recognize volunteerism, public service that promotes cultural diversity, community relations and human rights.

Freeholder Mirabella congratulated County Manager Faella, Deputy County Manager Wagner, all the departmental directors and county employees on a very good year. He noted the hard work that the Board gets credit for, is a direct result of the hard work of the County's employees. He thanked Freeholder Wright for her service, noting that she was his children's favorite freeholder (audience laughed). He commended Chairman Bergen on successful two-year tenure as Chairman, noting that he was always fair and respected the opinions of all the members on the Board.

County Counsel Barry wished Freeholder Wright the best on all future endeavors. He congratulated Chairman Bergen on a successful year.

County Manager Faella thanked the Board for their support. He thanked his department heads for all their support. He told Freeholder Wright that she was a person of high character and that it was an honor to work for her. He congratulated Chairman Bergen for his two years as Chairman and stated that their working relationship was special. He wished all residents a happy holiday and a healthy new year.

Vice Chairman Granados wished all a happy holiday and a happy new year. He invited the Board to join him in presenting Chairman Bergen with a small gift in recognition of his leadership as Chairman.

Chairman Bergen thanked his colleagues. He stated that any success over the past two years has been a byproduct of a team effort.
