

UNION COUNTY BOARD OF CHOSEN FREEHOLDERS

THURSDAY, OCTOBER 19, 2017 AGENDA SETTING MEETING AGENDA

CALL TO ORDER

Chairman Bruce H. Bergen presided over the meeting and called the meeting to order at 7:02pm.

ROLL CALL

Roll call showed Chairman Bruce H. Bergen, Vice Chairman Sergio Granados, Freeholder Linda Carter, Freeholder Angel G. Estrada, Freeholder Mohamed S. Jalloh, Freeholder Alexander Mirabella and Freeholder Vernell Wright were present, with Freeholder Christopher Hudak and Freeholder Bette Jane Kowalski absent.

Also present were County Manager Alfred J. Faella, County Counsel Robert E. Barry, Esq., and Clerk of the Board James E. Pellettiere.

PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

PRESENTATION TO THE BOARD

A presentation will be made by Matt Mathan to the Board highlighting the new "County Parks Trails App."

Chairman Bergen called upon Deputy County Manager Wagner to lead a presentation to the Board.

Deputy County Manager Wagner advised the Board that County Manager Faella had requested her to oversee the investigation of a group of trails at the Watchung Reservation. She advised the Board that the County had begun the process of developing a "Trails App" for smart phones. She advised the Bureau of GIS had done an excellent job assisting in the process. She provided the Board with an overview of the app functions; inclusive of the ability for the public to report any hazards they may have come upon on the 47 miles of trails. She introduced Matt Mathan of the Bureau of GIS.

Mr. Mathan, with the assistance of Danny Lazano, made a detailed presentation to the Board on the applications' capabilities.

Vice Chairman Granados made comments relative to the public safety component the application provides to the public and the County. He made suggestions relative to adding contact information to the Parks Department and the Police Department.

October 19, 2017

Freeholder Estrada inquired to the cellular reception in the Watchung Reservation.

County Manager Faella interjected, stating that there is one area in the Watchung Reservation that is considered a "dead-zone", but that in general, there is adequate reception in the Reservation.

Chairman Bergen commended Mr. Mathan on the work with the application.

OFFICE OF THE UNION COUNTY SHERIFF

Joseph Cryan, Sheriff

Sheriff Cryan introduced his resolution; noting the program has been a success in many ways with over 200 employees utilizing the program.

1. Authorizing the County Manager to award a contract to A&A Fitness, Inc. d/b/a The Max of Springfield, Union, New Jersey, to provide physical and nutritional administration services to the Union County Sheriff's Office and County of Union employee participants for a period of 12 months from July 1, 2017 through June 30, 2018 for a total not to exceed \$40,000.00. (Chairman Bruce H. Bergen)

Vice Chairman Granados stated that he has seen the evidence of employees losing weight, feeling better and being more productive in the workplace as a result of the program.

Freeholder Carter noted that the contract is from July (meeting date October, 2017) and asked if this contract was obtained through an open and fair process.

Sheriff Cryan stated that this contract was obtained in an "open and fair" process through resolution 2016-325. He advised County Counsel has authorized this process.

Chairman Bergen congratulated the Sheriff on the success of this program.

DEPARTMENT OF ENGINEERING, PUBLIC WORKS & FACILITIES MANAGEMENT

Joseph Graziano, Director

1. Amending Resolution Number 2014-817, a Shared Service Agreement with the City of Summit for the replacement of the Locust Drive Culvert near Tulip Street over Stream 3-51 (Su105) and to provide for reimbursement to the County of Union for the costs associated with the design and relocation of the sanitary sewer line, to provide for additional reimbursement costs from the City to the County of Union in the amount not to exceed \$103,353.00 for a new reimbursement cost to the County of Union in an amount not to exceed \$201,453.00. (Union County Engineering Project Number 2010-005C) (Freeholder Bette Jane Kowalski)

2. Authorizing the County Manager to award the proposed contract obtained through advertised public bidding in accordance with the Local Public Contracts Law, NJSA 40:A11-1 et seq to: Department of Engineering, Public Works & Facilities, Division of Facilities Management with Paul's Electronic Maintenance, Inc., dba SBP Industries, South Plainfield, NJ (BA#62-2017) for the purpose of providing Emergency Generator Services for the Department of Engineering, Public Works & Facilities Management, Division of Facilities Management for twenty-four (24) consecutive months with the provision for one (1) twenty-four (24) month optional extension, contract amount not to exceed \$123,600. (Freeholder Bette Jane Kowalski)

Freeholder Estrada inquired if this is for a 24 month period.

Director Graziano advised that this contract is to maintain and provide all testing of the County's twenty emergency generators.

3. Authorizing the County Manager to award the proposed contract obtained through advertised public bidding in accordance with the Local Public Contracts Law, NJSA 40A:11-1 et seq: Department of Engineering, Public Works & Facilities Management; Morton Salt, Inc. Chicago, Il. for the purpose of providing Rock Salt for a twelve month (12) contract in the amount of \$488,800.00. (Freeholder Bette Jane Kowalski)

Freeholder Estrada inquired how much was spent last year on this contract.

Director Graziano advised that last year's bid was \$699,000; advising that the contract called for \$69/ton, whereas this year the contract is 448/ton. He added that all of the County's domes are full.

Freeholder Estrada asked if this was a "not to exceed" amount.

Director Graziano advised that it was.

4. Resolution granting permission to the Township of Berkeley Heights for the closing of Springfield Avenue from the intersection of Snyder Avenue to Plainfield Avenue on Saturday, December 2, 2017 from 2:00 p.m. to 11:00 p.m. for the Township's annual Winter Walk and Tree Lighting Event. Also granting permission to hang a banner across Springfield Avenue and Plainfield Avenue from November 10, 2017 through December 4, 2017. (Freeholder Bette Jane Kowalski)

Freeholder Mirabella inquired if this resolution has anything to do with Ben Franklin.

Director Graziano advised that it did not.

5. Resolution granting permission to the Township of Scotch Plains to close Park Avenue, between Bartle Avenue and East Second Street/Westfield Avenue from 2:30 p.m. until 5:00 p.m. on Saturday, October 28, 2017 (rain date Sunday, October 29, 2017) for the Family Fun Trunk or Treat festival. Also, granting permission to close Park Avenue from Front/Bartle Avenue and Westfield Avenue/East Second Street on Sunday, December 3, 2017 between the hour of on or about 1:30 p.m. to on or about 5:00 p.m. for the annual Holiday Tree Lighting Ceremony. (Freeholder Bette Jane Kowalski)

DEPARTMENT OF FINANCE

Bibi Taylor, Director

1. Resolution determining the form and other details of not to exceed \$44,250,00 refunding bonds of the County of Union, New Jersey, to accomplish the refunding on the terms required by the Local Finance Board pursuant to N.J.A.C. 5:30-2.5 and consistent with the refunding provisions of the Internal Revenue Code of 1986, as amended, and to provide for the sale and delivery of such bonds to the underwriters. (Freeholder Alexander Mirabella)

Freeholder Carter asked for additional information.

Director Taylor advised that the resolution allows the County to refund an aggregate principle amount of \$44,250,000 to achieve a savings of \$2,009,803. She advised that the final pricing of the refunding bonds would be done at the point of sale. She added the County anticipates a total savings of 4.63%. She advised that the state statute requires a savings of at least 3% in savings.

Chairman Bergen added that this is essentially like "refinancing the bonds" at a lower interest rate.

Director Taylor added that it maintains the same amortization schedule. She also added that this process allows the County to take advantage of market conditions to save money.

Chairman Bergen asked for a motion to return to the Agenda Meeting. On a motion made by Freeholder Mirabella and seconded by Freeholder Carter, roll call showed seven members of the Board voted in the affirmative, with Freeholder Hudak and Freeholder Kowalski absent.

County Counsel advised that there was nothing to report as a result of discussion in Executive Session.
