CALL TO ORDER

Chairman Bruce H. Bergen presided over the meeting and called the meeting to order at 7:05pm.

ROLL CALL

Roll call showed Chairman Bruce H. Bergen, Vice Chairman Sergio Granados, Freeholder Linda Carter, Freeholder Angel G. Estrada, Freeholder Mohamed S. Jalloh, Freeholder Bette Jane Kowalski, Freeholder Alexander Mirabella, and Freeholder Vernell Wright were present, with Freeholder Christopher Hudak absent.

Also present were County Manager Alfred J. Faella, County Counsel Robert E. Barry, Esq., and Clerk of the Board James E. Pellettiere.

OFFICE OF THE UNION COUNTY CLERK

County Clerk Rajoppi provided the Board with an overview of her resolution request.

There were no questions or comments by the Board.

1. First Assistant Prosecutor Tim Isenhour represented the Office.

Michael Yuska, Director

Bernstein & Associates, LLC, Warren, New Jersey, special counsel for Labor and Personnel matters, to increase the amount of award for legal services in the amount of \$35,000 for a total amount not to exceed \$85,000. Freeholder Mirabella asked the Director to elaborate as to the nature of the increase.

Director Yuska advised that the Bernstein firm is handling four on-going disciplinary appeals; noting that they probably will continue to bill through the end of the year, and feels this amount should cover the expenses.

DEPARTMENT OF ECONOMIC DEVELOPMENT

Amy Wagner, Deputy County Manager/Director

1. Authorizing the County Manager to execute a contract award with The DRS Group, Springfield, New Jersey, through BA# UCCP 28-2015, for the purpose of On-Call document digital imaging and scanning services to be utilized for the Bureau of GIS Online Crisis Mitigation Plan through December 31, 2017, in an amount not to exceed \$200,000. (Chairman Bruce H. Bergen)

Freeholder Kowalski asked the Director to provide an overview of this resolution.

Deputy Director Wagner advised that this resolution pertains to the on-line crisis mitigation plan. She advised that they will scan the plans for all the schools throughout the County. She advised that, through Chairman Bergen's initiative, the County is opening up the service for any other public buildings. She added that, to date, the County has heard from 17 of the 21 municipalities in the County, with two more sending their response shortly.

Freeholder Jalloh inquired how this system is different from the digital imaging system that Public Works utilizes.

Director Graziano advised that the Public Works digital imaging is done from above to realign GIS mapping, noting that they are required to update every five years. He stated that this GIS system is a completely different system used for crisis mitigation.

Freeholder Jalloh inquired if the services can be done by the same company, and if they could would it be cost-effective.

Director Graziano stated that the service is definitely different.

Freeholder Mirabella stated that he wholeheartedly supports this resolution and complimented Matt Mathan, of the Union County GIS, for the excellent work he provides both Director Graziano and Deputy County Manger Wagner.

County Manager Faella announced that Matt Mathan and the County's GIS rolled out the new park trails application earlier today, noting that a public presentation would be provided to the Board at a later date.

DEPARTMENT OF ENGINEERING, PUBLIC WORKS & FACILITIES MANAGEMENT

Joseph Graziano, Director

Director Graziano asked for the Board's indulgence to add a resolution relative to a concurring resolution to a "road closure/banner' request in Plainfield.

1. Authorizing the County Manager to award a Professional Engineering Service Contract, through a Request for Proposal (RFP) process, to Remington Vernick & Arango Engineers, of Secaucus, New Jersey to provide Engineering Design Services, Construction Administration and Inspection Services for the 2018 Resurfacing Project for an amount not to exceed \$306,643.00. (Union County Engineering Project Number 2016-045) (Freeholder Bette Jane Kowalski)

Vice Chairman Granados inquired as to the amount of last year's Road Resurfacing Project.

Director Graziano advised that it was roughly the same, noting that there were 20+ miles of roads. He added that each project ranges from \$275,000-\$350,000.

2. Amending Resolution Number 2015-993 adopted on December 3, 2015 authorizing the County Manager to enter into an Agreement with the New Jersey Department of Transportation (NJDOT) for the Gordon Street Bridge, Roselle/Roselle Park, County of Union, New Jersey to accept additional funding in the amount of \$142,420.00 from NJDOT for Union County Engineering Project Number 2011-051 (TTF SWAP AGREEMENT NO. 2014-DT-BLA-FEP-206) for a total agreement not to exceed \$1,021,389.00. Freeholder Estrada inquired about the resolutions pertaining to the Gordon Street Bridge in Roselle Park, asking the Director for an update on the project.

Director Graziano advised that Department of Transportation has expanded the project. He advised that they are expecting to go out for construction in the Fall of 2018.

There was a discussion relative to the "structural deficiency" of the bridge. County Engineer Mineo advised the Board that the Bridge is safe to use by cars. He stated that he would provide the Board with a list of all "orphan" bridges in Union. Director Graziano added that the State continues to conduct their inspections, and if any safety concerns arise, the County would close the bridge.

Director Graziano advised that the Water Company had some concerns with an unforeseen waterline issue relative to the vibrations of the bridge and the sheet piling. He added that the Governor's shutdown added to the delay. He also noted that there was a design change to allow for one lane to be left open during construction. He stated that he expects the project to be completed by December 1, 2018.

Freeholder Kowalski advised that she would have an additional resolution from the Parks, Public Works and Facilities committee to add to the Regular Meeting. She advised that she would also have a condolence resolution to add as well.

Chairman Bergen advised that he may have additional advisory board appointments to add to the next Regular Meeting agenda.

EXECUTIVE SESSION

To the extent known, the following item will be discussed in Executive Session:

Attorney-Client privileged communications and discussions relative to the matter of Esposito v. Borough of Roselle, et al and discussions relating to the on-going negotiations of the County Guarantee Agreements on the Mind and Body Project between the County of Union and the Union County Improvement Authority.

County Counsel Barry stated that pursuant to provisions of the Open Public Meetings Act, a public body may enter into Executive Session for the purpose of discussing certain enumerated subjects.

He stated that this Board wished to enter into Executive Session for the purpose of discussing Attorney-Client privileged communications and discussions relative to the matter of Esposito v. Borough of Roselle, et al and discussions relating to the on-going negotiations of the County Guarantee Agreements on the Mind and Body Project between the County of Union and the Union County Improvement Authority.

He stated that the minutes of the Executive Session shall be separated from the minutes of the Open Public Session and that the minutes of the Executive Session, redacted as appropriate and necessary, shall be available in approximately 30 days. He stated that the Clerk of the Board shall retain the original minutes until such time as the confidential limitations have been removed, at which time they shall be made available.

He stated that upon affirmative vote of the majority of the members present, the Board may retire Executive Session and upon the Board's return, as it is an Agenda Meeting, it will not take formal action on the matters discussed.

Freeholder Mirabella mentioned that as per the Fiscal Committee meeting, he would have a resolution to add to the next Regular Meeting.

Chairman Bergen asked for a motion to enter Executive Session. On a motion made by Freeholder Carter and seconded by Freeholder Kowalski, roll call showed seven members of the Board voted in the affirmative, with Freeholder Jalloh abstaining and Freeholder Hudak absent.

Chairman asked Freeholder Jalloh if he will be recusing himself from Executive Session, to which Freeholder Jalloh said that he would be recusing himself from the discussion.

Chairman Bergen asked for a motion to return to the Agenda Meeting. On a motion made by Freeholder Mirabella and seconded by Freeholder Carter, roll call showed seven members of the Board voted in the affirmative, with Freeholder Hudak and Freeholder Jalloh absent.

County Counsel advised that as a result of discussion in Executive Session, there will be an additional resolution to add to the Regular Meeting relative to a consent resolution, also known as a "Chapter 56" resolution, for the Borough of Roselle's project for the construction of a community center and library.

ADJOURNMENT

Chairman Bergen asked for a motion to adjourn. On a motion made by Freeholder Mirabella and seconded by Vice Chairman Granados, a voice vote showed seven members of the Board voted in the affirmative, with Freeholder Jalloh and Freeholder Hudak absent. The meeting was adjourned at 8:40pm.
