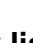

Homefirst Interfaith Housing and Family Services, Inc. (Homefirst), a non-profit organization was founded in 1986 in Union County, New Jersey provides a broad continuum of housing in conjunction with social service. The mission of Homefirst is to deliver permanent solutions to homelessness by providing transitional and permanent housing, homeless prevention assistance, and support services to strengthen families and build community. Homefirst has assisted homeless and disabled individuals and families in our CoC, Sponsor Based Rental Assistance (SRA) and Permanent Supportive Housing Program (SHP) projects since 1995. In 1995, Homefirst, as a NJ-DCA and HUD certified Community Housing Development Organization (CHDO), embraces the national "Housing First" model that addresses the homeless and affordable housing crisis for those with special needs and disabilities. The cornerstone of the model and Homefirst's philosophy is to provide housing first to create a stable foundation for each household and then offer family support social services. The Homefirst CoC Housing Program has been developed within a scattered site model and provides comprehensive supportive social services in order to promote personal development, health, wellness and self-empowerment. Through this Renewal Application, Homefirst provides permanent supportive housing for homeless persons with disabilities as defined by the U.S. Department of Housing and Urban Development (HUD) in conjunction with comprehensive supportive social services. Homefirst's staff provide Case Management supportive services including: information and linkages to community services including medical, mental health, addiction treatment, legal, and access to mainstream benefits, financial literacy, employment readiness, and a range of support services including parenting, cooking, health, wellness, self-advocacy, nutrition, and enrichment recreational activities. A Service Plan is developed each year when the staff and program participant together develop goals and action steps to achieve goals. The Homefirst social service staff has broad experience and knowledge mainstreaming clients to appropriate and needed services. The Homefirst staff works collaboratively with other county agencies to ensure that entitlements and services are received. All family support case management plans are reviewed on a yearly basis to ensure that the goals are being met. 
