

# UNION COUNTY BOARD OF CHOSEN FREEHOLDERS

# THURSDAY, FEBRUARY 15, 2018 AGENDA SETTING MEETING MINUTES

#### CALL TO ORDER

Chairman Sergio Granados presided over the meeting and called the meeting to order at 7:05pm.

#### ROLL CALL

Roll call showed Chairman Sergio Granados, Vice Chairman Bette Jane Kowalski, Freeholder Bruce H. Bergen, Freeholder Linda Carter, Freeholder Angel G. Estrada, Freeholder Angela Garretson, Freeholder Christopher Hudak, Freeholder Mohamed S. Jalloh and Freeholder Alexander Mirabella were present.

Also present were County Manager Alfred J. Faella, County Counsel Robert E. Barry, Esq., and Clerk of the Board James E. Pellettiere.

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

# PRESENTATIONS FROM THE BOARD

A Resolution Presentation will be made by Chairman Sergio Granados and Freeholders Christopher Hudak and Alexander Mirabella to Peter Capodice, Superintendent of Schools and various students of the Union County Vocational-Technical School, as the Union County Board of Chosen Freeholders designates the month of February, 2018 as National Career and Technical Education (CTE) Month in Union County.

A Resolution Presentation will be made by Chairman Sergio Granados and Freeholders Christopher Hudak and Alexander Mirabella to Peter Capodice, Superintendent of Schools and Bonnie Baldasare, FFA Advisory and Horticulture Instructor as the Union County Board of Chosen Freeholders designates the week of February 17, 2018 through February 24, 2018 as the "National FFA Organization Week" throughout the County of Union.

Chairman Granados noted that the Union County Vocational-Technical schools continually are ranked in the top of the nation. He commended Superintendent Capodice for his leadership and the teachers for their tireless work, and most importantly, to the students for always striving to be the best.

Vice Chairman Kowalski thanked the Vocational-Technical School Superintendent, school staff, and students for their dedicated work. She stated their efforts make the Board proud, and knows they (the Board) can expect great things to come.

Freeholder Mirabella noted that twenty years ago he was a part of the discussion relative to the vision of what opportunities the Vocational-Technical schools could provide students of the County. He stated that he was proud to see the development of the complex and the annual achievements of the students.

Superintendent Peter Capodice noted that the school and its students were present to recognize both "National Career and Technical Education (CTE) Month" and "National FFA Organization Week."

Superintendent Capodice made comments relative to Freeholder Mirabella's remarks relative to the vision established twenty years ago, noting its student body expansion from 200 share-time students to the current 1,600 full-time students and 600 share-time students. Superintendent Capodice called upon the principals from the various schools, who in turn introduced student representatives, to join him to receive the proclamation. The Board presented the students with the proclamation and a photo was taken.

Chairman Granados acknowledged former Governor James McGreevey in the audience as his daughter Jacqualine was one of the students participating in the ceremony. He thanked Governor McGreevey for his work as Governor and his continued work with prisoner re-entry within Union Couty.

Superintendent Capodice introduced Bonnie to introduce two students of the FFA program; Colleen Clark (President) and David Tahoon. Superintendent Capodice made comments relative to how FFA and agricultural education provides a strong foundation for the youth of America and the future of food, fiber and natural resource systems. He made comments as to how the FFA program promotes peer leadership, personal growth and career success within the student members, noting that the FFA program ensures a steady supply of young professionals to meet the growing needs in science, business and technology of agriculture. The Board presented the students with the proclamation and a photo was taken.

A resolution presentation will be made from Chairman Sergio Granados and Freeholders Christopher Hudak and Alexander Mirabella to the St. Patrick's Day Parade Committee in recognition of the annual Union County St. Patrick's Day Parade; congratulating the following Union County St. Patrick's Day Parade Committee 2018 honorees: John McParlan, Grand Marshal; Pamela Joyce-Adjutant; Kathleen Holmes-General Chairwoman.

Freeholder Mirabella noted that he was a quarter Irish, along with Freeholder Hudak and Freeholder Jalloh. Freeholder Estrada noted that he has 12% as indicated by ancestry.com. Freeholder Mirabella introduced the leadership of the Union County Parade Committee. They (committee) entered the room to bagpipes.

Freeholder Mirabella introduced their 2018 Grand Marshal, John McParlan.

Mr. McParlan stated the honor of Grand Marshall is extended to his business (Molly McGwuires in Clark), his employees and the customers that patron his business. He thanked the Board for their support over the years and invited all to join in the festivities on March 10, 2018, noting you don't have to be Irish to enjoy the day.

General Chairwoman Kathleen Holmes thanked the Board for supporting the Parade Committee over the past 22 years. She thanked the committee for all their work over the past year.

Chairman Granados (jokingly) stated that he believed that the Portuguese Parade was the best parade in Union County, admitting that the Union County St. Patrick's Day Parade is by far the biggest and best parade in Union County. He thanked the Committee for all they do within the community. The Board presented them with a proclamation and a photo was taken.

# Michael Yuska, Director

- 1. Authorizing a payment to Beckerman & Company, County General Insurance Agent of Record, to obtain the Equine Mortality Policy with Great American Assurance Company, Cincinnati, OH from February 24, 2018 through February 23, 2019 in an amount not to exceed \$1,952.00. (Chairman Sergio Granados)
- 2. Amending Resolution Number 2017-1093 to reflect a name alteration only from ComPsych to FMLASource, a part of ComPsych Corporation, at the same address 455 N. Cityfront Plaza Drive, Chicago, IL. (Chairman Sergio Granados)
- 3. Amending Resolution Number 2016-1021, a contract awarded to Delta Dental of New Jersey, Inc., to increase the amount by \$9,511 to a not to exceed figure of \$1,509,511.00 due to unforeseen increased usage in late 2017. (Chairman Sergio Granados)

Freeholder Carter asked the Director to provide an explanation on his third resolution.

Director Yuska advised the County contracts with three separate dental companies: Healthplex, Delta, and Flagship. He advised that this year more people have used Delta than the other two estimates. He advised that while they were requesting an increase of \$9,000 for Delta, that costs for Healthplex were decreased by approximately\$68,000. He noted that they would adjust the figures to better represent who they (employees) were using.

Freeholder Estrada asked if the County is self-insured as it relates to dental, and questioned the reason for the increase.

Director Yuska advised that the County is not self-insured for dental, and noted that the increase is a result of the billing from Delta. He advised that the County's total cost for dental was \$1.8 million. He advised that they were \$9,000 over on Delta contract, but \$61,000 under the other two contracts. He also advised that the employees pay million dollars back through their contributions.

# DEPARTMENT OF ECONOMIC DEVELOPMENT

#### **DEPARTMENT OF HUMAN SERVICES**

Debbie-Ann Anderson, Director

1. Authorizing the County Manager to award a contract to Mutual of America, Parsippany, New Jersey, in an amount not to exceed \$114,896.17 for the period of July 1, 2017 through June 30, 2018 to implement an employee 401(a) benefits plan for county employees not covered under the Public Employee Retirement System (PERS). (Vice Chairman Bette Jane Kowalski)

Chairman Granados asked the Director to elaborate on her first resolution.

Director Anderson advised that the Workforce Board has its own pension, noting that it was established roughly thirty years ago. She advised that this resolution is a renewal contract for approximately 19 staff members, representing approximately \$114,000 towards their pension costs. She deferred historical fact to the County Counsel to elaborate.

County Counsel Barry advised this pension program was established in the 1980's, and grew out of CETA and was federally funded. He advised that the employees who worked under the CETA funding program were not eligible to participate in the state pension PERS. The Board created this plan (and provided the payments) to provide equal benefits for those employees so that they were comparable to other county employees within the PERS system.

Freeholder Estrada asked if the name was "Mass Mutual of America".

Chairman Granados asked Director Taylor to address the question.

Director Taylor advised Mutual of America is the company that manages the employees under JTPA funding, noting that the Mass Mutual is for our 527 plan (deferred compensation) for the County employees.

- 2. Authorizing the County Manager to award a contract to Mutual of America, Parsippany, New Jersey, in an amount not to exceed \$20,424.00 for the period of July 1, 2017 through June 30, 2018 for the provision of Group Life Insurance with Group Accidental Death and Dismemberment Plan for employees not covered under the Public Employee Retirement System (PERS). (Vice Chairman Bette Jane Kowalski)
- 3. Amending Resolution 2018-106, 2018 Youth Services Commission Comprehensive Spending Plan, to adjust accounts and reallocate funds in the UC Division of Youth Services crisis intervention services contract with no change in total dollars as specified on the amended Spending Plan; no change in the total spending plan amount; no other changes to the terms of this spending plan. (Chairman Sergio Granados)
- 4. # DEPARTMENT OF PARKS AND RECREATION

There were no questions or comments by the Board.

1. Authorizing the County Manager to enter into agreement, through the use of the Educational Services Commission Contract #MRESC 14/15-60 and 14/15-62 16-8, with Nickerson Corporation, of Bayshore, New York for the purchase and installation of the bleachers seating component parts for the rehabilitation of the bleachers at Warinanco Sports Center, in the amount not to exceed \$125,000.00. (Chairman Sergio Granados)

County Manager Faella advised the resolution will provide for handicapped accessible bleachers, which coincides with the County's initiative to have all parks handicapped accessible.

2. Authorizing the County Manager to award the proposed contract obtained through advertised public bidding in accordance with the Local Public Contracts Law, NJSA 40A:11-1 et seq: Parks and Recreation, Division of Recreational Facilities; East Coast Sod and Seed, LLC of Pilesgrove, NJ, for the purpose of providing sod for the period of 24 months, in the amount of \$104,000.00. (Chairman Sergio Granados)

# **DEPARTMENT OF PUBLIC SAFETY**

# Andrew Moran, Director

- 1. Authorizing the County Manager to enter into an agreement with Petro-Dragon for the purchase of hose couplings and adapters for the UASI Neptune System in an amount not to exceed \$29,232 utilizing 2015 Urban Area Security Grant Funding. (Freeholder Mohamed S. Jalloh)
- 2. Authorizing the County Manager to designate the certain public safety equipment as no longer needed for County purposes and authorizes the County Manager to dispose of the equipment in accordance with N.J.S.A. 40A:11-36. (Freeholder Mohamed S. Jalloh)

Chairman Granados asked the Director to elaborate on his second resolution.

Director Moran advised that the equipment is a 2004 trailer which was used by the Police Department and has been determined to be no longer usable. He noted that when such equipment is deemed such, the County puts it out for auction.

- 3. Authorizing the County Manager to enter into a non-fair and open professional services contract, with Lehrer-Gibilsco Funeral Home, Inc., 275 West Milton Ave., Rahway, New Jersey, for the purpose of providing Livery Services through December 31, 2018, in a total amount not to exceed \$150,000.00. - 4. Re-appointing Christopher Scaturo, as the Union County Emergency Management Coordinator for a three (3) year term commencing on March 1, 2018 through February 28, 2021. (Freeholder Mohamed S. Jalloh)

Freeholder Bergen asked the reason as to why the County is transferring to the Middlesex Public Safety County Radio Network.

Director Moran advised that the County is not transferring to the Middlesex Public Safety County Radio Network, but noted that Middlesex County has a public safety communication system that their public responders use at no cost to the County. He advised that this will allow the County to access their radio system. He advised that if the County of Union is involved in a joint operation with Middlesex County, this agreement will allow for better communication.
