# Thursday, May 3, 2018 Agenda Setting Meeting Minutes

# CALL TO ORDER

Chairman Sergio Granados presided over the meeting and called the meeting to order at 7:05pm.

# ROLL CALL

Roll call showed Chairman Sergio Granados, Vice Chairman Bette Jane Kowalski, Freeholder Bruce H. Bergen, Freeholder Linda Carter, Freeholder Angel G. Estrada, Freeholder Angela Garretson, Freeholder Christopher Hudak, Freeholder Mohamed S. Jalloh, and Freeholder Alexander Mirabella were present.

Also present were County Manager Edward Oatman, County Counsel Robert E. Barry, Esq., and Clerk of the Board James E. Pellettiere.

# PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

## STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

## PRESENTATIONS

A resolution presentation will be made by Freeholder Chris Hudak to Linden High School students Jade Rodrigues and Taylor Battle recognizing their artistic talents and recognizing them for representing the state of New Jersey at the 140th Annual Easter Egg Roll at the White House.

Chairman Granados called upon Freeholder Hudak for the evening's first presentation.

Freeholder Hudak called upon Taylor Battle and Jade Rodrigues to join him. Freeholder Hudak made comments relative to the White House Easter Egg Roll, noting that it started 140 years ago. He stated that students across the 50 states had an opportunity to design an egg to represent their state (and to be displayed on the White House lawn). He commended Taylor and Jade (of Linden High School) for their artistic abilities as their egg had been chosen to represent the State of New Jersey.

Freeholder Hudak noted that Taylor will be attending Kean University and studying architecture, and Jade would be taking advantage of the UCSTARS program, and then will attend NJIT.

Jade Rodrigues and Taylor Battle made comments about the program; noting that they only had 3 days to accomplish the project. They thanked their graphic design teacher, Mrs. Heverin, for her

guidance. They spoke on the limitation of time and of colors, and spoke of their use of Photoshop and Adobe Illustrator.

Freeholder Hudak stated the students were smart, talented, and when a microphone, perform under pressure.

A presentation will be made by Scotch Plains Mayor Alexander Smith, Project Coordinator Tom Strowe, and Human Resource Manager Margaret Heisey to the Board relative to the Sandy Hook Promise; an apolitical non-profit organization whose "Know The Signs" programs are researched-based programs and practices to help protect children from gun violence in our homes, schools, and communities.

Chairman Granados called upon the Honorable Mayor Smith for the evening's second presentation.

Mayor Alexander Smith, of Scotch Plains, made a presentation to the Freeholders relative to a plan to prevent gun violence. He made comments relative to the goals and implementation of the Sandy Hook Promise; a program that concentrates on how to work with the students to make schools more inclusive and prevent bullying. He presented the Board with a 6 minute video.

He encouraged the Mayors in the audience (to receive grant awards later in the meeting). He noted that he is a "Promise Leader" and advised what steps can be taken for others to join him as a "Promise Leader." He made comments relative to the township of Schotch Plains' participation in the "Just Say Hello" program, which is the first step of the "Sandy Hook Promise" initiative. He made comments relative to the legislation introduced in the State Assembly: Extreme Risk Protective Order Act of 2018; allowing for a procedure where a loved one can report an individual to the police which would prohibit, with judicial review, the individual from purchasing a weapon and/or issue a warrant to seize weapons if they are deamed a potential threat to the public or themselves.

Freeholder Mirabella thanked the Mayor for his presentation. He advised Mayor Smith that the Board previously voted in support of the "Sandy Hook Promise" and would forward the resolution to the other 20 municipalities asking them to join in support of the program.

Resolution presentations will be made by Chairman Sergio Granados, Freeholder Alexander Mirabella and Freeholder Christopher Hudak to the recipients of the 2018 Union County Level The Playing Field Grant Program and the 2018 Union County Infrastructure Grant Program.

Chairman Granados acknowledged that Freeholder Hudak was the driving force in creating the Infrastucture Grant and thanked Freeholder Mirabella, as Chairman of the Trust Fund Subcommittee, for his assistance in establishing the Level the Playing Field Grants as part of one of his Chairman Initiatives. He stated that the grants would create an inclusive playground in each of the municipalitie, noting that the County of Union is the first county to provide inclusive playgrounds in all its municipalities. Freeholder Mirabella thanked Chiarman Granados on his vision. He made comments on the County's successes in providing inclusive opportunities to all individuals, noting the success of the County's Sensory Friendly Theatre program. He stated that he was proud of all of the towns for taking advantage of this grant opportunity.

Freeholder Hudak made comments relative to history of the Infrasturcture Grants, noting the Board, under then Chairman Jalloh, collectively supported using the proceeds from the sale of Runnells Specialized Hospital to be used to invest money into the local infrastructure. He stated tha the County has contributed \$6 million since 2015, noting that each municipality has received funding every year since its inception. He added that the grant is a dollar-for-dollar matching grant, resulting in a total of \$12 million in infrastructure improvements.

Representatives from each of the municipalities and received a presentation check for both grant programs and provided an overview of how the funds were to be used.

Chairman Granados thanked the County Trust Fund Administrator Drake, Judy Binaris and Edee Marie on their involvement in administering the Level the Playing Field grants, and Deputy County Manager Wagner and Kathy (Addessa) on the administration of the Infrastructure Grants.

Authorizing the County Manager to enter into a Shared Services Agreement with the County of Essex Department of Corrections Newark, NJ for relocation of inmates on an as needed basis for the contract period of May 1, 2018 through December 31, 2018, per diem cost of \$98.00 per inmate per day in an amount not to exceed \$96,040.00. (Chairman Sergio Granados)

Freeholder Jalloh asked the Director to provide futher clarification.

Director Charles advised that this contract would allow for alternative housing for individuals in instances that involve co-defendants and for those with crimes against staffers.

Freeholder Jalloh inquired as to the frequency of utilizing such a contract.

Director Charles advised that there typically are 4 individuals transferred to Essex County.

Chairman Granados asked the Director to provide futher clarification.

Director Taylor advised that the County received notification from the State authorizing the County to adopt its budget pending the approval from the Department of Human Services relative to the Social Services budget.

Freeholder Hudak inquired if there is any chance the Social Services budget will not be approved.

Director Taylor advised that the review is a normal procedure in the State's approval of all budgets, noting that there is a staffing issue that has resulted in not officially getting the approval. Director

Taylor advised that at this time there are no scheduled amendments to the County Budget, and that it was unlikely to have any delay in the County's adoption of its budget.

# DEPARTMENT OF HUMAN SERVICES

Debbie-Ann Anderson, Director

Division Director Maureen Glenn represented the Department.

1. Authorizing the County Manager to approve the 2018 Union County GAP One-Time Spending Plan pursuant to a Request for Proposal (RFP) procurement process in the total amount not to exceed \$370,905 for subcontracted services to be provided during the period of June 1, 2018 through December 31, 2018; further the authorizing the transfer of funds among the agencies during the contract period should service needs change and/or if any of the agencies fails to meet its contractual obligation. (Vice Chairman Bette Jane Kowalski)

Chairman Granados inquired as to who would utilize the services.

Division Director Glenn advised that the service is primarily for emergency housing and homeless prevention.

- 2. Amending Resolution 2016-590 entering into contract with Urban League of Union County, Elizabeth, NJ, to extend the contract period only for a new contract period of August 1, 2016 through December 31, 2018; all other terms of contract remain the same. (Vice Chairman Bette Jane Kowalski)
- 3. Amending Resolution 2016-541 entering into contract with Bridgeway Rehabilitation Services, Inc., Elizabeth, NJ, to reduce the total amount of the contract by \$30,000 for a new total contract amount of \$191,211.38 and to extend the contract period an additional six (6) months for a new contract period of July 1, 2016 through December 31, 2018; all other terms of contract remain the same. Freeholder Hudak inquired if the change was in scope only, or if there was a change in the amount as well.

Director Zuber advised that it is a change in scope, noting that the County was originally eligible for \$3.2 million. He advised that the Skating Center was not eligible for Green Acres funding, which was the reason the County changed the scope to include a Track and Field component. He advised that the new change in scope allowed for the release of the remaining \$900,000 for this project.
