

UNION COUNTY BOARD OF CHOSEN FREEHOLDERS

THURSDAY, AUGUST 9, 2018 AGENDA SETTING MEETING MINUTES

CALL TO ORDER

Chairman Sergio Granados presided over the meeting and called the meeting to order at 7:10 pm.

ROLL CALL

Roll call showed Chairman Sergio Granados, Vice Chairman Bette Jane Kowalski, Freeholder Bruce H. Bergen, Freeholder Angel G. Estrada, Freeholder Angela R. Garretson, Freeholder Christopher Hudak, Freeholder Mohamed S. Jalloh, Freeholder Alexander Mirabella, and Freeholder Rebecca Williams were present.

Also present were County Manager Edward Oatman, County Counsel Robert E. Barry, Esq., and Clerk of the Board James E. Pellettiere.

PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

(The meeting was delayed a few moments as the Clerk of the Board's staff handed out agendas to those in the audience. Chairman Granados apologized to the public for the delay.)

STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

PRESENTATIONS

A Certificate presentation will be made by Chairman Granados (Vocational-Technical School Board of Education), Freeholder Christopher Hudak (Vocational-Technical Board of Education) Freeholder Mirabella (Vocational-Technical Schools Board of Education) and Vice Chairman Kowalski (NJAC Liaison) to Vocational-Technical graduate Jeffrey Gonzalez, in recognition of receiving the New Jersey Association of Counties (NJAC) Foundation Scholarship.

Chairman Granados called upon Freeholder Mirabella, Freeholder Hudak and Vice Chairman Kowalski (NJAC Liaison), to join him for the evening's first presentation.

Vice Chairman Kowalski called upon NJAC Executive Director John Donnadio, Vocational-Technical Schools Superintendent Peter Capodice, and Jeffrey Gonzalez to join them. Vice Chairman Kowalski advised that one of the recipients of the NJAC Foundation Grant, Jeffery Gonzalez, was from the UC Vocational Technical Magnet School.

Mr. Donnadio thanked the Freeholder Board for their support of NJAC. He noted that he always enjoys visiting Union County as he grew up in Hillside and Schotch Plains, and is a proud graduate

of Union County College. He also thanked Investors Bank for their generosity and for supporting NJAC for the past seven years in their efforts to give away over \$3000,000 in scholarships to Vocational-Technical School graduates who continue their education in the State of New Jesrey.

Vice Chairman Kowalski summarized Gonzalez's academic resume and noted that he was a student who committed himself to his academics. Vice Chairman stated that that Gonzalez, a student from Elizabeth, took various advanced classes and has always gone above and beyond the requirements.

Jeffrey Gonzalez thanked the Freeholder Board for giving him the opportunity for receiving such a prestigious award. He made comments relative to his experience at the Vocational-Technical school, noting his classes and the hands-on experience he had at the school were experiences that made him realiz he wanted to work in mechanical engineering. Jeffrey made the decision to attend Rutgers University in New Brunswick after he saw their exceptional mechanical engineering course.

A resolution presentation will be made by Freeholder Mirabella and Chairman Granados to Union County Sheriff Officer Christopher Zamanski congratulating him on his distinct honor in receiving the Big Brothers Big Sisters' "2018 Bigs of the Year" award.

Freeholder Mirabella called upon Sheriff Peter Corvelli, Undersheriff Amilcar Colon, and Officer Christopher Zamanski. Freeholder Hudak joined Freeholder Mirabella and Chairman Granados with the presentation.

Officer Zaminski thanked the Freeholders and Big Brothers Big Sisters for the award. He noted that volunteering with the program for the past five years has been a very rewarding experience for him as well as his Little Brother, Greg.

Chairman Granados called upon Big Brothers Big Sisters COO Michele Williers and Gabrielle Lasko to thank them for their work. Chairman Granados stated that Big Brothers Big Sisters is a program that the Freeholder Board, Sheriff, County Police Director Andrew Moran, and Director of Corrections Ron Charles are all working closely with to bring back "Bigs in Blue", another outlet that members of law enforcement can use to give back to the community.

COO Michele Williers made comments relative to Officer Zamanski's dedication to serving the community and volunteering in the Big Brothers Big Sisters program. She then read a quote from Officer Zamanski's Little Brother, Greg. Greg stated that Offizer Zamanski has taught him many important life lessons and, that with his help, Greg can at least try to play his favorite sport again.

Michele continued on with a summarization of Greg's life-altering accident and how Office Zamanski has been a constant presence during his recovery. She mentioned how Officer Zamanski single-handedly set up a fundraiser to raise money for Greg's prosthetic. Michele then thanked everyone for the support and noted how important it is to bridge the gap between law enforcement and the community.

A check presentation will be made by Trust Fund Committee Chairman Mirabella and Chairman Granados to the nineteen (19) 2018 Library Grant Award recipients.

Freeholder Mirabella praised the librarians in the County for working together to determine what funds each library needed. Freeholder Mirabella then recognized libraries as equal opportunity information centers and said that it was thanks to the spirit of the librarians of Union County.

Representatives from each library came up and received a presentation check for the grant program and provided an overview of how the funds were to be used.

First Assistant Prosecutor Albert Cernadas represented the Office.

Chairman Granados thanked the Prosecutor's Office for partnering up with Big Brothers Big Sisters' Big Blue program.

1. Approving the annual Short Term and Long Term Disability Insurance policy with Union Insurance Company, Atlanta, GA, for the period of September 1, 2018 through August 31, 2019 in an estimated amount not to exceed \$230,000.00. (Chairman Sergio Granados)

Freeholder Estrada inquired as to which is the Short Term and Long Term Disability Insurance policy the County currently has and what it covers.

Director Yuska stated that the insurance covers government workers who are out of work for a reason that isn't normally covered, due to government workers not having disability insurance. As part of union contracts, the County is only paying for half of the \$230,000.

Freeholder Estrada inquired if this is only for unionized employees or if it is for every County employee.

Director Yuska stated that it applies to certain unions with the contract. He noted that the coverage is similar to Aflac (people are more familiar with such).

- 2. Authorizing a payment to Beckerman & Company, County General Insurance Agent of Record, to obtain Cyber Security insurance coverage with ACE American Insurance Company, Philadelphia, PA for the period of 6/26/2018 through 6/25/2019 for a total amount not to exceed \$35,469.00. Ron Charles, Director

Authorizing the County Manager to enter into a Shared Services Agreement with the County of Mercer, Trenton, NJ for the purpose of providing secure detention beds for its juvenile detention population at the Union County Juvenile Detention Center, on an as needed basis, effective for the initial period commencing upon the date on which both parties have fully executed the Agreement and concluding on August 31, 2019 at a per diem rate of \$225.00 per juvenile as specified in the Shared Services Agreement. Director Charles noted that he would get the information for Freeholder Mirabella. Director Charles stated that, if needed, the County has a 30-day out on the contract.

Freeholder Mirabella inquired if the County was renewing with the same firm.

Director Charles stated that it was the same contract the Coutny has used for the past 3 years with the same price.

DEPARTMENT OF ECONOMIC DEVELOPMENT

Amy Wagner, Deputy County Manager/Director

1. Authorizing the County Manager to utilize the second year option outlined in Resolution #2016-722 to extend the contract with Development Directions, LLC, of Rahway, NJ to September 1, 2018 through August 31, 2019, to provide administration of the Union County

Freeholder Kowalski asked if the numbers were going down for the HUD grant.

Deputy County Manager Wagner stated that the numbers went up this year. Programs were threatened to be eliminated and the department received an exrra \$400,000 from the CDBG Grant and an extra \$400,000 in the Home grant.

Chairman Granados asked the Director to elaborate on some of the projects provided through the Home program.

Deputy County Manager Wagner stated that there are a number of different programs for housing, including those for disabled or for low-income individuals throughout the County.

DEPARTMENT OF PARKS AND RECREATION

Ron Zuber, Director

1. Authorizing the County Manager to conduct the 2018-2019 Deer Management Program for Union County, relative to the reduction of the white-tailed deer population within the

Watchung Reservation, Nomehegan Park, Lenape Park, Summit portion of Passaic River Park, Ash Brook Reservation, Oak Ridge Park, the Hawk Rise Sanctuary, the Crushing Road Detention Basin and the Hillside Portions of Elizabeth River Park. Licensed hunters, acting as agents of the county, would harvest during the permit shotgun and Archery equipment season of September 2018 through March 2019, in the manner prescribed by the Fish and Game Code of the State of New Jersey and the 2018-2019 Deer Management Program for Union County Guidelines in an amount not to exceed \$20,815.00. The County Manager is authorized to restrict areas when conditions necessitate. (Chairman Sergio Granados)

Freeholder Estrada inquired about the time frame for the Deer Management Program.

Director Zuber explained that the extension is for the addition of archery. In order to hunt during November, the Department needed to include September in the time frame; clarifying that the Fall Bow Season begins in September, but the County would not be hunting until November.

Freeholder Estrada asked what the time frame was for the hunt last year.

Director Zuber stated that the time frame was from January until early February.

Freeholder Estrada asked if the County has accounted for the deer population this year and what it is.

Director Zuber stated that there are 68 deer per square mile in Watchung Reservation, 182 deer per square mile in Lenape and Nomahegan Park, 98 deer per square mile around Ash Brook Reservation and Oak Ridge Park, 53 deer per square mile in Hawk Rise Sanctuary in Linden and the Linden Municipal landfill, 183 deer per square mile in and around the Cushing Road Detention Basin in Plainfield, and 260 deer per square mile in Elizabeth River Parkway in Hillside.

Freeholder Estrada asked for clarification on the number of deer in Hillside.

Director Zuber replied that there are 260 deer per square mile in Elizabeth River Parkway in Hillside.

Freeholder Estrada then inquired what the population goal is this year.

Director Zuber replied that the goal for this year is to remove 130 deer from Watchung Reservation, 85 deer from Lenape and Nomahegan Park, 100 deer from Ash Brook Reservation and Oak Ridge Park, 16 deer from the Summit portion of Passaic River Park, 10 deer from Hawk Rise Sanctuary in Linden and the Linden Municipal landfill, 25 deer from the Cushing Road Detention Basin in Plainfield, and 25 deer from the Hillside section of Elizabeth River Park.

Freeholder Estrada asked if these deer will be processed and given to programs for the homeless.

Director Zuber replied that the deer will primarily go to Hunters for the Hungry.

Freeholder Williams noted that forest ecologists suggest a number of deer per square mile that is adequate to protect the wildlife flora, and inquired as to what that number was.

Director Zuber brought up Daniel Bernier, who is part of the Deer Hunt, to answer the question.

Dan Bernier stated that the forest ecologist recommend a density of 20 deer per square mile for a healthy forest and for impacted forests like those in the County, a density of 5 per square mile is recommended.

Freeholder Mirabella commented that the Coutny has been aggressive in maintaining the deer population for various reasons including the safety of residents and nature. Freeholder Mirabella added that for the past few years, the method has worked but it is time to be a little more aggressive and that he is glad we are moving forward with a new plan.

Freeholder Estrada commented that the addition of an archery component makes sense and is a good option.

- 2. Authorizing the County Manager to enter into an agreement with United Youth of New Jersey to run the "Annual Cookout" event at the Warinanco Park on August 11, 2018; and to make available for this specific event for the United Youth of New Jersey the sum, in the amount not to exceed \$1,500.00. (Chairman Sergio Granados)
- 3. Authorizing the County Manager through the Office of Cultural & Heritage Affairs to execute any and all agreements for the 2018 HEART (History, Education Arts Reaching Thousands) Grant Program for the total allocated amount of \$100,000.00 to 63 recipients. (Chairman Sergio Granados)

Chairman Granados asked the Director to elaborate on the HEART Grant and its services.

Director Zuber stated that there are 63 groups receiving HEART Grant funding this year. Director Zuber brought in Cultural and Heritage Manager Kathy Kakaletris to answer the question.

Vice Chairman Kowalski explained that the HEART Grant is for cultural and educational programs for groups and individuals.

Kathy Kakaletris stated that the HEART Grant is History, Education Arts Reaching Thousands and that this year groups and libraries are receiving art and history grants in addition to a few individuals who are receiving arts services grants. The office received \$122,000 in requests and the office was able to grant \$100,000.

Chairman Granados thanked Ms. Kakaletris and acknowledged that it is a great program that benefits many organizations, including Hispanic heritage festivities and other history programs.

Vice Chairman Kowalski added other programs covered by the grant, including dance, theater, choral presentations, and other cultural events.

4. Authorizing the County Manager, through the Office of Culture and Heritage Affairs, to enter into agreement with Page Conservation, Inc., and execute all necessary items needed with services of specialist in art conservation, at the locations of the Deserted Village of Feltville, in the amount, not to exceed \$40,000.00. Freeholder Estrada asked if this number of pathologists is sufficient for the County.

Director Moran responded that this number is sufficient.
