#### Thursday, July 12, 2018 Agenda Setting Meeting minutes

#### CALL TO ORDER

Chairman Sergio Granados presided over the meeting and called the meeting to order at 7:08 p.m.

#### ROLL CALL

Roll call showed Chairman Sergio Granados, Freeholder Bruce H. Bergen, Freeholder Angela R. Garretson, Freeholder Christopher Hudak, Freeholder Angel G. Estrada, Freeholder Rebecca Lynne Williams were present, with Freeholder Mohamed S. Jalloh, Freeholder Alexander Mirabella and Vice Chairman Bette Jane Kowalski absent.

Also present were County Manager Edward Oatman, County Counsel Robert E. Barry, Esq., and Clerk of the Board James E. Pellettiere.

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

#### **PRESENTATIONS FROM THE BOARD**

A resolution presentation will be made by Freeholder Alexander Mirabella congratulating Roselle Park Mayor Carl Hokanson for being honored by the Chapel of Four Chaplains with the Legion of Honor Award.

Chairman Granados called upon Freeholder Estrada to join him with the evening's presentation. A resolution presentation was made by Freeholder Angel G. Estrada congratulating Roselle Park Mayor Carl Hokanson for being honored by the Chapel of Four Chaplains with the Legion of Honor Award. Freeholder Estrada stated that veterans play a great role in our society and stated the importance in recognizing their service. He read the resolution aloud.

Chairman Granados spoke to Mayor Hokanson, not only as Mayor of Roselle Park, but as a police officer and for your service in the armed forced. He commended him on giving back to veterans and supporting Veteran events throughout the year.

Mayor Hokanson stated that the award began in 1943 with four chaplains on the USS Dorchester which was a troop ship on its way to Iceland. He explained that the ship was torpedoed and the four chaplains gave up their life jackets, and positions on the life boats, to save the wounded. He stated that the chaplains went down with the ship. He said that it is a prestigious award, and he was

honored to receive it on behalf of the leathernecks and all branches of the service. He also thanked Union County for the great job it does for veterans.

Chairman Granados and Freeholder Estrada presented Mayor Hokanson with the resolution and photos were taken with the Mayor and his wife.

Director Graziano introduced Joann to speak about the new "recycle coach" app and presented a power point presentation to the Board.

Coordinator Gemenden said that the app is free and is the source to go for garbage, recycling and curbside information. She stated that it is open to all municipalities and that it gives information regarding upcoming recycling events. Ms. Gemenden stated that it is a statewide app, so residents can access it from any site in NJ. She also spoke about a few other initiatives of the Borough of Recycling; including the County's grants to municipalities, increased recycling in schools, compost bin sales, and business and residential guides.

Director Graziano stated that Joanne was one of the most respected Recycling Coordinators in the state. He advised the Board and the public that recycling shopping bags were available for them to take home, and provided other brochures and information on recycling.

Chairman Granados thanked JoAnn and Director Graziano for all of their hard work in working with the municipalities to ensure the County as a whole is increasing its efforts and awareness towards "going green;" he especially thanked her for their efforts within the school systems.

Chairman Granados inquired as to the type of services (what the money will be used for).

Deputy County Manager Wagner advised that they are used for supportive services, child care, bus passes and for appropriate clothing for a job interview. She said it was new this year and that has been beneficial to job seekers.

Director Zuber stated that the resolution is an amendment to the Kemper contract for the monthly fee as it relates to the shared services agreement with Scotch Plains. He advised that Scotch Plains has to reimburse the County for all cost, noting that Scotch Plains would be responsible for any shortcomings.

The chairman asked the Director to confirm that this is agreement is cost neutral to the County, and any short falls would be paid by Scotch Plains.

Director Zuber stated that that was correct.

Director Moran stated that this resolution pertained to the preparation for active shooter incidents. He advised that last year this program trained police, fire and EMS in bleeding control. He advised that this year the County will expand the program to include school districts so that educators, school staff, and administrators will be trained in the use of tourniquets and other bleeding control techniques.

The Chairman commended the Director, noting that this is a great initiative to ensure that the County is reaching out to schools. He thanked Director Moran and his staff for their efforts.
