AN ORDINANCE FIXING THE SALARIES OF MEMBERS OF THE BOARD OF CHOSEN FREEHOLDERS, THE COUNTY MANAGER AND DEPARTMENT HEADS

Be It Ordained by the Board of Chosen Freeholders of the County of Union as follows:



Section 1. The salaries of the Members of the Board of Chosen Freeholders, County Manager, County Counsel and Departments Heads shall be as hereinafter set forth and shall be effective as of January 1, 2019.

Section 2. That this Ordinance shall take effect at the time and manner provided by law.

Section 3. That the Clerk of this Board be and he is hereby authorized to publish a notice in the appropriate newspaper of such introduction and of a public hearing on December 13, 2018, and shall forward one certified copy of final passage to each Clerk of all Municipalities located within the County of Union.


