



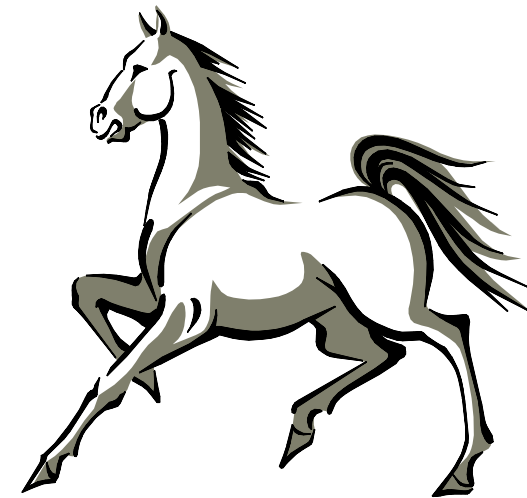

CAMP REGISTRATION DATES:

- **On-Line Registration for ratings D2-1C/T**—Starting May 28 at 8 am – ending May 30 at 7pm
- **ONLY** First squad may register for 2 weeks during on line registration
- Any other rating wanting a second week please send an email to stablequestions@ucnj.org with: Child's name, rating, cell number and the week you want. We will start to call for second weeks on June 5th.
- **Union County Resident Beginners:** Saturday, May 18—8 am Lottery—In Person registration only. **You must have an account set up before registration.**
- **Out-of-County Beginners and All riders new to the program:** Saturday, June 1; beginning at 10 am if space permits. In person only. Please call to see if any spaces still exist. (lottery)

In Person Registration for all ratings starts

Saturday June 1, at 1:00 pm and continues until all spots are full

ENROLLMENT: Boys and girls ages 9 to 18 are eligible to attend. Enrollment is limited to one week per child (if available). All required fees must accompany an application.

CLOTHING: Jeans, a riding helmet with a fixed harness (no bicycle helmets) and a pair of sturdy shoes with a heel are a must. Rain gear should be available every day. **CAMP IS NEVER CANCELED DUE TO WEATHER.** A camp t-shirt will be given to every participant.

Medical Form Procedure

On-Line Registration for ratings D2-1 C/T

- Medical forms will now be filled out online during registration and sent directly to nurse
- You will not lose your spot by filling out this form unless you take more than 10 minutes
- You will need emergency contact, doctors information, medical conditions/allergies and any medications they need
- After you have registered all participants will automatically receive via email the following forms:

Authorization and Release Form for the Administration of Medication –

This form is required if medication is to be administered to a summer camp participant. It is to be completed by the parent /guardian. It does not require a physician's signature. This form must be returned no later than June 12, 2019, forms can be emailed to nurse@ucnj.org or mailed to Watchung Stables, 1160 Summit Lane, Mountainside NJ 07092, Attention: NURSE.

Physicians Authorization Form for the Administration of Medication-

This form is required for each participant who is currently prescribed an inhaler or medication other than an epinephrine auto injector. This form must be completed by a physician and requires a physician's signature and stamp. This form must be returned no later than June 12, 2019, forms can be emailed to nurse@ucnj.org or mailed to Watchung Stables, 1160 Summit Lane, Mountainside NJ 07092, Attention: NURSE.

Allergy and Anaphylaxis Emergency Form-this form is to be completed if your child has an allergy that may require an epinephrine auto injector. This form must be filled out by a physician and requires a physician's signature and stamp. This form must be returned no later than June 12, 2019, forms can be emailed to nurse@ucnj.org or mailed to Watchung Stables, 1160 Summit Lane, Mountainside NJ 07092, Attention: NURSE.

- Failure to return forms may result in your child being unable to attend camp.

- You must provide proof of age (birth certificate/passport) and proof of residency on the day of registration
- Lottery numbers will be handed out at 8:00am-registration will start at 8:15am
- After you register you will automatically be emailed three medical forms.

AGREEMENT**

PLEASE READ CAREFULLY BEFORE SIGNING. THIS STABLE DOES NOT GUARANTEE YOUR SAFETY.

Serious Injury may result from your participation in this activity.

In consideration of and by participating in any fashion in any activity today and on all future dates at the Watchung Stables, any participant, his/her heirs, assigns, and legal representatives, hereby expressly agree to the following:

1. Participant agrees to assume any and all risks involved in or arising from the participant's use of Watchung Stables services, activities and/or property and facilities including, but not limited to the risks of death, bodily injury, property damage, falls, kicks, bites, collisions with vehicles, persons, horses or stationary objects, or the negligence or deliberate act of another person.
2. Participant agrees to hold Watchung Stables and the County of Union and all of its successors, assigns, subsidiaries, employees, and agents harmless and release them from any/all liability whatsoever and in connection with any claims, causes of action, injuries, damages, cost or expenses arising out of participant's use of Watchung Stables services, activities and/or property and facilities, including without limitation, those based on death, bodily injury, or property damage.
3. Participant agrees to indemnify and defend Watchung Stables and the County of Union and all of its successors, assigns, subsidiaries, employees, and agents against any and all claims, causes of action, damages, judgments, costs or expenses resulting from the participant's negligence arising from the participant's use of Watchung Stables services and/or property and facilities.
4. Participant certifies that he/she is physically and mentally fit for all equestrian activity and will obey all rules and regulations established by Watchung Stables.

WARNING: UNDER NEW JERSEY LAW, AN EQUESTRIAN AREA OPERATOR IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN EQUINE ANIMAL ACTIVITIES RESULTING FROM THE INHERENT RISKS OF EQUINE ANIMAL ACTIVITIES, PURSUANT TO P.L.1997, c.287 (C.5:15-1 et seq.).

"Inherent risk or risks of an equine animal activity" means those dangers which are an integral part of equine animal activity, which shall include but need not be limited to:

1. The propensity of an equine animal to behave in ways that result in injury, harm, or death to nearby persons;
2. The unpredictability of an equine animal's reaction to such phenomena as sounds, sudden movement and unfamiliar objects, persons or other animals;
3. Certain natural hazards, such as surface or subsurface ground conditions;
4. Collisions with other equine animals or with objects; and
5. The potential of a participant to act in a negligent manner that may contribute to injury to the participant or others, including but not limited to failing to maintain control over the equine animal or not acting within the participant's ability.

Finally, participant represents to Watchung Stables management that this Agreement is being made freely and voluntarily, and that if this Agreement is on behalf of a participant who is under the age of eighteen (18) years, that the undersigned is the participant's parent or legal guardian. Participant further acknowledges and understands that this Agreement shall remain valid now and at all times in the future until it is revoked in writing by participant.
