

# UNION COUNTY BOARD OF CHOSEN FREEHOLDERS

## THURSDAY, APRIL 26, 2018 AGENDA SETTING MEETING MINUTES

## CALL TO ORDER

Chairman Sergio Granados presided over the meeting and called the meeting to order at 7:05pm.

## ROLL CALL

Roll call showed Chairman Sergio Granados, Vice Chairman Bette Jane Kowalski, Freeholder Bruce H. Bergen, Freeholder Linda Carter, Freeholder Angel G. Estrada, Freeholder Christopher Hudak (and his daughter, "Junior Freeholder" Catherine Riley) were present, with Freeholder Angela Garretson, Freeholder Mohamed S. Jalloh, and Freeholder Alexander Mirabella absent.

Also present were County Manager Edward Oatman, 1<sup>st</sup> Deputy County Counsel Rosalba L. Comas, Esq., and Clerk of the Board James E. Pellettiere.

## PRESENTATIONS FROM THE BOARD

Resolution presentations will be made by Chairman Sergio Granados and Freeholder Linda Carter to the winners of the 2018 Shade Tree Young Writers Poetry Contest.

Chairman Granados called upon Freeholder Carter for the evening's first presentation. Chairman Granados and Freeholder Carter alternated in introducing each of the award winners and called each up to receive a proclamation. Chairman Granados advised all those in the audience that each winner will receive a check as a reward for their poetry skills. He called upon Director Graziano, James Kelly and Barbara Knapp to join in the presentation.

Freeholder Carter commended the children on their poetry, noting that there were many poems to review and evaluate. She said it was a difficult process in selecting, but commended each of the winners for their outstanding work. Chairman Granados announced that the first place winners received \$50 and the second and third place winners received \$25.

Some of the young writers read their poems aloud to great applause.
