THURSDAY, DECEMBER 20, 2018 AGENDA SETTING MEETING MINUTES

CALL TO ORDER

Chairman Granados presided and called the meeting to order at 7:07 p.m.

ROLL CALL

Roll call showed Chairman Sergio Granados, Vice Chairman Bette Jane Kowalski, Freeholder Bruce H. Bergen, Freeholder Angel G. Estrada, Freeholder Angela R. Garretson, Freeholder Christopher Hudak, Freeholder Alexander Mirabella and Freeholder Rebecca Lynne Williams were present, with Freeholder Mohamed S. Jalloh absent.

Also present were Deputy County Manager Amy Wagner, County Counsel Robert E. Barry, Esq., and Clerk of the Board James E. Pellettiere.

PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

PUBLIC HEARING

Chairman Sergio Granados opened the meeting up for public comment and asked the Clerk of the Board to read the Ordinance by Title.

Clerk of the Board read the Ordinance aloud into the record.

The meeting was open for the purpose of hearing persons interested in, or who are affected by, the adoption of the Amendment to the Solid Waste Management District:

AN ORDINANCE TO MODIFY THE UNION COUNTY DISTRICT SOLID WASTE MANAGEMENT PLAN BY INCLUDING A GENERAL CLASS "B" RECYCLING FACILITY TO BE OWNED AND OPERATED BY NJ RUBBER, LLC, LOCATED AT 475 DIVISION STREET, Lot 8, BLOCK 1875, ELIZABETH, NEW JERSEY. THE PROPOSED FACILITY WILL HAVE A 300 TONS PER DAY CAPACITY TO ACCEPT, PROCESS AND TRANSFER USED TIRES FROM GOVERNMENTAL ENTITIES AND COMMERCIAL BUSINESSES IN THE AREA.

Bruce Patterson, of Garwood, stated that every once in a while something great comes out of county government and stated supports this greatly. He questioned how many tires are out there that need to be recycled.

Seeing no other speakers, Chairman Granados closed the public hearing. He advised that a vote on the ordinance will take place during the Regular Meeting later that evening.

Chairman Granados advised that they would now move along the agenda for a number of presentations.

PRESENTATIONS FROM THE BOARD

A resolution presentation will be made by Chairman Sergio Granados and Vice Chairman Bette Jane Kowalski to Audrey Davis, recognizing her accomplishment in achieving the Girl Scout Gold Star Award.

Chairman Granados sated that he had spoken to Ms. Davis prior to the meeting and commented on the amount of energy and the interest towards making a difference in her community is outstanding and inspirational. Chairman Granados stated that Ms. Davis received the Youth Virtue Value and Vison Award, which is only given to ten students in the Country. Chairman Granados stated that Ms. Davis organized a walking club for individuals (teens and young adults) with special needs. He read the proclamation aloud. Chairman Granados also called up Manny Ramirez and Nicole DeAugustine of the office of special needs to help recognize Ms. Davis.

Freeholder Kowalski thanked Ms. Davis for the great work she has done and stated how proud her family, the Girl Scouts and the County was of her.

Ms. Davis thanked the County, Nicole D'Agustine and Manny Ramirez and the community for all of their encouragement. She stated that they had over 70 participants participate in the club, and stated that she looks forward to continuing the program in the future. She stated that both Manny and Nicole were wonderful to work for and inspire her to want to continue doing this field of work as a career.

Chairman Granados also thanked Audrey's family for supporting her in all of her endeavors.

A resolution presentation will be made by Freeholder Chris Hudak and Freeholder Alexander Mirabella to Union County College Elizabeth Campus Dean Dr. Lester Rapalo recognizing his efforts in organizing the First International Youth Concert for Peace.

Freeholder Mirabella stated that Dr. Rapalo is the Dean of the Elizabeth campus of Union County College, and that he and his wife attended the international peace concert on December 8, 2018. He stated that they were impressed by his leadership and of the students that came from around the world to celebrate diversity.

Dr. Lester Rapalo said that it was a pleasure and thanked Dr. McMenamin, noting that without her vision the concert would not have happened. He thanked the Freeholders for their support, stating that they had more than 400 people attend and participate with the peace concert, and had representation from many countries.

A resolution presentation will be made by Freeholder Christopher Hudak and Freeholder Angel Estrada to Isabella Buss recognizing her achievement in winning the VFW Patriots Pen Essay Contest.

Freeholder Hudak stated that there has been tremendous talk in our country regarding immigration, noting that a lot of it is unfortunately negative. He said that it is unfortunate because nearly every resident of the United States came from another country. He said that immigration is the lifeline of (this) country. He heard that Ms. Buss won an essay contest that was sponsored by their local VFW. He stated that her essay was very touching, noting that it touched upon her personal experiences. He stated that the Board was very proud to see a young person with such a great outlook and found her to be very inspirational.

Freeholder Estrada stated that he came to the United States from Cuba when he was 10 years old, and that the United States is the land of opportunity.

Ms. Buss read her essay regarding her honor of the American flag.

Certificate presentation will be made by Chairman Sergio Granados and Freeholder Estrada to the following Cheer Squads for their success at the Pop Warner Cheer and Dance 2018 National Championships in Disney World, Florida: Rahway Chiefs Cheer (4th Place); Hillside Jr Comets (4th Place); Plainfield Lady Cardinals Peewee (1st Place); Plainfield Lady Cardinals Varsity (1st Place); and Elizabeth (5th Place).

Freeholder Granados stated that over 400 cheerleading teams over the United States compete and that Union County has some of the best in the country.

Representatives from each of the five (5) cheerleading teams spoke on their experience with the Pop Warner Cheer and Dance 2018 National Championships in Disney World.

Freeholder Estrada congratulated all the youth in the room for all the hard work that they do, not just in cheering, but in their community to family and school. He wished them the best.

Freeholder Garretson said she was excited to see so many people from Hillside, and commended them on doing an incredible job. She commented on how the program has successfully grown under their work and stated how proud the Board was of them and their accomplishments.

Freeholder Williams said it was a pleasure to introduce the first place cardinals. She stated that she was proud of the pee-wees and let the head coach say a few words; who noted that it was their third consecutive national championship. Freeholder introduced the Plainfield Lady Cardinals Varsity team, and stated how proud the Board was of their accomplishment.

Chairman Granados introduced the Rahway Chiefs Cheer, 4th place national champions. The Vice President made remarks on the team's experience. He stated how proud he was of his squad and offered words of encouragement.

The Chairman thanked the cheer squads for coming out and especially recognized the Freeholder Aides Ryan Vasquez, Angelica Cedeno and Niko Micheludis for of all of their help coordinating this presentation.

OFFICE OF THE UNION COUNTY CLERK

Joanne Rajoppi, County Clerk

Clerk Rajoppi stated that she has three resolutions; two are amendments to contracts that we already have will election venders for envelopes. She advisd that they are needed because the change in the vote mail law this year. She advised that the third resolution is the 5-year county clerk plan, based on our trust fund.

- 1. Amending Resolution Number 2017-1075, a contract with Royal Printing Services, West New York, New Jersey for the purpose of providing envelope services in the amount of \$39,425. (Chairman Sergio Granados)
- 2. Amending Resolution Number 2017-1077, a contract with B & B Press, Lebanon, New Jersey, to secure additional monies in the amount of \$63,881.75, for printing expenses incurred due to the new Vote By Mail Law mandate enacted in August 2018. (Chairman Sergio Granados)

Freeholder Hudak asked to clarify Resolutions #1 and #2.

Clerk Rajoppi stated that they are the result in the change in the law as it relates to the Vote By Mail (VBM) application and the VBM outer and inner envelopes (as mandated by the State).

Freeholder Hudak inquired if there were three envelopes.

Clerk Rajoppi advised that he was correct. She stated that the law mandated a change in the language on the envelopes. She stated that the certificate envelope is an expensive endeavor.

Freeholder Hudak inquired if this cost is for 2019 only.

Clerk Rajoppi stated that these funds are only for the 2019 Primary and General Elections.

3. Approving the 2019 Union County Clerk Five Year Plan. (Chairman Sergio Granados)

Freehold Estrada inquired as to how much is identified in the plan.

Clerk Rajoppi stated that they generate \$2 for every recording, and approximated that the fund would generate about \$150,000 annually.

OFFICE OF THE UNION COUNTY PROSECUTOR

Michael A. Monahan, Acting Prosecutor

County Counsel Barry represented the Office.

There were no questions or inquiries from the Board.

1. Authorizing the County Manager, through the Union County Prosecutor's Office, to enter into a contract with Robert Santilli of Middletown, NJ to serve as IT Manager at the Union County Prosecutor's Office for the period of January 1, 2019 through December 31, 2019 in an amount not to exceed \$70,000. (Chairman Sergio Granados)

Counsel Bob Barry represented the Prosecutor's office. There were no questions.

DEPARTMENT OF ADMINISTRATIVE SERVICES

Michael Yuska, Director

There were no questions or inquiries from the Board.

- 1. Amending Resolution Number 2018-591, a professional services contract with Ruderman, Horn & Esmerado, Springfield, New Jersey, special counsel for Labor and Personnel matters, to increase the amount of award for legal services in the amount of \$10,000 for a total amount not to exceed \$50,000. (Chairman Sergio Granados)
- 2. Awarding a contract for 36 months for a vision insurance plan with VSP, Vision Care for Life Insurance Company in an amount not to exceed \$798,000 for the period of January 1, 2019 through December 31, 2021. The employee contribution is approximately \$360,000 with a County portion of approximately \$438,000. (Chairman Sergio Granados)
- 3. Authorizing the following vehicle to be deemed as surplus and no longer needed for use by the County: (1) 2004 Suburban 2500, VIN# 3GNGK26U64G164943, with an odometer reading in excess of 93,700 miles. (Chairman Sergio Granados)
- 4. Authorizing the following surplus-deemed vehicle for donation to the City of Linden, NJ: One (1) 2004 Suburban 2500 VIN # 3GNGK26U64G164943 with an odometer reading in excess of 93,700 miles. The City of Linden will assume all costs incurred with transfer and title. (Chairman Sergio Granados)

DEPARTMENT OF CORRECTIONS

Ron Charles, Director

- 1. Authorizing the County Manager to enter into a contract with Deacon Michael DeRoberts Mountainside, New Jersey to provide 5 hours of religious services and counseling per week for Catholic inmates in the Union County Jail, per State Code 10A:31-26.3 for the contract period of January 1, 2019 through December 31, 2019 in an amount not to exceed \$3,418.80. (Chairman Sergio Granados)
- 2. Authorizing the County Manager to enter into a contract with Minister Richard Hogans Linden, New Jersey to provide 10 hours of religious services and counseling per week for Protestant inmates in the Union County Jail, per State Code 10A:31-26.3, for the contract period of January 1, 2019 through December 31, 2019 in an amount not to exceed \$6,638. (Chairman Sergio Granados)
- 3. Authorizing the County Manager to enter into a contract with Community Access Unlimited Elizabeth, New Jersey to provide anger management training for the incarcerated male and females of the Union County Jail for the contract period January 1,

2019 through December 31, 2019 in an amount not to exceed \$30,000. (Chairman Sergio Granados)

Chairman Granados asked how many individuals go through the anger management program per year.

Director Charles said there were about 58 individuals participating in 2018.

4. Authorizing the County Manager to exercise the option in Resolution No. 2016-977, adopted 12/8/16 an agreement with GD Correctional, LLC, Watchung, NJ to renew the contract with GD Correctional Services which provides food services for the Union County Jail. The option is for January 1, 2019 through December 31, 2019 at a cost not to exceed \$1,200.000. (Chairman Sergio Granados)

Freeholder Hudak asked if the amount was a typo (\$1,200), as he assumed it was supposed to read \$1.2 million.

Director Charles stated that he was correct, that it should read \$1.2 million.

Freeholder Hudak asked clerk of the Board Pellettiere note this correction.

Freeholder Hudak asked if it was an option on the 2016 agreement.

Director Charles stated that he was correct.

Freeholder Hudak inquired if it was a one-year contract with two one-year extensions.

Director Charles advised that it is a two-year contract with three one-year options.

Freeholder Hudak asked if the previous two contracts were also \$1.2 million, and asked how much of the contract we used in the last two years.

Director Charles stated that the previous contract was in the amount of \$1.2 million, and that the County used approximately \$1.1 million.

- 5. Authorizing the County Manager to Amend Resolution 2016-1002, adopted 12/22/16 an agreement between Bergen County-Division of Family Guidance, Hackensack, New Jersey for purpose of providing secure detention beds for Union County Juvenile detainees in the Bergen County Correctional Center subject to the Shared Services Agreement. Original amount was \$150,000 and the new total amount not to exceed is \$200,000. Per diem cost of \$225 per juvenile per day. (Chairman Sergio Granados)
- 6. Authorizing the County Manager to enter into a Shared Services Agreement with the County of Essex Department of Corrections Newark, New Jersey, for relocation of inmates on an as needed basis for the contract period of January 1, 2019 through December 31, 2019. Per diem cost of \$98 per inmate, per day, in an amount not to exceed \$107,000. (Chairman Sergio Granados)

Freeholder Mirabella asked if the \$98 a day rate was consistent with last year.

Director Charles stated that it was consistent (no change from last year).

7. Authorizing the County Manager to enter into a Memorandum of Agreement (MOA) with the New Jersey Reentry Corporation for the purpose of allowing inmates, who voluntarily desire, to participate in NJRC's social programs, including services related to removing barriers to employment, employment preparation, skills training, biopsychosocial assessments, healthcare referrals, addiction treatment linkage, driver's license restoration and birth certificate retrieval. Contract period December 20, 2018 through December 1, 2021, there is no cost to the county. (Chairman Sergio Granados)

DEPARTMENT OF ECONOMIC DEVELOPMENT

Amy Wagner, Deputy County Manager/Director_

There were no questions or inquiries from the Board.

1. Authorizing the County Manager to enter into a contract agreement with Monmouth Telecom, Red Bank, NJ, for the purpose of providing integrated voice and data services to the County of Union for a three-year period beginning on January 1, 2019 through December 31, 2021, with a one-time set-up fee of \$400, monthly service fee of \$1,885, and an amount of \$23,020 for year one, an amount of \$22,620 for year two, and an amount of \$22,620 for year three, for a total amount not to exceed \$68,260. Freeholder Hudak asked if Resolution Numbers 4 through 10 were renewals for next year.

Director Graziano stated that was the case, and added that they are just for on-call services.

DEPARTMENT OF FINANCE

Bibi Taylor, Director

- 1. Canceling unexpended grant account balances in the listed Grant Accounts. (Freeholder Bruce H. Bergen)
- 2. Cancelling Capital Balances to Capital Surplus and Deferred Charges Unfunded. (Freeholder Bruce H. Bergen)

Freeholder Hudak asked for more details relative to Resolution #2.

Director Taylor stated that those are for various capital projects deemed complete, noting that the County would therefore be cancelling \$969,000 to capital surplus and \$2.1 million as cancellations to deferred charges.

Freeholder Hudak asked if these were projects that we funded and we didn't do or projects funded and didn't spend the funded amounts.

Director Taylor indicated that it is a combination of projects that were authorized, so those that are lapsing to capital surplus were the items that were funded. She advised that the \$2.1 million were authorized by board but unspent. She added that those projects were deemed complete, so the County didn't issue bonds. She stated that the \$2.1 million will go towards reducing the County's gross debt, even though they are considered "differed charges unfunded."

Freeholder Hudak asked Director Taylor to confirm that the County is reducing its Capital debt by \$2 million.

Director Taylor advised he was correct.

Freeholder Mirabella asked what the total in the capital surplus (in light of transferring \$1 million).

Director Taylor advised that the County has over \$5 million in capital surplus, and as a result of this resolution, the County will have \$6 million.

Freeholder Mirabella asked how do projects get funded out of this new capital surplus ("pool of capital surplus funds")..

Director Taylor answered that the County would need a specific capital ordinance to fully fund a specific project. She noted that the County have done that in prior years. She advised that the Vo-Tech School approached the County six years ago for a project in advance of the typical Capital Project cycle. She advised the County was able to use the Capital Surplus to fund that project.

Freeholder Mirabella inquired if these funds could be retired.

Director Taylor stated that the capital surplus can only be utilized. She stated that these are funds we are taking off a debt capacity which cannot be utilized until a specific project is identified. She advised that the Capital Surplus is cash, as they were funds that were authorized and expended at one point in time for a specific project.

Freeholder Hudak inquired as to the number of times the Capital Surplus has been utilized for a project.

Director Taylor advised that capital surplus can be anticipated as a source of revenue in the budget that has to be applied to a capital expense.

Freeholder Hudak inquired as to the amount utilized from this fund in 2018.

Director Taylor advised that the County did not utilize any funds in 2018.

Authorizing the County Manager to award professional services contracts in an amount not to exceed \$188,000.00 for the period of January 1, 2019 through March 31, 2019 to provide additional professional psychiatric medical services to patients of Cornerstone Behavioral Health Hospital of Union County. Chairman Granados asked for an explanation as it relates to the type of subcontracted services.

Director Anderson stated that this is a project through the Human Services Advisory Council (HSAC) that goes out to the communities. She stated that the Family Support program provides flex funds and case management services for family success initiatives. She stated that the contract was obtained by an RFP (like last year). She stated that the United Way of Union County received the funding this year, adding that there are about 358 families serviced the throughout the years.

7. Authorizing the County Manager to award 2019 Social Services for the Homeless (SSH) Spending Plan subcontracts for the twelve (12) month budget period of January 1, 2019 through December 31, 2019 in the total amount not to exceed \$791,389; further

authorizing the transfer of funds among the awarded agencies during the contract period should service needs change and/or if any fails to meet its contractual obligation; and further authorizing a one-time advance payment of up to one month of the award for the agencies to carry out the program activities.
