

# UNION COUNTY BOARD OF CHOSEN FREEHOLDERS

## THURSDAY, OCTOBER 25, 2018 MINUTES OF THE AGENDA SETTING MEETING

## CALL TO ORDER

Chairman Sergio Granados presided and called the meeting to order.

## ROLL CALL

Roll call showed Chairman Sergio Granados, Vice Chairman Bette Jane Kowalski, Freeholder Bruce H. Bergen, Freeholder Angel G. Estrada, Freeholder Angela Garretson, Freeholder Christopher Hudak, Freeholder Alexander Mirabella, Freeholder Mohamed S. Jalloh and Freeholder Rebecca Williams present. County Counsel Robert Barry and Clerk of the Board James Pellettiere were also present.

The meeting took place at the City of Summit City Hall, 512, Springfield Ave., Summit, NJ.

## PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

## STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by the Clerk of the Board Pellettiere.

## PRESENTATIONS FROM THE BOARD

Chairman Granados thanked the Mayor Nora G. Radest of the City of Summit for allowing the Freeholder Board to conduct the meeting at Summit City Hall. He added that the Board would be visiting the Town of Westfield in the coming weeks.

Check presentations were made by the Board to the recipients of the 2018 Kids Recreation Trust Grant and 2018 Greening Union County Grant programs, funded through the Union County Open Space, Recreation & Historic Preservation Trust Fund.

Freeholder Mirabella made remarks describing the Greening Union County Grant program. He called upon the members of the Union County Open Space Public Trust Fund Advisory committee, Ed O'Malley of Cranford, Arthur Kobitz of Hillside, and Mike Deshenko of Union who were in attendance and asked them to stand and be acknowledged. He stated that this committee provided significant input regarding this program.

Chairman Granados and Freeholder Mirabella then called upon Berkeley Heights Council Members Michael D'Aquila and Michelle Greco. Mr. D'Aquila thanked the Board on behalf of the municipality.

Freeholder Mirabella then called upon Ralph Bernardo of Clark to step forward. Mr. Bernardo made remarks about a planned new playground in Clark in memoriam of Caitlin Nelson, a resident who passed away, and thanked the Board.

Freeholder Mirabella then called upon Steve Rinaldo of the City of Elizabeth, to step forward. Mr. Rinaldo thanked the Board on behalf of the City, and described some of the planned uses for the grant, a synthetic turf field and tree implantation. Freeholder Estrada then joined Mr. Rinaldo and Freeholder Mirabella and Chairman Grandos in a photograph.

Freeholder Mirabella then called upon Robert Budiansky and Bruce Zakarin of Fanwood to step forward. Mr. Budiansky explained the borough's master plan for the grant including fields and landscaping.

Freeholder Mirabella then called upon Councilmember Sara Todisco of Garwood to step forward. Ms. Todisco thanked the Board and spoke about an ongoing park project to which the grant will be applied.

Freeholder Mirabella then called upon Jason Johnson, Recreation Director, and Arthur Kobitz, Advisory Board Volunteer, of Hillside, along with Freeholder Angel Garretson to step forward. Mr. Johnson thanked the Board and explained that the grant will go toward a playground project, to add equipment.

Freeholder Mirabella then called upon Councilwoman Kay Ceceri of Kenilworth to step forward. Councilwoman Ceceri thanked the Board and stated that the grant would be used for renovations on a recreation center. Freeholder Mirabella called upon Sheriff Peter Corvelli to be a part of the photograph with the Councilwoman.

Freeholder Mirabella then called upon Freeholder Christopher Hudak, Frank Dann, Nancy Braxton and John Roman of Linden to step forward. Frank Dann made remarks thanking the Board, stating that this will be used for playground development. He also gave a special thank you to Victoria Durbin of the Office of Open Space, Recreation and Historic Preservation Trust fund.

Freeholder Mirabella then called upon Mayor Paul N. Mirabelli of Mountainside to step forward. Freeholder Mirabella remarked upon the similarity of his name and that of the Mayor, stating that they are often confused with each other. The Mayor thanked the Board on behalf of the Council and community, and stated that the money would be used to refurbish basketball courts, purchase Four Square layouts, and for a lightening detection system for the playing fields. He also challenged his friends to a Four Squares tournament.

Freeholder Mirabella then called upon Mayor Al Morgan, Councilman James Madden and Recreation Director Bernadette Cuccaro of New Providence to step forward. Mayor Morgan said the grant would go toward a new project for Special Needs children called Harmony Park.

Freeholder Mirabella then called upon Business Administrator Carlos Sanchez of Plainfield to step forward. Mr. Sanchez thanked the Board on behalf of the City of Plainfield.

Freeholder Mirabella then called upon Recreation Director Anthony Deige and Councilman Dave Brown of Rahway to step forward. Mr. Deige thanked the Board and stated the some of the grant would go toward renovation of the football field, and Councilman Brown thanked the Board and added that some of the funds benefit the entire community and enhances a great many of the activities available.

Freeholder Mirabella then called upon Recreation Director Donald Shaw of Roselle to step forward. Mr. Shaw thanked the Board and stated that the grant would go toward the preservation of parks and implanting of trees.

Freeholder Mirabella then called upon Councilman Michael Connelly and Municipal Clerk Andrew Casais of Roselle Park to step forward. Mr. Connelly thanked the Board, and stated that the grant will be used for renovations of parks and implanting of trees.

Freeholder Mirabella then called upon Deputy Administrator Margaret Heisey and Recreation Director D.J. Salvante of Scotch Plains to step forward. Freeholder Mirabella noted that Mayor Alexander Smith had been on his way but was inconvenienced by a flat tire. Mr. Salvante thanked the Board and stated that the grant funds would be used for upgrades to a playground and playing fields. Ms. Heisey added that some of the money would also be used toward a Tree Replacement program.

Freeholder Mirabella then called upon Freeholder Bergen to join him, and then called upon Mayor Richard Huber, Adam Lieb, Michael Butrico and Robert Boettcher of Springfield to step forward. Mayor Huber thanked the Board and stated the grant funds would go toward tree implantation and toward a Special Needs park.

Freeholder Mirabella then called upon Mayor Nora Radest, who introduced Councilpersons Marjorie Fox, Beth Little, Matthew Gould, Mark Ozoroski of the department of Community Programs of Summit. The Mayor commented that the grant funds would go toward planting trees and toward some work on a senior recreation area.

Freeholder Mirabella then called upon Freeholder Jalloh to join him, and then called upon Michael Yesenko and Assistant Superintendent of Recreation John Moritti of the Township of Union to step forward. Mr. Morritti made remarks thanking the Board.

Freeholder Mirabella then called upon Administrator James Gildea of Westfield to step forward. Mr. Gildea stated the grants will go toward tree planting and toward a bathroom facility in a park.

Freeholder Mirabella thanked all of the Municipalities for the work they do to improve the lives of the citizens of the County of Union each day.

## OFFICE OF THE UNION COUNTY SHERIFF

Peter Corvelli, Union County Sheriff

1. Authorizing the County Manager to enter into an agreement with Axon Enterprise, Inc., Scottsdale, Arizona, for the purchase of new add on hardware and licenses and replacement of current body cameras and belt clips for use by the Union County Sheriff's Officers in an amount not to exceed \$25,147.00. (Chairman Sergio Granados)

Freeholder Bergen asked the Sheriff to elaborate on what is to be purchased in item #1. The Sheriff explained that the cameras need to be updated.

## OFFICE OF THE UNION COUNTY PROSECUTOR

Michael A. Monahan, Acting Prosecutor

Tom Koundry represented the Office of the County Prosecutor.

1. Authorizing the County Manager, through the Office of the Prosecutor, to apply for and accept funding from the U.S. Department of Justice, Office for Victims of Crime for the FY2018 Law Enforcement-Based Direct Victim Services and TA Program Purpose Area 1: Direct Services grant program for project titled UCPO Office of Victim/Witness Advocacy: "Project Direct" in the amount of \$824,256.00 for the period of October 1, 2018 through September 30, 2021. (Chairman Sergio Granados)

The Chairman asked Mr. Koundry to expand upon item # 1. Mr.Koundry said that it was a three year grant to aid victims.

2. Amending Resolution number 2018-645, an agreement with Thermo Fisher Scientific/Life Technologies of Carlsbad, CA for the purchase of proprietary reagents and supplies reflecting a change in amounts assessed to specific grant accounts only: to increase account number G-02-17-306-863-487 an additional amount of \$11,000.00; increase account number G-02-17-306-863-451 an additional amount of \$1,570.00; and reduce account number G-02-18-306-863-451 by \$12,570.00. (No change in total amount of contract.) (Chairman Sergio Granados)

Freeholder Hudak asked Mr. Koundry to explain about the training being paid for in item #3. Mr. Koundry explained that it was not for a specific training session but also for instructions on using various types of equipment. The County accepts the funds and then the uses are to be determined.

3. Authorizing the County Manager to apply for and accept funding from the State of New Jersey, Office of the Attorney General, Department of Law and Public Safety under the SFY 2018 Law Enforcement Officers Training and Equipment Fund (LEOTEF) grant, for the period of July 1, 2018 through June 30, 2019, in the amount of \$16,793.00 (Chairman Sergio Granados)

## **DEPARTMENT OF ADMINISTRATIVE SERVICES**

Michael Yuska, Director

1. Authorizing the County Manager to award a contract to Medcom, Birmingham, AL to provide Retiree Benefit Billing Services and COBRA Administration Services from November 1, 2018 through October 31, 2019 for an amount not to exceed \$36,000 with an option to renew for one 12-month period through the recommendation of our insurance broker. (Chairman Sergio Granados)

Freeholder Estrada asked Director Yuska how many employees are covered under the plan in item #1. Director Yuska explained that the COBRA services are federally mandated, and this company manages those benefits, and that there are 281 cases at this time but that there are thousands of retirees that can be added on.

Freeholder Mirabella asked if the firm is the same one as last year, the Director replied that it is the same firm, and that the insurance broker presented this company, and that the pricing is the same as last year.

## DEPARTMENT OF ENGINEERING, PUBLIC WORKS & FACILITIES MANAGEMENT

Joseph Graziano, Director

Thomas Mineo, County Engineer, represented the department. Freeholder Estrada asked a question on item # 5, asking if it is temporary or regular fencing. Mr. Mineo replied it is regular fencing. Freehold Hudak asked regarding #5, asking how much of the previous contract amount was expended. Mr. Mineo replied that the County spent \$316,000.

Freeholder Hudak asked regarding item #3, asking what services are being provided. Mr. Mineo said he would provide the Board with a list of services. He added that these services take place throughout all County facilities.

1. Authorizing the Cancellation of Unissued Bond Balances (guaranteed Bonds of the Union County Improvement Authority) in an amount totaling \$8,150,418.00. (Freeholder Bruce H. Bergen)

Freeholder Estrada asked regarding item #1, if this cancellation has ever been done before. Director Taylor replied that this has happened in the past, and is an effort to clean of the books. Freeholder Estrada asked if there was an interest rate associated with these bonds. Director Taylor said there are no debts associated with these bonds. These funds were not used.

Freeholder Hudak asked if these balances are not cancelled, is that held against the County when it goes out to borrow again. Director Taylor said that is correct. Freeholder Hudak stated that these bonds were for funding for Improvement Authority projects involving the Courthouse and Oakwood Plaza, and that these cancellations mean that the County borrowed less than the County authorized on those projects. Director Taylor concurred. She added that last year the County eliminated \$900,000 in unfunded debt last year.

Chairman Granados commented that item #4 is a great program, and Director Anderson elaborated on what the program provides, and how one shelter has closed and other provision had to be made, and that 5,000 plus constituents were served between November and April, last year into this year.

Freeholder Estrada also commented that the program saves lives. Chairman Granados also lauded the program and noted that the Director had personally supervised some of the facilities last year.

- 5. Amending Resolution 2018-870, increasing the 2016-2018 Area Plan, to reflect an additional increase in funding only in the amount not to exceed \$1,275 for a new grand total not to exceed \$5,132,687 to be allocated as outlined and charged to account numbers specified for the same contract year three period of January 1, 2018 through December 31, 2018 with no other changes to the 2016-2018 Area Plan. (Freeholder Angela R. Garretson)
- 9. Approving a pre-qualified list of Medical Staff for the provision of Psychiatric Care Services to Cornerstone Behavioral Health Hospital of Union County for the period of November 1, 2018 through December 31, 2019. (Freeholder Angel G. Estrada)

Freeholder Mirabella asked the Director to elaborate on the Patrol fleet and equipment being procured in item #1. The Director said that this equipment is not under state contract and had to go out for bid.

Freeholder Estrada asked regarding item #1, if the County was still utilizing Shared Services programs for installations. The Director said that there is a program to get the equipment, but installation is not covered. Freeholder Estrada asked regarding item #6, asking if the work is being done toward a new facility, or for renovations. The Director said the funding could have been allocated for either, and that in this case it is for renovations.

Chairman Granados also commented on the question on expanding the Fire Academy facilities and new construction. Freeholder Mirabella asked the Director to give more information at the next meeting on future construction and renovations at the Fire Academy.

Freeholder Hudak asked questions regarding the dollar amount in item #2, and asking what is noteworthy in this year's grant. The Director highlighted funding going to first responders and law enforcement, and large-scale fire-fighting training.

Vice Chairman Kowalski asked about the search and rescue part of the grant. The Director elaborated on the specifics of this training which involves rescues from building collapses.

Chairman Granados asked the Director to elaborate on item #4, and the Director described the training in detail.
