CALL TO ORDER

Chair Bette Jane Kowalski presided over the meeting and called the meeting to order at 7:01pm.

PRESENTATION BY THE BOARD

PUBLIC COMMENT PORTION

This meeting is open to the public comment on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Ray Lacotta of Cranford made comments or inquiries regarding a proposed cell tower and distributed antenna system for Union County College's campus in Cranford. He proposed the campus can use a DAS (Distributed Antenna System) or an ODAS (Outside Distributed Antenna System) rather than the cell tower. He noted their language regarding the cell tower in their proposals or resolutions is intentionally confusing and asked why is an educational institution concerned about providing cell coverage to residents in Cranford, all the way

down to the train station. Lacotta suggests it is for money/profit and they do not need to be in the business of providing coverage to the surrounding areas; they only need the Distributed Antenna System and nothing more. Lacotta explains that the proposed cell tower will be 230 feet from the nearest residence. He concluded his comments with concerns relative to negative health effects from the cell tower.

Ms. (Inaudible) of Cranford also made comments or inquiries regarding the Union County College Cranford campus' proposed cell tower. She stated she came before the Board a few years ago when UCC wanted to cut down 700 trees in the woods of the college parking lot in order for them to build a sports field. She thanked the Board for helping the neighborhood maintain its character by offering UCC an alternative site for the sports field. She stated the proposed tower will impact the Northside of Cranford and Westfield and it is estimated that the cell tower can decrease the value of nearby homes up to 20%. She asks the Board to help find alternatives and to keep Union County College as a good neighbor.

Mike Norman of Cranford made comments or inquiries regarding the UCC cell tower, stating Union County College must stop and be a good neighbor to our community and not build a cell tower.

Mariette Horn of Cranford made comments or inquiries regarding the cell tower as to why UCC is allowed unfettered commercial development on public property. She states under any other circumstance, this kind of development would not be allowed under local planning and zoning guidelines, which would restrict anything like this within such close proximity to an established residential property. Ms. Horn noted the tower will be approximately 500 feet from her bedroom, and is concerned for her health and the market value on her home. Ms. Horn concluded her comments by stating her perceived view of negative relationships between the president of Union County College, the Board, and the directors of Verizon.

Freeholder Estrada stated in reference to the cell tower, he would like to get the name of the reports mentioned because he has not come across certain information mentioned by those during the Public Comment Portion. He advised those who publicly commented to speak with him after the meeting to try and get the reports to find out further information.

FREEHOLDER REPORTS AND COMMENTS

Freeholder Garretson began her comments by recognizing this meeting as the first official regular meeting as a full Board. She then congratulated Chair Kowalski, Vice Chairman Mirabella, Freeholder Staten, Freeholder Palmieri-Mouded, and Freeholder Williams. Freeholder Garretson stressed the importance of voting announcing an "I Voted" sticker contest within the County for $5^{th} - 12^{th}$ graders. She gave recognition to Martin Luther King, Jr. Day followed by a quote. She stated her and Freeholder Granados, along with Governor Phil Murphy and the Attorney General, had the opportunity to speak at New Hope Baptist Church in Elizabeth to represent the importance of service (to the community). She noted that next month is Black History Month and advised that for the first time the County will do a flag raising event on February 1st to recognize the attributes and contributions of the black community. To conclude, she advised the public that if there are reports that Freeholders have not seen to please share these reports with the Board.

Freeholder Palmieri-Mouded made comments regarding attending the farewell ceremony for the first squadron 102nd Calvary regiment for their deployment this week wishing them a success and safe return. She stated that during President's Day weekend, the Trailside is

offering their February festivities program and you can find information regarding these activities on our website. She concluded her comments by giving congratulations to those who contributed to the Sensory Friendly Trail which received an award for excellence in design from the New Jersey Recreation and Park association.

Freeholder Estrada referenced the Cranford residents regarding the cell towers approval process and that it was sent to the state in Trenton. He advised the public he was interested in the reports with the information on the negative effects of the cell tower as he has not seen evidence supporting those statements so far. Regardless of that information, he advised that the Board does not approve of that particular contract regarding the cell tower.

Freeholder Staten began by thanking her colleagues for their guidance and leadership. She mentioned that January is cervical cancer awareness month and that regular screenings are critical to prevention and early detection. She announced Union County will be holding their 3rd annual "Union County Means Business" networking event at Kean University on February 20th. She noted it is open to Union County business owners, managers, and entrepreneurs and Lina Cohen will be the featured guest at this event. Freeholder Staten then made comments relative to her participation in the Union County Point in Time Count to find homeless families in order to offer them shelter, food, clothing, and services. She thanked everybody involved for their services and support.

Freeholder Granados made comments in reference to the Union County College cell tower. He explained that the main concern provided by UCC students, administration, and the public is that this is a public safety issue; it is not an issue in reference to making money. He noted his personal experience relative to the lack of reception on campus and advised that the Board is willing to listen to and see all the different information the public has regarding the cell tower.

Freeholder Granados then made comments regarding the Recycle Coach app and has reported that Union County has partnered with 21 municipalities last year to make this service available to all residents. He stated that Union County is the first and only county in New Jersey to have all municipalities participating in Recycle Coach.

Freeholder Williams made comments regarding additional Black History Month events: February 2nd the organization United Youth of New Jersey will be presenting Harlem Renaissance: Another Black Wall Street at the Ritz Theater in Elizabeth; February 9th the County will gather at the UCPAC in Rahway to honor Monte Brooks, lifelong Linden resident, who will be the recipient of the 7th annual Chester Homes Humanitarian award, followed by a concert version of the Broadway musical: Aint Misbehavin'; February 20th Doctor Melissa Cooper will discuss how the study of Sapelo Island Culture in the early 20th century can still provide us with insights into the rise of social sciences, black studies movement, and land struggles of coastal black communities.

Freeholder Hudak thanked the Human Services staff, volunteers, and law enforcement professionals who took part in the Point in Time Count. He stated the County has a great team out there assisting those who do not have shelter in this cold weather. Freeholder Hudak made comments in regards to the February 9th event at UCPAC, noting that former councilman Monte Brooks is an educator and coach and has worked tireless with young people in Union County for many years. He enjoyed attending a number of events, for example, the Union County celebrity bartending event in anticipation of the parade in March, events regarding the celebration of the life of Dr. Martin Luther King, Jr., and the

morning star Christian community center in Linden for their annual celebration. Freeholder Hudak concluded by making comments to the residents from Cranford regarding the cell tower and noted that he observed the city of Linden install a similar tower approximately the same amount of feet away from his residence for emergency communication. He stated the public's concerns in terms of this change are understandable and encouraged them to speak with local zoning officials and the college regarding their concerns.

Vice Chairman Mirabella made comments regarding Martin Luther King, Jr. Day; he stated that he had the pleasure to participate in a service in Fanwood where they honored Malcolm Nettingham, Scotch Plains resident, who was a World War 2 soldier and airman. Mr. Nettingham is 100 going on 101 years old. He noted he also attended the Westfield Armory with Chair Kowalski and Freeholder Granados where there they bid farewell to the first squadron 102nd Calvary on their deployment. This squadron is made up of 250 soldiers and 120 of which are from Union County. The Board is proud of their commitment to serve our country and joined in on congratulating the families on their sacrifices during that period of deployment. He advised that the Union County Office of Veteran Affairs is available to offer resources and guidance through our Union County hero program which seeks to increase awareness of eligibility, entitlements, benefit programs, and services provided to our veterans in Union County by other agencies. Vice Chairman Mirabella then made comments regarding the Union County College cell tower stating it is his understanding that it is a safety issue and not a monetary issue from a college standpoint. He urged the residents in that area of the proposed cell tower to constrain their remarks to facts and not innuendos and cautioned the public from making inappropriate accusations.

Chair Kowalski also made comments regarding Union County College that it is an autonomous body and they make their own decisions. She stated the Board has had communications with them on this topic, and will be doing so again. She encouraged the public to communicate with the college and Jamie Segal can direct you on how that is best done. She thanked everyone who participated in the farewell to the troops of the Army National Guard and noted she has a nephew who is a navy pilot and has been deployed far away for many months at a time. Chair Kowalski thanked the Human Services department and all the volunteers who helped with the Point in Time Count. She stated it is a rough time for federal workers at the moment during the partial government shutdown; there are almost 500 federal employees who live in Union County. To assist those in need during this time, Union County has set up a web page with links to resources and suggestions for making donations. Food and security is the biggest issue facing workers without a paycheck. She advised SNAP recipients they should be aware of false rumors: that they must use or spend their allotment before the end of January. SNAP recipients should disregard these rumors and be assured that they may be able to use their EBT card allotment to make food purchases until the amount runs out. Federal employees who would like to enroll in SNAP may do so at County offices throughout February if the shutdown resumes.
