Chairman Kowalski called for a motion to approve the Minutes. On a motion made by Freeholder Granados and seconded by Freeholder Staten, roll call showed seven votes in the affirmative for the January 6<sup>th</sup> reorganization meeting as well as the January 17<sup>th</sup>, January 24th, February 21<sup>st</sup>, March 7<sup>th</sup>, March 14<sup>th</sup>, Match 28<sup>th</sup>, and April 25<sup>th</sup> respective agenda setting and regular meetings; six votes in the affirmative for the February 17<sup>th</sup> agenda meeting, with Freeholder Estrada abstaining; five votes in the affirmative for the February 14<sup>th</sup> regular meeting, with Freeholder Garretson and Freeholder Staten abstaining; six votes in the affirmative for the April 4<sup>th</sup> agenda meeting and April 11<sup>th</sup> regular meeting, with Freeholder Garretson and Freeholder Staten abstaining; six votes in the affirmative for the April 4<sup>th</sup> agenda meeting and April 11<sup>th</sup> regular meeting, with Freeholder Garretson abstaining.

### SUSPENSION OF THE RULES

Chairman Kowalski outlined certain changes to customary meeting procedures that would be in effect as a means to accommodate the large volume of people wishing to speak relative to Resolution No. 2019-414.

Chairman Kowalski called for a motion to suspend the rules. On a motion made by Freeholder Granados and seconded by Freeholder Garretson, roll call showed seven members of the Board voted in the affirmative; with Vice Chairman Mirabella and Freeholder Hudak absent.

## PUBLIC COMMENT PORTION

The meeting was opened to the public for the purpose of commenting on Resolutions being offered for adoption only.

Bruce Paterson, of Garwood, made comments relative to the suspension of the rules as well as several resolutions. Relative to Resolution No. 2019-390, he asked for the price of the extension option. Relative to Resolution No. 2019-401, he asked for the original contract amount. Relative to Resolution No. 2019-403, he asked the Board to elaborate on the settlement. Relative to Resolution No. 2019-413, he asked for a dollar amount relative to the increase in funding.

Chairman Kowalski reiterated the reasoning behind the cited modifications to the traditional meeting format, noting that speaking time for members of the public had been adjusted to 3 minutes.

Relative to Resolution No. 2019-390, Director Anderson advised that this item related to a new annual contract that would cost \$367,000 for the initial year. She added that opting to extend the contract for another year would yield the same cost.

Relative to Resolution No. 2019-401, Division of Facilities Management Director Charles Chirafesi, representing the Department of Engineering, Public Works and Facilities Managements, advised that the original contract amount was \$230,780.

Relative to Resolution No. 2019-403, County Counsel Barry advised that the item related to an extensive personal injury matter. He added that under the recommendation of County Counsel and other independent counsel, a settlement of \$375,000 was accepted. He further

added that under the terms of the insurance policy, the county was required to furnish the first \$250,000 of the settlement amount, with the insurance company responsible for the difference.

Relative to Resolution No. 2019-413, Chairman Kowalski noted that the state had yet to approve their respective budget, hence why no amount was cited in the resolution. She added that NJ Transit has long since been neglected which is why the Board supports increases in funding to facilitate necessary improvements and additions.

Chairman Kowalski read the body of Resolution No. 2019-414 in its entirety.

Justin Quinn, of Cranford, and member of No High Voltage Cranford (NHVC) outlined his concerns relative to the high-voltage powerlines.

David Krieger, of Westfield, outlined a similar plan scheduled for Westfield, noting that overwhelming resident response managed to temporarily thwart the plans, until a more feasible route could be proposed. He offered his support to Cranford residents facing a similar plight and argued against the necessity of the proposed project.

Pamela Kevelson, of Westfield, expressed her opposition to the proposed route of the powerlines, noting that PSE&G was researching alternative, less disruptive routes in Westfield for the project. She outlined her concerns relative to PSE&G and offered recommendations to the Board as a means to impede such projects in the future.

Kathy D'Amobla, of Cranford, expressed her concerns and opposition relative to the proposed high-voltage powerlines, outlining several perceived health-related risks associated with the project. She thanked the Board for their support as it relates to addressing and seeking an amicable solution to this issue.

Mona Purse, of Westfield, expressed her concern and support for those potentially impacted by the project. She questioned PSE&G's practices, in particular their failure to provide residents with adequate notice regarding the project, which she feels was deliberately done to mitigate community involvement and opposition.

Burim Regjaj, owner of Outta Hand Pizza in Westfield, expressed his concerns relative to the project and the negative short-term and long-term effects it could ultimately have on his business. He clarified that he was not opposed to the project, but rather PSE&G's approach to the project, which in his opinion demonstrates complete disregard for the community and its residents.

Jerome Feder, of Westfield, thanked the Board for their support and interest in the issue. He referenced a report submitted to Congress by the National Institute of Environmental Health Sciences which addressed the potential health-related hazards associated with exposure to various types of radiation, noting alternatives that could be considered to limit exposure.

Teresa Bowers, of Cranford, outlined several of her concerns related to the high-voltage powerlines, including the perceived health-related risks attributed to being in close proximity to such radiation. As a nurse practitioner, she noted that while existing studies and research did not directly identify radiation as the cause of certain ailments, residential concerns are valid as risks/dangers cannot be completely discredited and or dismissed. She concluded by thanking the Board for their support in addressing the issue.

Richard Hurley, of Cranford, and President of the Cranford Education Association thanked the Board for supporting the residents' stand against the proposed project. He outlined several potential dangers posed by these high-voltage powerlines corresponding to their close proximity to several elementary schools and daycare centers. He also expressed his concerns relative to the negative effects of these power lines on property values. He closed by questioning the means and motivation of PSE&G in furthering the project, noting their perceived lack of regard for those immediately affected.

Angela Petschow, of Cranford, noted PSE&G's perceived lack of transparency relative to the potential hazards of these high-voltage powerlines. In particular, she referenced the use of potentially toxic chemicals like Pentachlorophenol (Penta), among others to treat and maintain existing and prospective powerlines, noting several alarming side-effects associated with exposure to such chemicals. She recommended that PSE&G pursue alternative measures to further the project or otherwise be held accountable for the potential consequences of their methods and practices.

Kathleen Curran, of Cranford, outlined her concerns related to the powerlines and the potential health-related risks. She thanked the Board for their support and implored them to continue their involvement in hopes of reaching a solution to the problem.

Lyubov Ursic, of Cranford, expressed her concerns relative to the project and questioned the approach and motivations of PSE&G. She asked the Board for their continued support as a means to compel PSE&G to pursue more reasonable alternatives to the proposed project.

Cranford Commissioner Mary O'Connor thanked the Board for the resolution, noting its critical importance relative to the issue and the overall concern surrounding the project, mainly the proposed route and the process through which the project will be achieved. She noted her recent attendance at the PSE&G forum where she had the opportunity to talk with several representatives from the organization as well as members of the community regarding the project. She noted the overwhelmingly negative response from residents which she hoped would positively affect the outcome of the project.

Diana Maldonado, of Cranford, and member of No High Voltage Cranford noted her prior experience with Occupational Safety and Health Administration (OSHA) and expressed her concerns relative to the personal protective equipment (PPE) required by PSE&G employees when performing work on utility poles as a means to safeguard them against the chemical agents used to treat the powerlines. She closed by citing the safety and well-being of her children and the children of other residents as her main concern and the driving force behind her opposition.

Bryn Llyod Bollard, of Cranford, otulined the importance of trees and expressed his opposition to having several trees removed along the proposed route. He noted that although PSE&G was willing to replace the removed trees with saplings, the latter would dull in comparison to the fully flourished trees already on site. He concluded by referencing a recent traffic accident on his street, in which a truck snagged a powerline and expressed his concerns relative to how the proposed high-voltage powerlines could have augmented the circumstances and outcome of the traffic incident.

Dr. Kurt Krause, of Cranford, noted the county's responsibility to its residents to fully investigating the necessity of and the potential health-hazards associated with the proposed project.

Mary O'Flynn, of Cranford, thanked the Board for Resolution No. 2019-414. She expressed her concerns relative to the proposed project, outlining instances of how the project seemingly violates certain prescribed regulations of county roads and asked the Board to use these perceived violations to investigate the matter further and ideally influence the outcome.

Christine Javornicky, of Cranford, expressed her concerns relative to the powerlines and argued the case for a less disruptive route for the proposed project.

Nicole Quinn, of Cranford, thanked the Board for their support and asked them to seriously consider and heed the concerns of residents opposed to the project. She outlined her concerns relative to PSE&G and the methods employed thus far to further and complete the proposed project.

David Pringle, of Cranford, outlined his concerns relative to the project. He thanked the Board for their support, noting that due to the overwhelming response received in opposition to the proposed project, PSE&G was seemingly taking into greater consideration the concerns of residents and reviewing alternative routes for the project.

Seeing no additional speakers wishing to comment, Chairman Kowalski closed the public comment portion.

# PUBLIC COMMENT PORTION

Chairman Kowalski thanked the residents and members of the public in attendance for their participation, research, and efforts relative to the Resolution No. 2019-414, noting that PSE&G was considering alternative routes for the proposed project as a result of negative community response.

Freeholder Garretson likewise commended the residents for their concern and efforts, noting her discussions with representatives from PSE&G relative to the issue. She advised that although residents had done great work so far, additional work was required. She encouraged residents to document and maintain a detailed log citing their interactions with PSE&G and keep the Board abreast on any related discussions and developments.

The meeting was opened to the public for comment on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Virginia Zachariades, of Cranford, outlined her many attempts and methods for communicating with PSE&G.

David Pilmensten, of Springfield, expressed his concerns related to election candidates leveraging public property for campaign purposes.

County Counsel Barry advised that the county was aware of these infractions and advised that the Board of Elections had been alerted to the issue and was asked to take appropriate action to remedy the problem.

Ronald McCray, of Rahway, expressed his concerns related to drivers' disregard for the cited speed limit on East Hazelwood Ave in Rahway.

Christy Dobles, of Elizabeth, noted that she had been a grant recipient in 2018 and wanted to provide an update to the Board relative to her awarded grant. She provided handouts to Clerk of the Board Pellettiere to distribute amongst the Freeholders.

Bruce Paterson, of Garwood, made comments relative to Resolution No. 2019-414. He also congratulated the winners of the poetry contest, noting a strong display by Garwood. He also referenced NJ Transit, citing certain improvements he would like to see introduced.

Seeing no speakers wishing to comment, Chairman Kowalski closed the public comment portion.

He stated that the Clerk of the Board shall retain the original minutes until such time as the confidential limitations have been removed, at which time they shall be made available.

He stated that upon affirmative vote of the majority of the members present, the Board may enter Executive Session and upon the Board's return may take formal action on the matter discussed.

Chairman Kowalski asked for a motion to enter into Executive Session. On a motion made by Freeholder Granados and seconded by Freeholder Williams a voice vote showed seven members of the Board voted in the affirmative; with Vice Chairman Mirabella and Freeholder Hudak absent.

Chairman Kowalski asked for a motion to return from Executive Session. On a motion made by Freeholder Williams and seconded by Freeholder Staten a voice vote showed seven members of the Board voted in the affirmative; with Vice Chairman Mirabella and Freeholder Hudak absent.

# FREEHOLDER REPORTS AND COMMENTS

Freeholder Granados reminded residents that the Board along with PALCUS would be hosting the first Portuguese Flag Raising Ceremony in front of the Union County Court House on Broad Street on May 30<sup>th</sup>. Relative to PSE&G, he thanked residents for participating in the forum that evening and reassured them that the Board was working diligently to resolve the issue with the community's best interest at the forefront.

Freeholder Williams issued a reminder relative to the public meeting on Tuesday, May 21 at McManus Middle School on the opioid crisis. She added that the forum would provide critical information as well as tools to tackle the growing issue. She also mentioned the upcoming Rhythm & Blues by the Brook festival taking place on June 1<sup>st</sup>, at Cedar Brook Park in Plainfield.

Freeholder Staten reminder residents about the Master Gardeners' Garden Fair and Plant Sale near the Trailside Nature and Science Center in the Watchung Reservation. She also mentioned the upcoming Union County Women Mean Business seminar at The Clubhouse at Galloping Hill Golf Course in Kenilworth. She thanked the sponsors of the event, in particular Shoprite of Clark for their generous donations.

Freeholder Estrada commented on the overwhelming response received from the community in opposition to PSE&G's proposed project. He expressed his excitement to see residents passionately involved in trying to bring about change related to a concerning development in their community. He commended the participants that evening for being well-versed on the topic and providing valid arguments to support their stance. He also expressed his desire to have the issue addressed and resolved in favor of the affected individuals.

Freeholder Palmieri-Mouded advised that a new clubhouse, which includes a restaurant and pro shop, among other features would be unveiled at Ash Brook Golf Course in Scotch Plains on May 22. She also thanked the residents in attendance for their participation in the discussion related to the PSE&G high-voltage powerlines. As a Westfield resident and mother, she expressed that she too shares similar concerns regarding the project and hopes that PSE&G pursues safe and appropriate routes for the projected upgrade.

Freeholder Garretson thanked Chairman Kowalski as well as Freeholders Hudak and Palmieri-Mouded for introducing Resolution No. 2019-414 and shedding light on the issue as well as the growing concern of residents. She also thanked Freeholders Staten, Williams, and Granados for showing their support and co-sponsoring the resolution prior to adoption. She noted the complexity of the issue at hand and expressed her hope that PSE&G will heed the concerns of residents and consider alternative courses of action. On another note, she mentioned the upcoming ribbon-cutting ceremony for the Contant Park playground in Hillside on Saturday, May 18.

Chairman Kowalski thanked her colleagues for their support related to Resolution No. 2019-414 as well as the residents that expressed their concerns relative to the proposed project. As a Cranford resident, she expressed her support of residents that have taken a vocal and active position against the issue and noted PSE&G's failure to provide adequate notice and discussion related to the proposed project, citing their responsibility to provide electric power to residents in a safe and responsible fashion. On another note, she cited the importance of shared services as a means to save money throughout the various municipalities. She referenced a new directory that was now available which lists the various shared services opportunities that are available within the county. She closed by reminding residents of an upcoming report presentation entitled "A Preventable Crisis, The Economic and Human Costs of a Hudson River Rail Tunnel Shutdown" scheduled for May 23.
