Reference is made to the evidence submitted by you for use in determining your status for the purpose of Federal income taxation, the question having arisen in connection with your claim for exemption from payment of the capital stock tax.

It is stated in an affidavit of the president of the board of directors that you were incorporated in 1901; that you are a regularly constituted Young Men's Christian Association and a member of the National Council of the Young Men's Christian Associations; that your income is derived from membership dues, private contributions and city Community Chests; and that your income is used entirely for maintenance and operating expenses. It appears that none of your income inures to the benefit of any private shareholder or individual.

Based upon the facts presented, it is held that you are entitled to exemption under the provisions of section 101 (6) of the Revenue Act of 1934 and the corresponding provisions of prior revenue acts. You are not, therefore, required to file returns for 1935 and prior years. Imaginch as section (101 (6) of the Revenue Act of 1936 is similar to section 101 (6) of the Revenue Act of 1934, returns will not be required for 1936 and subsequent years so long as there is no change in your organization, your purposes or method of operation.

Any changes in your form of organization or method of operation, as shown by the evidence submitted, must be immediately reported to the collector of internal revenue for your district, in order that the effect of such changes upon your present exempt statue may be determined.
