The YWCA of Eastern Union County (EUC) is a private non-profit social service agency, which provides meaningful support services to vulnerable populations. YWCA will lease 8 apartments (scattered site, 1 and 2 bedrooms) that can accommodate up to 30 adults and children - 8 heads of household who are victims of domestic violence with their children, and lease a common space area at the YWCA Outreach Center. Referrals will typically come from a domestic violence emergency shelter. The YWCA EUC operates the only emergency shelter for low-income victims of domestic violence in Union County. Women and children who enter the supportive housing program may have lived in an emergency shelter for up to 60 days or otherwise qualify due to homelessness and domestic violence. Participants may have already received approximately 2 months of individual and group counseling, in addition to life skills workshops. YWCA program counselors will assess potential participants for their willingness to participate in the Supportive Housing Program. Upon entry into the permanent supportive housing, each head of household will be assigned a Case Manager, who will meet with him/her for the entire stay needed. The Case Manager will help each client to identify goals and design a plan of action to meet those goals. Vocational training, job preparation, job placement, financial budgeting/saving for permanent housing, parenting, and permanent housing placement are the primary goals/services. The Case Manager assists participants in accessing and receiving integrated program services and entitlements, such as applications to mainstream health and social service programs, as well as linkages to community support systems. Consistent counseling, case management, advocacy, life skills training, legal services, vocational training, coaching, and job placement services will be available for the clients in order for them to succeed in permanent housing. Counseling will also be offered to children as needed as well as referrals to our PALS Program (a 6 months Creative Art therapy program). In addition, the entire non-offending parent-child counseling will be offered. If more individual counseling is necessary, they will be referred out to receive specialized counseling for other concurrent issues. Clients may also participate in psychoeducational groups regarding the effects of domestic violence on their lives and how to manage these effects and develop healthy mental/emotional lives. Support groups and counseling services will be available to all clients as added support in their efforts to maintain self- sufficiency. Concrete follow-up will be given to each of the clients to provide emotional support and information/referral services when necessary.
