PUBLIC NOTICE REQUEST FOR PROPOSALS Notice is hereby given that the Union County Workforce Development Board ("WDB") will receive proposals on Wednesday, May 22, 2019 at 11:00 a.m., EDT. in the Union County Administration Building, Small Conference Room, 4 th Floor, 10 Elizabethtown Plaza, Elizabeth, NJ, for the provision of: NEW JERSEY DEPARTMENT OF LABOR & WORKFORCE DEVELOPMENT WORKFIRST NEW JERSEY PROGRAM (EMPLOYABILITY FUNDS) PROGRAM YEAR 2019 The funding source is Program Year 2019 WorkFirst New Jersey funds. The anticipated funding period is July 1, 2019- December 31, 2020. Proposals are being solicited through a fair and open process in accordance with N.J.S.A. 19:44A-20.4. Allowable participant activities include: Job Search (JS), Community Work Experience Program (CWEP), CWEP + Education Directly Related to Employment, CWEP + Job Skills Training Directly Related to Employment, CWEP + Satisfactory School Attendance-Cert. of General Equivalence, Job Readiness/Life Skills (JR/LS) and Community Work Experience Program (CWEP) combined with Adult Basic Education (ABE), High School Equivalency Preparation (HSE), English as a Second Language. Participants to be served with these employability funds are recipients of Temporary Assistance for Needy Families (TANF), General Assistance (GA) and Supplemental Nutrition Assistance Program (SNAP) recipients. Funding allocations and minimum enrollment levels for funding sources pertaining to this legal notice will be announced at a later date.
