It's funny where life takes us, while not a gerontology major, I found my passion in the field of aging.

When I graduated with my MSW, with an emphasis on policy and research, the job market was not very promising. I landed in Morris County's Department of Human Services, then transferred to their Department on Aging. When the Union County Division on Aging's Executive Director Phil Perlman caught wind that I was working in Morris County but living in Union County, he recruited me to join the Union

County team. Phil obtained a grant on Elder Abuse and Neglect and I became the coordinator for the program in the absence of an adult protective services program in the county. It was a project that had to be developed with the community and through this position I met many providers, community leaders, crime prevention officers, and had the good fortune to travel to Elder Abuse conferences throughout the country as the issue was finally being recognized. That was 35 years ago.

I held different positions at the Division on Aging so the job never seemed boring. As Project Director I handled the SSBG/Title XX grant back when these funds were not part of the Area Plan Contract. For over a year I assisted the county with their Employee Assistance Program while it was in transition, encouraged by Phil Perlman to use the opportunity to utilize my LCSW; Aging by day, EAP by night.

In time, I became the Assistant Executive Director and I further learned how connected the Aging Network was; the dedicated service providers, 20 additional county Offices on Aging, and state AAA administration and leadership, as well as the strong network of Area Agencies on Aging and the National Association of AAA's for whom advocacy on behalf of older adults and caregivers was powerful and rewarding.

I had the privilege to serve on the National Association of Area Agencies on Aging's Board of Directors for 13 years, also serving on the Executive Committee as Treasurer, as well as serving on the New Jersey Association of Area Agencies on Aging's Executive Board as Treasurer. As a result, I have met many professional colleagues who in time became personal friends. I am grateful that the County of Union's leadership supported my interests and commitment to advocacy on behalf of older adults and caregivers.

I have loved working these past 35 years and feel privileged to have had the opportunity to serve as the Executive Director for 18 of them. I am not sure how those years flew by so quickly. As I close this chapter of my career I have many to thank; past Directors' Phil Perlman and Susan Chasnoff; amazing mentors who taught me the value of the Older Americans' Act and how it literally secures people's independence and dignity. They taught me the value of N4A (USAging) and NJ4A and how there is strength in numbers; the county who supported the efforts of the Division as well as the needs of the older population in this county; the Human Services Department directors' leadership, present and past, who understood what we did and allowed the Division to flourish; the service provider network who work as a team and seem to share my passion; the Advisory Council on Aging who were a great sounding board and contributed to my overall knowledge of the needs of older adults. It Really Happened! New Jersey Significantly Increased PAAD/ Senior Gold Income Guidelines

The income limits for the Pharmaceutical Assistance to the Aged & Disabled (PAAD) and Senior Gold increased by \$10,000 each – allowing an additional number of older residents to receive help with the cost of their medications and Medicare Part D premiums and deductibles.

The increase was effective January 1, 2022.

The NJ Division of Aging Services has mailed a letter and forms to all current **Senior Gold** members informing them of the move to PAAD that started January $\mathbf{1}^{\text{st}}$. Members need to complete 2 forms as part of this move – the application for Lifeline and a Medicare Part D Enrollment Assistance form which was included in the letter sent to beneficiaries.

A New Jersey resident may be eligible for PAAD if the following requirements are met:

- Must be a New Jersey resident;
- Are age 65 or older or between ages 18 and 64 and receiving Social Security Title II Disability benefits;
- Annual income for 2022 is less than \$38,769 if single or less than \$45,270 if married.

The Senior Gold Prescription Discount Program (Senior Gold) is a state-funded prescription program with a different co-payment structure and income eligibility guidelines than those of PAAD.

A New Jersey resident may be eligible for Senior Gold if the following requirements are met:

- Must be a New Jersey resident;
- Are age 65 or older or between ages 18 and 64 and receiving Social Security Disability benefits;
- Annual income for 2022 is between \$38,769 and \$48,769 if you are single or between \$45,270 and \$55,270 if you are married.

In addition: All Medicare-eligible Senior Gold beneficiaries are also required to enroll in a Medicare Part D Prescription Drug Plan of their choice. They will be responsible for paying the monthly premium directly to the Medicare Part D plan. They also will be responsible for paying any late enrollment penalty imposed by Medicare for each month they were eligible to enroll in Medicare Part D but did not enroll.
