Jennifer Zinszer review a presentation which is attached to the minutes. Jennifer Zinszer reviewed the various feature of Skill Up NJ and did a short demonstration on how to access the information.

American Job Center Presentation:

Perle Almeida shared a presentation of the American Job Center service delivery, performance, and initiatives. The presentation is attached to the minutes. Perle Almeida discussed the various job fairs including the Inclusive Hiring event that was the first for Union County. Perle Almeida shared information on the new youth mentorship initiative that began in September.

Strategic Plan Update: Meredith Barracato reviewed a presentation regarding newly released guidance from NJDOL and SETC regarding the 2022-2026 strategic plan. Meredith Barracato highlighted some of the guidance which includes the following details:

- Publish Local Plan February 2023
- Local Plan must adhere to all state and local public comment requirements
- Effective Through 2026
- Four-year local plan will be reviewed/modified after two years
- One-Stop Operators are not allowed to participate in the strategic planning process
- Emphasis on integration of technology into programs/services
- Ensure Diversity, Equity and Inclusion are considered
- Detail impacts of the pandemic and local labor markets, including indemand occupations and employment and education needs.
- Plan should be a how-to guide verses document on the shelf.

Partner Updates

Meredith Barracato asked the partners to provide a brief update on their program and share any special initiatives.

1. Division of Social Service-Tina Lopez mentioned they are still sending referrals to program partners for anyone who is on TANF and GA. Right now they are not sanctioning TANF but they will GA. In June there were 938 GA clients who have been sanctioned and now have 574 GA due to

sanctioned process. The TANF population has increased from 553 to 600 as of 10/1/22. They continue to have operations meetings with DFD, partners, and vendors.

- 2. NJ Department of Labor Employment Services (ES)- Anthea Williams discussed the Return and Earn program (On the Job training, OJT) offered through NJDOL is looking to focus on working with more employers and offered details on how to apply for new hire training. Anthea Williams mentioned there is a fintech company in Berkley Height will be looking to hire 1000 people soon. They have a rapid response request from Autorama who is laying off over 150 employees. They are still working with jobseekers. Perle Almeida asked that Anthea send her the information for the rapid response event so the AJC can help.
