THURSDAY, FEBRUARY 9, 2023 AGENDA SETTING MEETING MINUTES

CALL TO ORDER

Chairman Granados presided over the meeting and called the meeting to order at 6:00 P.M.

ROLL CALL

Roll call showed Chairman Sergio Granados, Vice-Chairwoman Kimberly Palmieri-Mouded, Commissioner James E. Baker, Jr., Commissioner Joseph C. Bodek, Commissioner Angela R. Garretson, Commissioner Bette Jane Kowalski, Commissioner Lourdes M. Leon, Commissioner Alexander Mirabella, and Commissioner Rebecca Williams were present.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen Esq., and Clerk of the Board James E. Pellettiere.

PRAYER AND SALUTE TO THE FLAG

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

STATEMENT OF COMPLIANCE WITH THE OPEN PUBLIC MEETINGS ACT

The statement of compliance with the Open Public Meetings Act was read by Clerk of the Board Pellettiere.

PRESENTATIONS BY THE BOARD

Certificate presentations were made by the Board to volunteers of the County's 2023 Annual Point-In-Time Count of the Homeless.

Chairman Granados spoke relative to the recent Point-In-Time Count conducted, noting teams of County staff and government officials as well as volunteers from local non-profit organizations that participated. He advised that several unsheltered persons had been identified during the seven-day county, adding that those individuals had been referred to the Department of Human Services, Division of Social Services, for additional services and resources. Chairman Granados also noted that over 200 adults and children had been sheltered by the County through its Code-Blue Initiative that season. He recognized the various organizations for their generous contributions and efforts to this effect including Kean University's Be the Change, the City of Plainfield, Plainfield Action Services, and the Elizabeth Coalition to House the Homeless. Chairman Granados asked Vice-Chairwoman Palmieri-Mouded, County Manager Oatman, Deputy County Manager Wagner, Director Anderson, and Division Director Christina Topolosky to join him for the presentation.

The following individuals were presented with a certificate for their efforts related to Union County's 2023 Point-In-Time Count for the Homeless: Officer Michael Martinez of the Plainfield Police Department; George Vessels from Bridgeway Rehabilitation Services; Johnell Beckles from Bridgeway Rehabilitation Services; Cheryl Abdur-Raham of Elizabeth; Hassan Abdur-Rahman of Elizabeth; Hajja Abdur-Rahman of Elizabeth; Dennise Lebron of Elizabeth; Andre Bryant from Organization for Recovery; Srabanati Sarkar from PROCEED Inc.; Jasmin Shaw from the Gateway YMCA of Elizabeth; Janeen Billings from the Elizabeth Salvation Army; and Dannisha Clyburn from the Elizabeth Salvation Army.

Vice-Chairwoman Palmieri-Mouded thanked all the volunteers for their efforts relative to the Point-In-Time Count, adding that their daily efforts to improve their communities were recognized and greatly appreciated.

Resolution presentations were made by the Union County Board of County Commissioners to UCVTS Superintendent Gwendolyn Ryan, joined by students from the various Academies of the Vocational-Technical School, in recognition of National Career and Technical (CTE) Month and National Future Farmers of America (FFA) Week.

Chairman Granados noted that the Board was always eager to celebrate the academic achievements of students from UCVTS during National Career and Technical (CTE) Month and National Future Farmers of America (FFA) Week. He recognized Vo-Tech Superintendent Gwendolyn Ryan, BOE President Jean Perkins, and Business Administrator Janet Behrmann for their efforts. He noted that throughout the years, U.C. Vo-Tech students had brought many honors to the Union County community, including national recognition as a Blue Ribbon School, among other accolades. He added that the Board was very proud of the students and their continued hard work in pursuit of their academic goals. Chairman Granados called upon Superintendent Ryan to make her presentation.

Superintendent Ryan thanked the Board for the recognition and for the opportunity to celebrate the students of UCVTS during National Career and Technical Month and National Future Farmers of America Week. She thanked BOE President Perkins as well as the Administration for their day-to-day efforts and contributing to the success of Vo-Tech students. She advised that in the last ten years, 6,129 students from all 21 municipalities, had graduated from one of UCVTS's nine schools, noting the inclusion of two alternative high schools for out-of-school youth. Superintendent Ryan noted that students had celebrated CTE Month in February through various activities including guest speakers, bulletin board presentations, field trips/site visits, and morning announcements. She noted that UCVTS had also incorporated Black History Month into various activities during National Career and Technical Month. She thanked the Board again for continuing to support UCVTS and its students. She proceeded to introduce the students in attendance, noting their course(s) of study and the various organizations and activities with which they were affiliated. The following students were introduced: Magnet High School junior, Mauricio Sanchez; AIT's Business Management and Administration Program senior, Cole DuHaime; Teacher Education Academy sophomore, Diamond Previlon; Academy for Allied Health Sciences senior, Ivan Liu; AIT's Business Management and Administration Program senior, Jordan White; AIT senior, Saniya Licorish;

Academy for Performing Arts senior, Kaitlyn Miranda; Teacher Education Academy sophomore, Elizabeth Koizumi; and Teacher Education Academy sophomore, Trecian Benjamin.

Superintendent Ryan also presented the following students from the Teacher Education Academy: Sofia Couto, Rebecca Lacerda, Natalia Prajzner, Sabella Torres, Abigail Noriega, and Adriana-Jazmin Varas.

The aforementioned students thanked the Board for their continued support and for the educational opportunities they are afforded through UCVTS. They noted the invaluable resources and hands-on experience provided through UCVTS relative to preparing them to be proficient in their future careers.

Commissioner Williams noted her career as a professor, adding that she was very inspired by the students, specifically those from the Teacher Education Academy at UCVTS. She congratulated them all on their academic successes.

Chairman Granados noted the week of February 18th through February 25th was designated as National Future Farmers of America (FFA) Week. He provided some background information on the Future Farmers of America (FFA) organization, noting the importance of agricultural education. He added that the Board was committed to supporting these efforts.

Superintendent Ryan recognized Josephine Taglialavore and Maise Shimko, 11th grade students from the School of Sustainable Sciences at UC-Tech, noting some of their academic accolades. She also introduced Joanna Knoblauch, who serves as the lead instructor in the School of Sustainable Sciences as well as FFA Advisor.

Commissioner Mirabella noted that both his children attended AIT, noting that his son placed 4th in an FFA competition.

Commissioner Garretson thanked Superintendent Ryan and all the students for their dedication and hard work and congratulated them on their respective academic successes.

Director Graziano advised that additional conduit was needed to relocate public service lighting at the Gordon Street Bridge. He further advised that this project was funded by NJ's Department of Transportation, adding that the change order was for PSE&G.

Commissioner Baker asked Director Graziano to elaborate on this item.

Director Graziano advised that this item related to the County's 2024 Road Resurfacing Project, noting 18 miles of resurfacing proposed throughout Union County. He added that these monies would cover the design, construction administration, and inspection services as well as the installation of guardrails.

Director Anderson advised that this item provided transportation services through the County's Paratransit System to adult day care clients attending programs in Summit, adding that the City of Summit would be paying the County for these resources.

Authorizing the County Manager to enter into a revenue generating agreement with Inroads to Opportunities, Roselle, New Jersey for the provision of transportation services through the Union County Paratransit System for Partial Care clients attending their programs based upon pre-scheduled trips provided by the County on Monday through Friday for the period of January 1, 2023 through December 31, 2023. Chairman Granados asked Director Anderson to elaborate on this item.

Director Anderson advised that this item provided round-trip, work-related transportation services to intellectually-disabled clients through the County's Paratransit System.

3. Authorizing the County Manager to enter into a revenue generating agreement with Bridgeway Rehabilitation Services, Inc., Elizabeth, New Jersey for the provision of transportation services through the Union County Paratransit System for Partial Care clients attending their programs based upon pre-scheduled trips provided by the County on Monday through Friday for the period of January 1, 2023 through December 31, 2023. (Revenue generating) (Commissioner Lourdes M. Leon)

Chairman Granados asked Director Anderson to elaborate on this item.

Director Anderson advised that this item also provided transportation services to partial care individuals receiving mental health services through the County's Paratransit System.

4. Amending Resolution 2021-763, a contract with Community Access Unlimited, Elizabeth, New Jersey, for the purpose of serving as operator of the state mandated Shelter Home for Union County for the period of January 1, 2022 through December 31, 2022, to increase the contract award in the amount of \$1,002.00 for a total contract amount not to exceed \$517,902.00, with no other changes to the terms or conditions of the contract. Commissioner Baker asked Director Anderson to elaborate on this item.

Director Anderson advised that Community Access Unlimited managed the County's Youth Shelter designated for court-adjudicated youth. She further advised that the County had initially contracted with Community Access Unlimited to provide four beds, noting an increase to 6-8 beds in 2022. She added that the additional monies being requested would cover this increase.

- 5. Authorizing the County Manager to approve the 2023 Coordinated Community Care Contract Spending Plan and enter into agreements with various agencies to deliver services to Union County residents 60 years of age or older and/or their caregivers under the 2022-2024 Coordinated Community Care contract for the period of January 1, 2023 through December 31, 2023, representing contract year two of a three year cycle with the option to renew contracts for one (1) additional year in a total not to exceed amount of \$100,000; further authorizing the transfer of funds among the agencies during the contract period should service needs change and/or if any should fail to meet its contractual obligation.
