# THURSDAY, NOVEMBER 9, 2023 REGULAR MEETING MINUTES

## CALL TO ORDER

Chairman Granados presided over the meeting and called the meeting to order at 6:19 P.M.

# ROLL CALL

Roll call showed Chairman Sergio Granados, Vice-Chairwoman Kimberly Palmieri-Mouded, Commissioner James E. Baker, Jr., Commissioner Joseph C. Bodek, Commissioner Bette Jane Kowalski, Commissioner Lourdes M. Leon, Commissioner Alexander Mirabella, and Commissioner Rebecca Williams were present, with Commissioner Angela R. Garretson absent.

Also present were County Manager Edward T. Oatman, County Counsel Bruce H. Bergen, Esq., and Clerk of the Board James E. Pellettiere.

The prayer and salute to the flag were led by Clerk of the Board Pellettiere.

Chairman Granados called for a motion to approve the Communications. On a motion made by Commissioner Mirabella and seconded by Commissioner Williams, roll call showed eight members of the Board voted in the affirmative, with Commissioner Garretson absent.

Chairman Granados called for a motion to approve the August and September Minutes. On a motion made by Commissioner Williams and seconded by Vice-Chairwoman Palmieri-Mouded, roll call showed seven votes in the affirmative for the August 17th Agenda Setting and Regular Meeting Minutes, with Commissioner Baker abstaining and Commissioner Garretson absent; eight votes in the affirmative for the September 7th Agenda Setting and Regular Meeting Minutes, with Commissioners Garretson absent; and six votes in the affirmative for the September 21 Agenda Setting and Regular Meeting Minutes, with Vice-Chairwoman Palmieri-Mouded and Commissioner Mirabella abstaining, and Commissioner Garretson absent.

# **PUBLIC COMMENT PORTION**

The meeting was opened for the purpose of commenting on resolutions being offered for adoption and on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Commissioner Garretson arrived to the meeting.

Linda Flores-Tober, Executive Director of Elizabeth Coalition to House the Homeless and Chair of the County's Human Services Advisory Council, spoke to an increase in homelessness and housing insecurity as well as rising rent prices. She noted the services provided by the Elizabeth Coalition to House the Homeless, including rental assistance as well as transitional and permanent housing. She noted that last year the organization had received over 6,000 requests for assistance, adding that the organization managed to assist approximately 1,900 households. She advised that this year, the organization had assisted over 2,100 households by the end of September. She offered her appreciation for the work that the Commissioner Board has done in helping to address these issues.

Bruce Paterson, of Garwood, asked questions and made comments relative to several resolutions. Relative to Reso No. 2023-964, he asked about changes to salary and benefits. Relative to Reso No. 2023-969, he asked for a list of the organizations involved. Relative to Reso No. 2023-970, he made comments about the settlement and inquired about the insurance company listed. Relative to Reso No. 2023-971, he asked for additional information related to potential litigation. Regarding general comments, Mr. Paterson asked for updates relative to the equipment and environmental damages at the swamp at Ash Brook. He also made comments about Commissioner Mirabella.

Relative to Reso No. 2023-964, County Manager Oatman advised that the agreement was a 2-year contract for 2024 and 2025, adding that there were no additional changes.

Relative to Reso No. 2023-969, Director Anderson advised that P.R.O.C.E.E.D., Rahway CAO, and United Way would provide services to the City of Elizabeth, City of Rahway, and Township of Hillside respectively.

Relative to Reso No. 2023-970, Counsel Bergen advised that the courts did not find any fabrication by the lie-detector operator relative to this matter. Additionally, he advised that this lawsuit was related to a matter that took place in 2014, adding that

the cited insurance company was used by the County at that time. He noted that while the County had won this matter at trial, the Third Circuit Court of Appeals of the State of NJ had overturned the original decision. He added that at the behest of the insurance company, the County decided to settle the matter as it made the most financial sense.

Relative to Reso No. 2023-971, Counsel Bergen advised that this law firm had been secured to provide potential litigation services concerning the Ash Brook Clubhouse construction. He noted that the law firm could also provide litigation services relative to other matters.

Relative to Ash Brook swamp, County Manager Oatman advised that he had no updates to provide at that time.

Relative to the comments made about Commissioner Mirabella, Chairman Granados recognized Commissioner Mirabella for his leadership and advocacy, commending him for his many years as a public servant. He noted Commissioner Mirabella's tremendous leadership as Chairman of the Board during the COVID-19 pandemic.

2023-978 CHAIRMAN SERGIO GRANADOS, & THE ENTIRE BOARD: Announcing UC LOVES SMALL BIZ initiative aimed at celebrating and encouraging residents and visitors to patronize Union County businesses, to shop, dine & support local from November 24, 2023 through December 24, 2023.

On a motion made by Commissioner Bodek and seconded by Commissioner Garretson, roll call showed nine members of the Board voted in the affirmative.

## COMMISSIONER REPORTS AND COMMENTS

Commissioner Garretson had no comments.

On behalf of County Clerk Joanne Rajoppi, Commissioner Bodek advised that the U.S. Department of State was experiencing longer processing times for new passport applications and passport renewals. He noted that processing times for routine applications were taking 7-10 weeks, with expedited service taking 3-5 weeks. He encouraged residents with a need to apply for and or renew their passports to make an appointment with the County Clerk's Office. He added that passport applications could be executed in-person, by appointment only, at the County Clerk's Elizabeth and Westfield offices. To close, he wished everyone a Happy Thanksgiving.

Commissioner Leon announced the renovation of Rutgers Avenue Park in Hillside. She noted the park as one of the oldest in Union County, adding that upgrades and improvements would include new playground equipment and playground surfaces. She advised that the playground would include ADA equipment to ensure safe and inclusive recreation for children of all abilities. She added that the new park was slated to open spring of 2024. She closed by wishing everyone a Happy Thanksgiving.

Commissioner Kowalski thanked Prosecutor Daniel and all those involved for their efforts relative to the Arrive Together initiative, noting that she looked forward to the expansion of this project in the future. She also thanked Linda Flores-Tober of the Elizabeth Coalition to House the Homeless for her continued efforts and for the invaluable resources provided by the organization. On another note, she congratulated Commissioner Bodek and Commissioner Leon as well as Commissioner-elect Michele Delisfort and Sheriff Corvelli on their recent election wins. She noted the importance of voting and participating in the democratic process. Commissioner Kowalski also spoke relative to her recent visit to the County's Emergency Services Regional Dispatch Center, joined by Deputy County Manager Wagner, Chairman Granados, and Commissioner Leon as well as staff from the Department of Public Safety. She noted that the County Regional Dispatch Center provided various dispatch services to 13 municipalities, adding that two more municipalities would be joining in 2024. To close, Commissioner Kowalski noted the conflict in Gaza and expressed her desire for an end to the humanitarian crisis that had led to the tragic and catastrophic suffering of many. She

noted her support of the UN General Assembly's Resolution of October 27<sup>th</sup>, calling for respect of international humanitarian law. She closed by urging President Biden and other elected officials in Washington DC to increase negotiation efforts and bring an end to the conflict.

Commissioner Baker noted the comments made by Commissioner Mirabella, citing them as disparaging and reprehensible. He noted Commissioner Mirabella's dedication to public service, recognizing him as a friend and a valuable advocate for the people of Union County. On another note, he congratulated his Commissioner colleagues on their recent election wins as well as Commissioner-elect Delisfort and Sheriff Corvelli. To close, Commissioner Baker encouraged residents to participate in an upcoming informational workshop entitled Bring Back the Bat at Trailside Nature and Science Center on November 11<sup>th</sup>.

Commissioner Mirabella thanked his colleagues for their kind words and unyielding support, noting the many difficulties that arise with being in the public eye as a public servant. On another note, he advised that in honor of Veterans Day the County would be participating in Operation Green Light from November 6 – November 12 and encouraged residents to participate by changing one bulb in their house to green. To close, he congratulated Commissioner Bodek Commissioner Leon and Sheriff Corvelli on their recent election wins.

Commissioner Williams noted the Code Blue Initiative, organized through the Department of Human Services, which would provide homeless and housing-insecure persons with emergency shelter and alternative housing during extreme weather conditions. On another note, she congratulated her Commissioner colleagues on their recent election wins as well as the other officials throughout the State of NJ. She thanked Prosecutor Daniel for his efforts relative to the Arrive Together initiative, adding that she had heard wonderful things about the program. She also expressed her desire for an end to the conflict in Gaza, adding that she was in support of a two-state solution. To close, she wished everyone a Happy Thanksgiving.

Counsel Bergen congratulated Commissioner Bodek, Commissioner Leon, Commissioner-elect Delisfort, and Sheriff Corvelli on their recent election wins.

Vice-Chairwoman Palmieri-Mouded spoke relative to two upcoming, holiday emergency food distributions on November 18<sup>th</sup> and December 17<sup>th</sup> at Kean University. She advised that the distribution would be done on a first-come-first-serve basis, reminding residents that proof of residency was required. To close, she congratulated her Commissioner colleagues on their recent election win as well as all those that participated in the process, noting the difficulties of running for public office. To close, she recognized our Veterans and wished everyone a Happy Thanksgiving.

Chairman Granados congratulated his Commissioner colleagues on their recent election wins as well as all the other victors throughout the State of NJ, adding that he looked forward to working with everyone in the future. To close, he noted his recent initiative UC LOVES SMALL BIZ and encouraged residents to shop local from November 24 – December 24.
