Commissioner Leon asked County Engineer Matias to elaborate on the cited decrease.

County Engineer Matias advised that the reduction in cost was due to asphalt price adjustments as well as changes to the roads being addressed.

- 7. Amending resolution 2022-885, a contract with T & M Associates, Middletown, New Jersey to provide additional services for LSRP Environmental Services for Meisel Park, Township of Springfield in an additional amount of \$27,725.00 for a new contract amount not to exceed \$113,975.00. (Commissioner Joseph C Bodek)
- 8. Amending Resolution 2022-337, a contract awarded through advertised public bidding in accordance with the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq., to Smith Sondy Asphalt Construction Company, of Wallington, New Jersey, approving Change Order Number 1 for the 2022 Road Resurfacing Project, County of Union, New Jersey. Chairwoman Palmieri-Mouded asked Director Anderson to elaborate on the increase.

Director Anderson advised that this resource would allow the Department to assist non-English speaking residents in securing social service benefits. She noted that the Department was actively working on 6,000-7,000 calls monthly. She added that this contract included a \$10,000 increase from last year to accommodate an influx of new Americans.

3. Amending Resolution 2023-1093, a contract with the United Way of Greater Union County, Elizabeth, NJ for the provision of a Volunteer Income Tax Assistance (VITA) program for low-income individuals and families of Union County for the

period of December 1, 2023 through April 30, 2024, to reflect a change in appropriation account number only. (Commissioner Sergio Granados)

Commissioner Granados asked Director Anderson to elaborate on this item.

Director Anderson advised that this related to a new, tax-processing service pilot program being offered to low-income Union County residents to assist them with their income-tax preparation.

Amending Resolution 2023-928, a contract with Synergex International Corporation, Gold River, CA for software license and software maintenance for the Department of Human Services, Division of Social Services for the period of January 1, 2024 through December 31, 2024, to reflect a change the appropriation account number only.
