#### CALL TO ORDER

#### ORDINANCE FOR INTRODUCTION

AN ORDINANCE TO AMEND "THE LAWS OF UNION COUNTY:
ADMINISTRATIVE CODE AND POLICIES AND GENERAL
LEGISLATION" BY AMENDING: PART I -ADMINISTRATIVE CODE:
CHAPTER 1, UNION COUNTY GOVERNMENT STRUCTURE:
ARTICLE XVII- DEPARTMENT OF ADMINISTRATIVE SERVICES
AND ARTICLE XXIV- DEPARTMENT OF ECONOMIC
DEVELOPMENT.

#### FIRST READING STATEMENT

Vice Chairman Joseph Bodek, Policy and Administrative Code Committee Chairman, moved Ordinance No. 855-2025 for First Reading and authorized the Clerk of the Board to advertise same in accordance with the law. The Public Hearing and Final Reading will be held on February 27, 2025.

On a motion made by Vice-Chairman Bodek and seconded by Commissioner Kowalski, roll call showed seven votes in the affirmative, with Commissioner Baker and Commissioner Delisfort absent.

#### PUBLIC COMMENT PORTION

The meeting was opened for the purpose of commenting on resolutions being offered for adoption and on any governmental issue that a member of the public feels may be of concern to the residents of the county.

Diana Gonzalez, of Clark, presented a Clark Reservoir Committee T-shirt to Clerk of the Board Pellettiere for County Manager Oatman. She thanked the County of Union and the Board for entertaining the concerns of Clark residents relative to the Clark Reservoir Project over the last several months. She added that she was pleased that a reasonable resolution had been reached, with many of their requests met.

Susana Civelli, of Clark, thanked the County of Union and the Board for their responsiveness to the concerns of Clark residents relative to the Clark Reservoir Project. She noted she was satisfied with the outcome.

Pat Delaney, of Clark, noted that he was grateful that the concerns of residents had been considered relative to the Clark Reservoir Project. He advised that he was pleased with the outcome.

Clara LeBruno, of Clark, thanked the County of Union and the Board for listening to the concerns of residents and adjusting their plans for the Clark Reservoir Project accordingly.

Nancy Twaskas, of Clark, provided an article to Clerk of the Board Pellettiere relative to endangered animals in NJ to share with the Board. She also provided photos of some of these endangered species near the Clark Reservoir.

Delia Collins, of Clark, inquired if the Animal Task Force under the U.C. Prosecutor's Office was still active. She expressed a need for animal welfare services in Union County.

County Manager Oatman asked Prosecutor Daniel to talk with Delia Collins following the meeting.

Relative to Reso No. 2025-150, Bruce Paterson, of Garwood, asked how the monies would be spent. Relative to Reso No. 2025-151, he made comments about the flooding in the County's Annex Building. Relative to Reso No. 2025-164, he made comments about the County's decision to discontinue publishing legal notices in physical newspapers. He also made comments relative to the bids for the Clark Reservoir Project, adding that he hoped the incoming bids were within budget.

Relative to Reso No. 2025-150, County Manager Oatman advised that this item would fund construction and administrative services.

There were no additional questions or comments.

On a motion made by Commissioner Mirabella and seconded by Commissioner Palmieri-Mouded, roll call showed seven members of the Board voted in the affirmative, with Commissioner Baker and Commissioner Delisfort absent.

2025-175 CHAIRWOMAN LOURDES M. LEON, COMMISSIONER SERGIO GRANADOS, & THE ENTIRE BOARD: Congratulating St. Joseph Social Service Center on the completion of their capital campaign and dedication of renovated space on Saturday, February 8, 2025.

On a motion made by Commissioner Mirabella and seconded by Commissioner Palmieri-Mouded, roll call showed seven members of the Board voted in the affirmative, with Commissioner Baker and Commissioner Delisfort absent.

#### COMMISSIONER REPORTS AND COMMENTS

Commissioner Kowalski invited residents to visit the Commissioners' Gallery on the 6<sup>th</sup> floor of the County Administration building through February 28<sup>th</sup> to view an exhibit in celebration of Black History Month. She advised that this year's exhibit highlighted the talent of local artists Mansa Mussa, Brian Branch Price, and Lydia Watson. She recognized the County's Office of Cultural & Heritage for curating the exhibit. To close, she encouraged residents to visit the County's website to learn more about the various programs and events slated for Black History Month.

Commissioner Mirabella had no comments.

Commissioner Williams invited residents to celebrate Black History Month with a series of events highlighting the cultural contributions and historical significance of African Americans. She noted this year's theme 'African Americans and Labor" which would focus on the profound impact of black Americans in the workforce, from early laborers to modern leaders. Additionally, she spoke relative to the Pan-African Flag Raising ceremony that took place earlier that week in front of the Union County Courthouse in honor of Black History Month. Commissioner Williams invited residents to attend a free Jazz Performance at UCPAC's Hamilton Stage, featuring jazz trio Grown Groovin'. She added that the 2025 Chester Holmes Humanitarian Award would also be presented that evening. She also invited residents to a Black History Seminar on February 26th at Union College of Union County, featuring NJEA Secretary Treasurer Petal Robertson. On another note, Commissioner Williams encouraged residents to contact the County's Office of Diversity and Community Engagement to secure their Black History Month Trading Cards highlighting modern African American labor leaders. To close, she noted that February 7th was National Black HIV/Aids Awareness Day (NBHAAD), and thanked her Commissioner colleagues for supporting Resolution No. 2025-172. She expressed her disapproval over a CDC/NIH webpage dedicated to NBHAAD being removed by the Trump administration. She noted that Elizabeth and Plainfield were among the top cities in NJ with the leading cases of HIV/AIDS.

Commissioner Palmieri-Mouded had no comments.

Commissioner Granados thanked the members of the Clark Reservoir Committee for attending the evening's meeting and recognizing the County and Board's efforts to reach a compromise that would satisfy both sides. On another note, Commissioner Granados confirmed that County personnel was appointed based on qualifications and experience, adding that comments about their appearance were inappropriate and would not be tolerated. He added that Union County was headed in the right direction thanks to its capable leadership.

Vice-Chairman Bodek invited senior residents and their caregivers to visit the County's Aging Services Kiosk (ASK) events of the 2025 season, through the Department of Human Services' Division on Aging. He added that these events would give attendees an opportunity to learn more about available services and resources for aging residents, including home-delivered meals and respite care, among other support services. He advised that events were scheduled for February 5<sup>th</sup> at the Garwood Public Library; February 13<sup>th</sup> at the Clark Public Library; February 18<sup>th</sup> at the Westfield Memorial Library; February 20<sup>th</sup> at the Elizabeth Public Library; and February 27<sup>th</sup> at the Hillside Public Library.

County Manager Oatman confirmed that Parks Director Durbin-Drake had been employed by the County for 25 years.

Chairwoman Leon noted her attendance of the 88<sup>th</sup> annual Hot Stove Awards Dinner, alongside Commissioner Mirabella, adding that she was happy to be able to recognize the newly inducted members of the Union County Baseball Hall of Fame. Alongside Vice-Chairman Bodek and Commissioner Williams, she also noted her attendance of Union's Black History Month Expo and Vendor Fair, adding that she was honored to be able to present Union Mayor James Bowser with a Resolution commemorating Black History Month. Chairwoman Leon spoke relative to the recent Black History Flag Raising ceremony that took place earlier that week at the Union County Courthouse. She also referenced her participation in World Read Aloud Day at Hillside Public Schools, alongside Commissioner Palmieri-Mouded.
